JUDGMENT

NIAZ MUHAMMAD KHAN, CHAIRMAN: Arguments of the learned counsel for the parties heard and record perused.

FACTS

The appellant is aggrieved from an order dated 09.02.2012 whereby her wilful absence was treated as extraordinary leave. Against this order she filed departmental appeal to the DCO on 13.03.2012 which was not responded to and thereafter the present service appeal on 25.06.2011.

ARGUMENTS

- 3. The learned counsel for the appellant argued that the impugned order was passed without any inquiry under the Khyber Pakhtunkhwa Government Servant (Efficiency and Disciplinary) Rules 2011. That no order could be passed without following the procedure laid down under the rules mentioned above.
- 4. On the other hand, the learned Deputy District Attorney, argued that the present appeal is time barred and secondly the departmental appeal was addressed to in incompetent authority. He further argued that the appellant herself admitted her absence by filing an affidavit.

CONCLUSION.

The delay of four days could not be taken to defeat the appeal of the appellant for the reason that the order was passed on 09.12.2012 and there is no proof of the fact that it was communicated to the appellant on the same day. It definitely takes few days to reach the aggreeved civil servant, therefore, this departmental appeal cannot be held to be time barred. Secondly the departmental appeal was submitted to the DCO. Under the Khyber Pakhtunkhwa Civil Servant (Appeal) Rules, 1986 the departmental appeal is to be made not to the appellate authority but in the office in which the appellant is serving. It is for the office to send the departmental appeal to the concerned authority if he himself is not the appellate authority (Rule-4). The DCO at the relevant time did figure in the hierarchy of the department. He should have referred the appeal to the appellate authority, if he himself was not the appellate authority. Admittedly, the department has not initiated the proceedings under the Khyber Pakhtunkhwa Government Servant (Efficiency and Disciplinary) Rules 2011. The proper procedure for the department was to have initiated the regular proceedings under the Rule-5 or under Rule-9 of the said rules. The competent authority could not decide the same on the basis of any affidavit by the

6. Resultantly, this appeal is accepted. The impugned order is set aside and the department is directed to initiate and conclude the proper proceedings within a period of 3 months from the date of receipt of this judgment. Parties are left to bear their own costs. File be consigned to the record room.

That ADEO (Female) Primary Inspection Abbottabad called the explanation about the absent from duty on 09/02/2011 and the appellant submitted the reply on 28/04/2011 and the Officer ADEO (Female) primary being satisfied from the explanation passed the order on 28/04/2011 for the release of the salary of the appellant but not action have been taken so for.

8. That the appellant submitted a presentation to EDO
Abbottabad for the release of the salary but the
Petition was rejected and the impugned order was

paned on 09/02/2012 and a copy of the order was also issued to the appellant.

(Copy of the order is annexed as Annexure "C")

9. That appellant being highly aggrieved from the order of EDO Abbottabad of dated 09/02/2012, submitted an appeal to the DCO Abbottabad for setting aside the order of EDO No.1617-20 dated 09/02/2012. But till now no reply have so far been made by the learned DCO Abbottabad.

(Copy of the Appeal is annexed as Annexure "D")

10. That now there remains no other remedy except to approach this Honourable Tribunal for the following amongst other grounds:-

GROUNDS:-

a) That the Order of 09-02-2012 of respondent No.3 is against the facts, law and rules. Thus the Order is not maintainable in the eye of law.

- b) That appellant is serving as a single Teacher in the Government Girls Primary School Mohri Mera for the last 13 years and not a single complaint was ever made against the Appellant.
- That only on 09-02-2012 when the Appellant was seriously sick and went to the Doctor for treatment only at this occasion she was found absent although appellant submitted the Medical Certificate in support of her version which was found correct by the ADEO (Female) Primary Education Abbottabad and recommended for the

release of the salary of the Appellant.

d) That the Appellant regularly remained in the above cited school and performed her duties honestly from 01-02-2011 to 31-08-2011 and was never charge sheeted or warned by the Higher Officer. So, treating the period from 01-02-2011 to 31-08-2011 as extraordinary leave without pay is against justice, law and rules and this observation of the Higher Authority is not sustainable and is against the principle of Audi Altrum Partum (No one should be condemned unheard).

- e) That the Appellant is a poor primary teacher and her 8 months salary is upheld without her fault.
- f) That the other factual and legal points if any will be raised with the permission of this Honourable Tribunal.

PRAYER:-

On acceptance of this appeal the impugned order No. 1617-20 dated 09-02-2012 may kindly be set aside and the Appellant may kindly be granted the salary of 8 months i.e. from 01-02-2011 to 31-08-2011.

JUDGMENT

NIAZ MUHAMMAD KHAN. CHAIRMAN: Arguments of the learned counsel for the parties heard and record perused.

FACTS

2. The appellant is aggrieved from an order dated 09.02.2012 whereby her wilful absence was treated as extraordinary leave. Against this order she filed departmental appeal to the DCO on 13.03.2012 which was not responded to and thereafter the present service appeal on 25.06.2011.

ARGUMENTS

- 3. The learned counsel for the appellant argued that the impugned order was passed without any inquiry under the Khyber Pakhtunkhwa Government Servant (Efficiency and Disciplinary) Rules 2011. That no order could be passed without following the procedure laid down under the rules mentioned above.
- 4. On the other hand, the learned Deputy District Attorney, argued that the present appeal is time barred and secondly the departmental appeal was addressed to in incompetent authority. He further argued that the appellant herself admitted her absence by filing an affidavit.

CONCLUSION.

The delay of four days could not be taken to defeat the appeal of the appellant for the reason that the order was passed on 09.12.2012 and there is no proof of the fact that it was communicated to the appellant on the same day. It definitely takes few days to reach the aggrieved civil servant, therefore, this departmental appeal cannot be held to be time barred. Secondly the departmental appeal was submitted to the DCO. Under the Khyber Pakhtunkhwa Civil Servant (Appeal) Rules, 1986 the departmental appeal is to be made not to the appellate authority but in the office in which the appellant is serving. It is for the office to send the departmental appeal to the concerned authority if he himself is not the appellate authority (Rule-4). The DCO at the relevant time did figure in the hierarchy of the department. He should have referred the appeal to the appellate authority, if he himself was not the appellate authority. Admittedly, the department has not initiated the proceedings under the Khyber Pakhtunkhwa Government Servant (Efficiency and Disciplinary) Rules 2011. The proper procedure for the department was to have initiated the regular proceedings under the Rule-5 or under Rule-9 of the said rules. The competent authority could not decide the same on the basis of any affidavit by the appellant.

6. Resultantly, this appeal is accepted. The impugned order is set aside and the department is directed to initiate and conclude the proper proceedings within a period of 3 months from the date of receipt of this judgment. Parties are left to bear their own costs. File be consigned to the record room.
