It is argued that appellant got seriously injured while performing his duty on 19.06.2012 as result of militants attack on the Police Station City, District Bannu. In the said regard FIR No. 616 was duly recorded at P.S City Bannu on the even date. As a consequence of injuries received by him, the appellant remained under treatment in various hospitals in the country as well as abroad. While recording the impugned order dated 29.03.2018 and awarding major punishment of dismissal from service <sup>to</sup> upon the appellant the said facts were not kept under consideration. Similarly, while disposing of the departmental appeal the circumstances beyond the control of appellant were not given due regard and the appeal was rejected on 30.05.2018. Regarding the delay in filing service appeal in hand it was stated that as the appellant was not communicated the order of rejection of appeal dated 30.05.2018, he applied for a copy thereof on 11.10.2018. On the same date the application was processed and the requisite copies were issued, hence the appeal filed on 08.11.2018 was within time.

In view of the averments of learned counsel instant appeal is admitted for regular hearing. The appellant is directed to deposit security and process fee within 10 days. Thereafter, notices be issued to the respondents. To come up for written reply/comments on 01.03.2019 before S.B.


