JUDGMENT

KALIM ARSHAD KHAN CHAIRMAN.: According to the appeal, the appellant, the appellant was appointed vide order No.8854-10095 dated 23.06.2017, on merit against the post of PST in GPS Lari Kaghan, village Council Kaghan, on the recommendation of the departmental selection committee through NTS and after observing all codal formalities; that the appellant performed his duties and continued his services when vide Endst No.19716-24 dated 14.11.2017, the appointment of the appellant was withdrawn on the allegation that the DMC of FA/Intermediate under roll No.54499 session 2009 annual was found fake and bogus as per the record of the BISE; that the appellant then filed writ petition No.172-A of 2019 before the Honorable Peshawar High Court Bench Abbottabad, which was decided on 03.03.2020 converting the writ petition into appeal and sending the same to the Secretary to the Government of Khyber Pakhtunkhwa, Elementary Secondary Education, Peshawar(Respondent No.1), who rejected the same vide Notification dated 31.08.2020, hence, this appeal.

2. On receipt of the appeal and its admission to full hearing, the respondents were summoned, who on putting appearance, contested the appeal by filing written reply raising therein numerous legal and

factual objections. The defence setup was a total denial of the claim of the appellant.

- 3. We have heard learned counsel for the appellant and learned Deputy District Attorney for the respondents.
- 4. It was contended by the learned counsel for the appellant that the impugned actions by the respondents were not justified and it was prayed that the same might be set aside reinstating the appellant in service with all back benefits
- 5. On the other side the learned law officer defended the impugned action and prayed for dismissal of the appeal.
- 6. It appears that the educational testimonials of the appellant, submitted by him, at the time of seeking appointment, were sent to the concerned authorities for verification of the same. The BISE Abbottabad vide letter No.97-F dated 02.11.2017 found the DMC of the appellant to be fake and that is why his appointment order was withdrawn. The appellant has not taken any other steps in the civil court or for that matter with the BISE authorities for declaring the DMC to be valid and not fake. Therefore, the impugned action is quite justified and this appeal is groundless. The same is dismissed accordingly with costs. Consign.
