ORDER.

Inspecor Sikandar Shah, now acting DSP was awarded the minor punishment of 02 years approved service by SP/Rural Peshawar vide OB No. 124, dated 21.04.1997 on the allegations that he while posted as Muharrar PP Naguman recovered blueprint cassettes from the shop situated in the jurisdiction of PP Naguman but he instead of registration of FIR harassed the shop keeper. He then filed a departmental appeal which was also filed/rejected by the competent authority vide order No. 6980/EC-II, dated 27.09.2009.

Feeling aggrieved the appellant then filed service appeal before the Honorable Khyber Pakhtunkhwa Service Tribunal. The appeal was thoroughly contested by the department through Government pleader by filing para wise comments.

The Honorable Service Tribunal while hearing the arguments passed directions vide judgment order on 11.06.2018 to the effect that "consequent respondently No. 2 CCPO Peshawar is directed to decide the application dated 04.07.2009 of the appellant afresh with speaking order. Copy of application dated 04.07.2009 be also sent to the respondent department for ready reference. The present service appeal is decided in the above terms".

Now the appellant filed execution petition No. 442/2022 for implementation of the judgment order dated 11.06.2018 passed by the Honorable Service Tribunal Peshawar and directed that last opportunity be given. Respondent shall positively produce implementation report on 20.10.2022 before the S.B failing which coercive measures shall be taken against them under the law.

Therefore, in pursuance of the judgement of the Honorable Service Tribunal Khyber Pakhtunkhwa Peshawar dated 03.10.2022, the punishment order of forfeiture of 02 years approved service awarded to him by SP/Rural Peshawar vide OB No. 124, dated 21.04.1997 is hereby set aside.
