



APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 FOR PAY FIXATION FROM BPS 12 TO BPS 14 AND THEN FROM BPS-14 TP BPS-15 AND AGAINST NO ACTION TAKEN ON THE DEPARTMENTAL APPEAL OF APPELLANT WITHIN THE STATUTERY PERIOD OF NINETY DAYS

PRAYER:

That on acceptance of this appeal the respondents may kindly be directed to fixed pay of the appellant from BPS- 12 to BPS-14 and then from BPS-14 to BPS-15 with all back benefits. Any other remedy which this august Service Tribunal deems fit that may also be awarded in favor of the appellant.

R/SHEWETH:

ON FACTS:

Brief facts giving rise to the present appeal are as under:

- 1- That the appellant was initially appointed as PST in BPS-7 now BPS-12 vide order dated 01.03.1993. That after appointment the appellant submitted his charge report and started performing his duty quite efficiently and upto the entire satisfaction of his superiors. Copy of the appointment order & charge report are attached as annexure **A & B.**
- 2- That vide Notification dated 30.05.2013 the appellant was promoted from PST (BPS-12) to the post of Senior Primary School Teacher (BPS-14) on the proper recommendations of

Departmental Promotion Committee. Copy of the Notification dated 30.05.2013 is attached as annexure **C.**

- 3-** That vide Notification dated 29.11.2014 the appellant was further allowed promotion to the post of Certified Teacher (BPS-15) on the proper recommendations of Departmental Promotion Committee. That astonishingly the respondent Department directly fixed the pay of appellant from BPS-12 to BPS-15 instead of BPS-12 to BPS-14. Copies of the Notification dated 29.11.2014 and relevant pages of service book are attached as annexure **D and E.**
- 4-** That due to the above mention malafide and arbitrary action of the respondents the appellant has received great financial loss by decreasing his pay instead of increasing.
- 5-** That appellant feeling aggrieved preferred departmental appeal but no response has been received from the quarter concerned so far. Copy of departmental appeal is attached as annexure..... **F.**
- 6-** That appellant, having no other remedy, prefer the instant appeal on the following grounds amongst the others.


GROUND:

- A-** That the inaction of the respondents by not fixing pay of the appellant from BPS-12 to 14 is against the law, facts, norms of natural justice and materials on the record.
- B-** That appellant has not been treated in accordance with law and rules by the respondent Department on the subject noted above and as such the respondents violated Article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.
- C-** That the respondents acted in arbitrary and malafide manner while fixing the pay of appellant from BPS-12 to BPS-15 directly instead of from BPS-12 to BPS-14.
- D-** That no notice has been issued to the appellant before fixation of his pay from BPS-12 to BPS-15.
- E-** That no chance of personal hearing/defense has been provided to the appellant and as such the respondents violated the principle of Audi Altrem Partum.
- F-** That according Article 38(e) of the Constitution of Pakistan, 1973 state is bound to reduce disparity in the income and earning of the individuals including persons in the various classes of the service of Pakistan.

G- That appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed for.





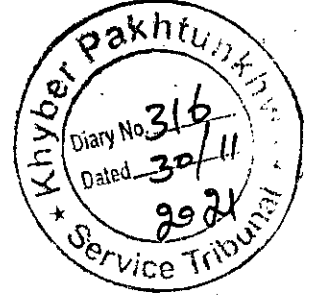

FACTS


- (1) That Para No: 1 of the facts is pertains to record.


GROUNDS

It is therefore humbly prayed that the appeal in hand may graciously be dismissed with cost.



Explanatory Notes :-

(i) In the case of Government servant who elects the Leave Rules, 1955, the leave account should commence with the opening entry under the heading "Due on 13th October 1955" written across columns 2 to 6. The earned leave due on the date should be noted in column 7. The leave on average pay under the ordinary leave rules on the date will be noted in column 7 upto the maximum limit of 4/2 months and the balance in column 8. The leave on half average pay that should be carried forward as balance at credit on 14th October, 1955 shall be the leave calculated at the rate under Leave Rules, 1955, as if that rate had been applicable to the Government servant from the beginning of his service under Government less, the period of leave with allowances other than leave on average pay or earned leave already taken by him under the rules applicable to him on 13th October, 1955. Such leave will be noted in column 9.

(ii) When Government servant applies for leave, columns, 2 to 9 should be filled in. Columns 2 to 4 should be shown the period of duty up to date preceding that on which a Government servant intends to go on leave and $\frac{1}{11}$ th in the case of Govt. servant in superior services of this period should be noted in column 5 $\frac{1}{22}$ nd in the case of the Class IV Government services. $\frac{1}{12}$ th or $\frac{1}{22}$ nd of the period in column 4 should also be shown in column 6. The balance in column 18 plus the leave earned vide column 5 up to the maximum 4/2 months in the case of Government servants in superior services and Class IV Government servants should be noted in column 7. The balance in column 19 plus the remaining leave out of the earned—vide column 5 (if any) will be noted in column 8 i.e. (column 18 and 19th + column 5—column 7). The figures in columns 7 to 9 will show the leave at credit of a Government servant. The grant of leave at one time will be subject to the prescribed maximum, i.e. 4/2 months on average pay against column 7 and six months against column 8 are against column 7+8 if combined. The maximum amount of leave on average pay against columns 7 to 9 each or altogether, combined with leave on half average pay against column 9 that can be taken at one time will be one year i.e. (4th months on average pay and 8 months on 1/2 average pay), but if supported any Medical Certificate it can be extended to two years, i.e. (6th months on average pay and 1 1/2 years on half average pay).

(iii) When a Government servant returns from leave column 10 to 20 should be filled in. The period of leave on average pay taken against the maximum limit of 4/2 months should be entered in column 11 and that taken on Medical Certificate or for Pilgrimage, Education, Rest and recreation on side Pakistan, Ceylon, Burma and India should be entered in column 12. The leave on average pay taken on Medical Certificate by conversion of leave on half average pay should be entered in column 13 (a) and its double in column 13 (b) till maximum of 12 6 months is worked up to in terms of average pay, leave on half average pay should be entered in column 15 and total columns 13.(b) plus 15-16 noted in columns 17.

(iv) If the leave taken on half average pay exceeds, the amount of such leave at credit the excess should be shown in red ink in column 17 and 20. When a Government servant returns from leave which was not due, to leave shall become due to him until he earns leave equal to the period of leave which he took before it was due. Leave not due can be taken up to a maximum of 12/3 months as the case may be in the whole service under rules 5 of the Leave Rules, 1955.

(v) Sick leave, maternity leave, hospital leave, extraordinary leave and quarantine leave should be noted in column 21.

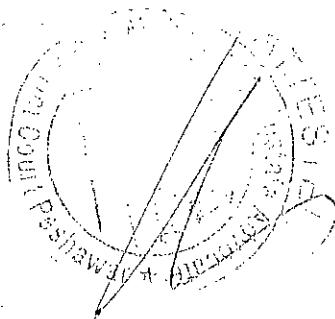
