





 Respectfully Sheweth:-

1. That on 08/09/1999 the Appellant was appointed on contract basis in BHU Rahat-kot, District Swat against the vacant post as a Medical Officer BPS-17. **(Copy of the appointment order is attached as annexure "A").**
2. That on 08/09/1999 Appellant after appointment submitted his charge report on dated 10-09-1999, in the said Hospital. **(Copy of charge report is attached as annexure "B").**

3. That on 18-06-2021 the respondent No. 1 issued notification No. SOH (E-V) GEN. CADRE/BS-18/2021 regarding promotion and final seniority list of the general cadre doctors. **(Copy of the Notification and Final Seniority list is annexure "C")**.
4. That on 17-01-2022 Appellant assailed this notification before the competent by filing departmental appeal before respondents No 1. which is still pending. **(Copy of Departmental appeal is attached as annexure "D")**
5. That the Appellant performed his duty with utmost satisfaction and zealous up the entire satisfaction of his high-up's Therefore the service of the Applicant was finally regularized.
6. That the services of the Appellant were regularized on 28/02/2010. In this respect the Government of KP issued notification No. SO (E) H-/13-118/2009 wherein the services were regularize with immediate effect from 14/10/2009. **(Copy of Notification No. SO (E) H-/13-118/2009 as annexure "E")**.
7. That some of the employees of the Health Department challenged their regularization before the Peshawar High Court Peshawar by filing Wirt Petition no: 1510 /2007, which was allowed by the Peshawar High Court on 18/11/2008 Therefore the services of the Appellant along with other incumbent were regularized under the regularization Act of 2005, so the name of the was placed on serial no 595 the Government of KP Health Department Issued Notification on 17/10/2017.
8. That on 02/01/2018 the Appellant was promoted to BPS-18 on regular basis with immediate effect.
9. That now the Appellant time and again approached to the competent Authority for his promotion by filing various application, which is still pending.
10. That Appellant is appointed on 08/09/1999 but inadvertently his appointment order has been mentioned as 09/02/2005 which is against the facts and law available on the subject, Therefore, the Applicant was deprived from his due right of promotion.
11. That Appellant delivered meritorious service to the Department for the last two decades but unfortunately the applicant was deprived from his promotion to BPS-20.

12. That the juniors incumbent were promoted but Appellant was deprived from his due right for no legal reason, Therefore, Appellant promotion to the next higher post is the basic fundamental right.

GROUND:

- a) That Appellant was appointed by the competent authority after due codal formalities available on the subject.
- b) That Appellant was eligible having requisite qualification to be appointed that on 08/09/1999 the Appellant was appointed on contract basis in BHU Rahat-kot, District Swat against the vacant post as a Medical Officer BPS-17.
- c) That respondent without giving any sound reason for withdrawal, arbitrary and unilateral action is taken against the Appellant.
- d) That there is no complaint or any other allegation of any misconduct has not been leveled.
- e) That respondent violated the mandatory provision of law available on the subject.
- f) That no opportunity of personal hearing has been given to Appellant neither no inquiry whatsoever has been conducted by the respondents but without any reason was given to Appellant.
- g) That the Appellant was not dealt in accordance with law, therefore they were discriminated by the respondents.
- h) That, any other grounds may be adduced during the course of arguments, with the kind permission of this Honorable Court.

PRAYER:

It is therefore most humbly prayed that on acceptance of this appeal. a) The seniority list issued by the respondent dated 18-06-2021 may kindly be corrected.

b) The contractual period(services) of the appellant maybe counted for the purpose of promotion to next higher grade because the appellant was appointed on 08-09-1999 instead of 08-02-2005.
