PRAYER IN APPEAL

On acceptance of this appeal, the official respondent may kindly be directed to release the salary of the appellant from the date of his initial appointment forthwith.

Respectfully Sheweth;

The facts of the instant are as under.

1. That the appellant is the permanent resident of Dir Lower and has been appointed as Ward Attendant (BPS-04) vide appointment letter bearing No. 411-12 dated 28.01.2017 (Copy of appointment letter is attached)
2. That the appellant submitted his arrival report on 30.1.2017 in the office of respondent No.3 (**Annex-A**).
3. That after the appellant was directed to perform his duty as Ward Attendant orthopedic OPD (Morning) and later on he is performing his duty as ward attendant in Surgical-A (Morning). (Copies of the office orders issued by the competent authority are attached)

4. That after the appellant asked for his salary and repeatedly knocked the door of competent authority but they are not willing for payment of salary of appellant, so, feeling aggrieved, he filed a writ petition bearing NO. 980-M of 2018 before the honourable Peshawar High Court Mingora Bench, wherein the honourable court vide judgment dated 23.10.2018 treated the writ petition ibid as department appeal and directed the respondent NO.2 for adjudication of the same. (Copy of judgment dated 23.10.2018 is attached as annexure-B)
5. That the appellant repeatedly asked about the fate of his departmental appeal, but till date as no response has shown by the concern authority.
6. That after, no reply has been received by the appellant during the stipulated time, so the appellant have no other remedy except to file the instant service appeal before this Service Tribunal, inter alia on the following grounds.

GROUND

- A. That the act of respondents, i.e. non-payment of salaries of the appellant, is illegal, against the rules, policy, hence be declared unlawful and in effective.

B. It is admitted that that appellant is still working in the department but the salaries have not been released to him from the date of his appointment without any reason, so such act of the respondents is contrary to the law and liable to be set at naught.

C. That the appellant after appointment, working in the department and there is no complaint whatsoever against him, so, withholding salary of the appellant without removal from service in accordance with law is contrary to the law of civil servants, hence the act of respondent qua stoppage of salary is highly discriminatory and against the fundamental rights guaranteed by the constitution of Islamic Republic of Pakistan, 1973.

D. That the authority could not be permitted to withhold the salary of his serving employee and to make him starve for no fault on his part.

E. That further grounds with leave of this honourable Court would be raised at the time of arguments.

3. That after the petitioner was directed to perform his duty as Ward Attendant orthopedic OPD (Morning) and later on he is performing his duty as ward attendant in Surgical-A (Morning). (Copies of the office orders issued by the competent authority are attached)
4. That after the petitioner asked for his salary and repeatedly knocked the door of competent authority but they are not willing for payment of salary of petitioner, so, the petitioner feeling aggrieved, have no other remedy except to file the instant petition on the following grounds.

That the respondents submit the following reply.

PRELIMINARY OBJECTIONS.

1. That the appellant has got no cause of action to institute the instant service appeal
2. That the appellant has no locus standi to file/institute the instant appeal.
3. That the appellant is estopped by his own conduct to file the instant appeal
4. That the instant appeal is bad for non joinder of necessary party and misjoinder of unnecessary party.
- 5).That the official record reveals that the appellant is not appointed as Ward orderly.
- 6).That the appellant had never submitted his appointment order, arrival report and Health & Age certificate to the office concerned of the Department.
- 7). That the appointment letter bearing No. 411-12 dated 28/1/2017 is forged, bogus, illegal and without law full authority and thus carries no legal force as it bears no initial of the concerned Health office. It is pertinent to mentioned that according to policy of the Government the Head Clerk or Establishment Clerk of the MS office makes an initial before signing any letter by the administrative officers.
- 8). That the dispatch register contain the dispatch No. 411-12 but does not disclose any further detail or information and is vacant and thus the said dispatch number. Proprio vigor does not create any right or liability (copy attached as Annexure-I).
- 9).That brother of appellant namely Mujtaba has been appointed vide order of the selection committee bearing endorsement No. 5112 dated 23/12/2016 alongwith other

candidates but the said order of the selection committee does not contain the name of the appellants (copy of order of selection committee Annexure-II).

10). That the proposition advanced by the appellant that he is an employee of the Department which is false and misleading even if accepted in that case too the appellant has not submitted an arrival report nor has he joined the duty within the 15 days from the date of appointment which is mandatory as per Para-8 of the appointment order.

11). The appeal in hand is not maintainable in the present form.

ON FACTS:-

1. That Para-1 is admitted to the extent of residence of the appellant but the rest of the Para is denied. The appellant has never been appointed as Ward orderly/ward attendant as no official record about the appointment of the appellant is present/available at the office/department. The appointment letter No. 411-12 dated 28/1/2017, is forged, bogus, self-created, illegal and without law full authority. It is worthy to mention that the appellant has not mentioned the appointing authority who issued the appointment letter.
2. That the appellant never submitted any arrival report in MS office the report annexed by the appellant is forged, bogus, illegal and without law full authority hence Para-2 is denied.
3. Para-3 is denied the official record reveals that the appellant has never been an employee of the department. The attendance Registers of different Units neither contain the name of the appellant nor show any attendance of the appellant which by itself negates the fact that the appellant ever served the Department thus the appellant was directed to perform duty as Ward attendant OPD and later on as Ward Attendant in Surgical "A" Ward is wrong, incorrect, misleading and contrary to the true facts. It is pertinent to mention that the order dated 9/10/2017 bearing endorsement No. 4829-33 dated 9/10/2017, was inadvertently issued by the then MS Dr. Anwar Zada was later on withdrawn when he came to know the real facts. (Copy of Attendance Register and withdrawal letter are attached as Annexure-iii and iv).
4. Para-4 is denied. The appellant has never been an employee of the department as per official record moreover the department was unable to proceed/adjudicate the Departmental appeal as per direction of the honourable Peshawar High court Mingora Bench because no official record of the appellant is available with the department as the appellant has never been an employee of the Department.
5. Para-5 is denied as briefly explained in the aforementioned Paras.
6. Since the appellant has never been an employee of the Department so the question of replying to any claim or objection of the appellant is immaterial and is thus a futile exercise.


ON GROUNDS.

- B. That the respondents department never admitted that the appellant has ever worked or is still working in the Department nor was he an employee of the Department so Para "B" is denied.



It is therefore most humbly prayed that on acceptance of this reply the instant appeal may kindly be dismissed, so as to serve the ends of justice.



above officials are attached maybe considered integral part of this rejoinder.

8. Incorrect, in response of the PARA it is stated that the copy of allege register attached with comments by the official respondent available at page no.5 (annexure-01) is forge/manufactured/bogus. It is further stated that one Mujtaba appointed vide endst No. 396-97 dated 28.01.2017 as mentioned in the same copy of register as empty however, the said official (Mujtaba) is a regular employee since 28.01.2017, similarly the other employees like Ikram ullah & Ibad ur Rehman also regular employees but in the said allege copy of register no entry whatsoever have been mentioned , so, the respondents have attached a forge/bogus copy of register just to deprive the appellant from his legitimate right, hence, such act of the official respondents as attaching the manufactured copy of register amounts to mis-reading & the said official who annexed the allege copy is liable to panel consequences.

9. Incorrect, as the minutes of the meeting are not relevant as one Sana Ullah Son of Muhammad Laiq shown as selected for the post of Chowkidar vide minutes dated 23.12.2016 although the appointment order of the said employee has been issued on 28.2.2017, on the other hand, Matiullah has not been reflected in the said minutes of meeting but has been appointed vide order dated 1.3.2017, so the alleged minutes of the meeting is not such a document to be treated such a scale to deprive the appellant from his legal right.
