The sum total of what has been addressed at the bar by learned counsel representing appellant, is that the latter was denied promotion to SST (General) for the reasons that he is holding a 3rd Division Bachelor Degree whereas the Hon'ble Peshawar High Court in its decision at Abbottabad Bench had suspended the rules on the subject by holding that all the candidates holding a Bachelor Degree of 3rd Division have to be promoted but in-spite of the fact the case of appellant was not considered. He pointed out that the Service Tribunal is holding an exclusive jurisdiction in the matter arising out of the Civil Servants Act, 1974, read with Article 212 of the Constitution of the Islamic Republic of Pakistan. The departmental appeal moved for the purpose proved abortive, hence, the present service appeal.

The point so agitated at the bar needs consideration. The appeal is admitted for regular hearing subject to all just legal objections. The appellant is directed to deposit security and process fee within 10 days, thereafter, notices be issued to the respondents for written reply/comments for 15.02.2021 before S.B at Camp Court, Abbottabad.

DECLARATION THAT THE APPELLANT IS
SERVING AS SENIOR CT AND IS ELIGIBLE
TO BE PROMOTED AS SST GENERAL ON
THE PRINCIPLE OF SENIORITY CUM
FITNESS, BUT RESPONDENTS'
DEPARTMENT DID NOT PROMOTE THE

APPELLANT AGAINST THE POST OF SENIOR SST GENERAL VIDE IMPUGNED PROMOTION ENDST. 8553-58 DATED 17/02/2020 ON THE GROUND THAT APPELLANT IS HAVING 3RD DIVISION IN BA WHICH IS PERVERSE, DISCRIMINATORY AGAINST THE LAW AND THE APPELLANT IS ELIGIBLE TO BE PROMOTED AS SST GENERAL.

PRAYER: ON ACCEPTANCE OF THE INSTANT SERVICE APPEAL, RESPONDENTS' DEPARTMENT MAY GRACIOUSLY BE DIRECTED TO PROMOTE THE APPELLANT ON THE PRINCIPLE OF SENIORITY CUM FITNESS WITH ALL SERVICE BACK BENEFITS FROM THE DATE OF PROMOTION OF OTHER EMPLOYEES. ANY OTHER RELIEF WHICH THIS HONORABLE TRIBUNAL MAY DEEMS FIT AND PROPER IN THE CIRCUMSTANCE OF THE CASE MAY ALSO BE GIVEN TO THE APPELLANT.

Respectfully Sheweth:-

The facts forming the background of service appeal are arrayed as under:-

1. That the appellant was promoted from CT to Senior Ct vide order Endst. No. 1502-09/EB/CT/SCT, dated 28/02/2013. Copy of promotion order dated 28/02/2013 is annexed as Annexure "A".
2. That the appellant is serving as Senior CT from the date of his promotion with complete devotion, dedication and to the entire satisfaction of his superior. As per seniority list of SCT name of the appellant is placed at serial No. 149 as per promotion order of senior CT.
3. That the appellant is MA and fulfills the criteria prescribed for promotion from SCT BPS-16 to SST General. The appellant is 3rd division in BA therefore, the respondents' department did not promote the appellant from Senior CT to SST General. Copy of Degrees/ Certificates of the appellant are annexed as Annexure "B".

4. That respondents' department issued promotion order of SCT to SST General vide promotion order Endst. 8553-58, dated 07/02/2020 but the appellant has not been promoted due to the sole reason that the appellant is 3rd division in BA. Copy of impugned promotion order dated 07/02/2020 is annexed as Annexure "C".

5. That feeling aggrieved the appellant filed departmental appeal to the next higher authority on 29/02/2020 which is still pending in the office of Secretary E&SE. Copy of departmental appeal is annexed as Annexure "D". Hence the instant service appeal is filed inter-alia on the following grounds:-

GROUND:-

- a. That having the degree of BA 3rd Division is no clog/ fetter in the way of promotion from SCT to the post of SST General. The question of 3rd division in BA has been settled by the Honourable Peshawar High Court in the judgment/ order dated

13/02/2017 as well as in judgment dated 05/04/2016. Copies of judgments of Peshawar High Court are annexed as Annexure "E".

- b. That the judgments of the Honourable Peshawar High Court have been upheld by the Apex Court vide judgment dated 03/05/2017. Copy of the judgment of the Apex Court is annexed as Annexure "F".
- c. That it has been settled by the Apex Court that when a point of law is decided in a particular case that must be made applicable in all the case of the employees who are similarly placed. Reliance is placed on 2009 SCMR 1.
- d. That the impugned promotion order dated 07/02/2020 is violative of the rules on the subject. The appellant has not been treated in accordance with law and the rules on the subject. Hence the appellant is eligible for promotion on the principle of seniority cum fitness.

- e. That when law prescribed something which is to be done in a particular manner that must be done in that manner and not otherwise. As per precedent case law on the subject respondents' department was supposed to promote the appellant from SCT to SST General.

- f. That fundamental right of promotion of the appellant has been violated with malafide intention by the respondents' department without any reason and justification. The respondents' department has led the appellant to the placed which is utterly unknown to the principle of the natural justice, good governance and fair play.

- g. That the matter in issue relates to the terms and conditions of the service, therefore, this Honourable Tribunal has jurisdiction to entertain the instant service appeal under Article 212 of the constitution.

- h. That other points shall be urged with the permission of Honourable Tribunal at the time of arguments.



IKRAMULLAH KHAN, J.- Through the instant writ petition under Article 199 of the Islamic Republic of Pakistan, 1973 the petitioner seeks declaration to the effect that the act of respondent No.3 whereby the promotion notification dated 28.10.2014 was withdrawn vide impugned notification dated 24.04.2014 on the ground of having qualification of B.Sc (3rd division) is illegal and without lawful authority and against the judgment of this court passed in W.P.No. 58-B of 2014.

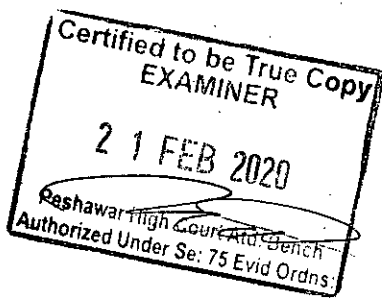
2. In essence, the petitioner was initially appointed as Certified Teacher and, as per entitlement, later on promoted to the post of Senior Certified Teacher (BPS-16) vide notification dated 28.10.2014 whereafter the petitioner assumed the charge of the said post on 30.10.2014 and after performing his duties to the satisfaction of his competent authority, on 24.04.2015 respondent No.3 has passed the impugned notification and, as

such, the promotion order of the petitioner was withdrawn on the ground of having B.Sc in third division.

3. Comments were called from respondent No.3, who filed the same, averring therein that though petitioner was promoted to the post of SST vide notification dated 28.10.2014 by respondent No.2 but on scrutinizing his qualification documents, it was found that petitioner was not eligible for promotion to the post of SST being B.Sc third divisioner, hence, his promotion order was de-notified by the Director Elementary and Secondary Education Khyber Pakhtunkhwa Peshawar and on the direction of Director the promotion order of the petitioner was withdrawn vide impugned notification dated 24.04.2015.

4. It has further been averred in the comments that promotion order of the petitioner was withdrawn on the ground of B.Sc third division and it was done in light of policy circulated vide Notification No.SO(PE)4-5 / SSRC / meeting / 2013 / teaching cadre dated 24.07.2014 according to which the method of recruitment of SST was specified with a first condition of at least second class BA / B.Sc from a recognized University on need basis with two relevant subjects alongwith second condition of MA Education or B.Ed from the recognized University. Further averred that it is the prerogative of the government to enhance, modify or alter the promotion

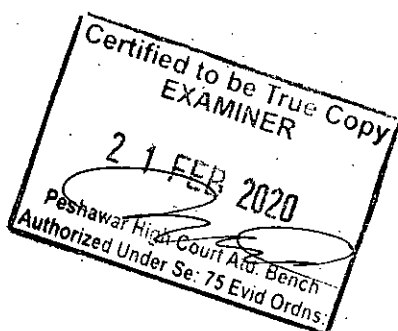
criteria / policy for the civil servants and a civil servant is not supposed to be treated with a set of rules of his own choice.

5. In response to Para-6 of the petition, respondent No.3 averred in the comments that the judgment of this court was announced on 04.06.2015 whereas the withdrawal order of the petitioner was passed on 24.04.2015, prior to the announcement of the judgment.

✓ 6. The main contention of learned counsel for the petitioner is that this court has already declared the condition of having third division as null and void in its judgment dated ✓ 04.06.2015 and the case of the petitioner is on better footing for the reason that in the referred judgment the petitioner had not been appointed but so far as the case of the petitioner is concerned, he was duly promoted rather received its benefits ✓ from 28.10.2014 to 24.04.2015 and thus, the impugned order is illegal, without lawful authority and jurisdiction.

7. Admittedly, the petitioner was duly promoted to the post in question on 28.10.2014 after the departmental promotion committee evaluated his case / PERs.

8. Now the question for determination before this court would be that when the petitioner actually performed his duties on the promoted post and that too for six long months, then how the respondent No.3 could withdraw the earlier promotion order only on the pretext of having B.Sc third division.

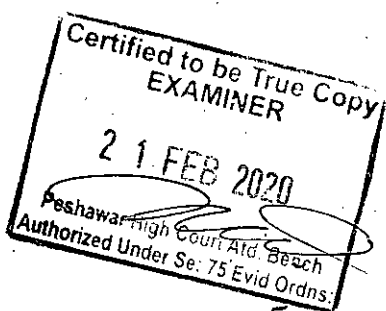

8. It appears from the record that a Division Bench of this had already declared the condition of having third division as null and void in its judgment dated 04.06.2015 which fact has also been affirmed by the respondent No.3 in his comments by stating that they were not aware of that judgment at the time of withdrawal of the impugned promotion of the petitioner and when the case of the present petitioner is at par with that of the petitioner therein, rather on better footing because the petitioner was not only promoted to the post in question but he performed his duties for six long months and received its benefits, the impugned notification passed by respondent No.3 is required to be set at naught.

9. It is also a well settled principle of law that once a benefit is granted to a civil servant, cannot be taken back from him and, if so, very stringent strong reasons are required for the same, which are not available in the case in hand, moreso, when the promotion order of the similarly placed teachers having B.Sc third division have not been so far withdrawn which is clearly violation of Article 25 of the Constitution of Pakistan.

10. For the reasons mentioned above, this petition is accepted and the impugned notification dated 24.04.2015 issued by respondent No.3 whereby the promotion order of the petitioner was withdrawn is declared to be without lawful

ORDER

Ejaz Arzal Khan, J. This petition has arisen out of the judgment dated 28.1.2016 passed by the Peshawar High Court, Bannu Bench whereby it allowed the petition filed by the respondent by holding as under:-

"In wake of the above, we direct the respondents to consider the petitioner for promotion to the post of SST (BPS-16) in the next Departmental Promotion Committee meeting on the basis of his degree in MA History and Pak Study coupled with M.Ed qualifications. The writ petition is disposed of in the above terms."

2. Learned Additional Advocate General, appearing on behalf of petitioners contended that since the dispute urged before the High Court relating to eligibility fell within the preview of terms and conditions of

service, the High Court could neither entertain the petition nor grant the desired relief and that the impugned order being void and Coram non iudice cannot be maintained. When asked, how would he explain the delay of 187 days in filing the petition, he could not give any plausible explanation in this behalf.

3. Learned ASC appearing on behalf of the respondent contended that the respondent deserved appointment on merit, therefore, nothing terrible would happen if he is allowed to continue.

4. We have gone through the record and considered the submissions of the learned counsel for the parties. There is a delay of 187 days in filing of this petition which has not been explained much less plausibly. When so we do not feel inclined to grant leave in this case, notwithstanding entertainment of petition in this case under Article 197 of the Constitution of Islamic Republic of Pakistan was unwarranted.

For the reasons discussed above, we dismiss this petition alongwith the CMAs No. 883-P for condonation of delay and 884-P/2016 for suspension of the impugned judgment.



Respectfully Sheweth:-

Comments on behalf of respondents are submitted as under:-

PRELIMINARY OBJECTION:-

1. That the appellant has no cause of action to file the instant appeal.
2. That the appeal of the appellant is time barred. Hence liable to be dismissed.
3. That the appellant has filed the present appeal to pressurize the respondents.
4. That the appellant has not come to this Honorable Tribunal with clean hands.
5. That the appellant is estopped to sue due to his own conduct.
6. That the instant appeal is not maintainable due to non-joinder and mis-joinder of necessary parties.
7. That the appellant has suppressed the material facts from this Honorable Tribunal, hence, not entitled for any relief and appeal is liable to be dismissed without any further proceeding.
8. **That the instant appeal is against the Notification No. SO(PE)4-5/SSRC/Meeting/2013/Teaching Cadre dated 24 July 2014 hence, same is liable to be dismissed without any further proceedings and appellant did not challenge the said Notification/Policy.**
9. **That the appellant is not eligible for promotion for the post of SST due to non-fulfillment of requisite criteria i.e. at least second class Bachelor Degree's from a recognize University whereas, appellant passed his B.A in 3rd Division.**

10. That as per judgment reported as 2013-SCMR-99, this Honourable Tribunal has got no jurisdiction to entertain the instant Service Appeal as Tribunal has got nothing to do with the fitness for promotion case hence, instant service appeal is liable to be dismissed without further proceedings.

11. That the August Supreme Court of Pakistan suspended the operation of the impugned judgment dated 13-02-2017 passed in WP No. 559-A/2016 in Civil Appeal of 2039 of 2019 out of CP No. 204-P/2017 titled Govt of KP & Others VS Fazal Qadeem & Others vide order dated 09-12-2019.

Factual Objections:-

1. That the Para No. 1 of the instant service appeal relates to the service record of the appellant hence, need no further comment.
2. That the Para No.2 of the instant appeal as composed is incorrect hence, denied as per final seniority list Senior CT BPS-16 the name of appellant is placed on serial No. 146. (Copy of relevant pages of the seniority list is hereby annexed as annexure "A").
3. That the Para No. 3 of the instant service appeal is correct to the extent that appellant is 3rd division in BA while, rest of the Para as composed is incorrect hence, denied. As per **Notification No. SO(PE)4-5/SSRC/Meeting/2013/Teaching Cadre dated 24 July 2014 the requisite criteria for the promotion of SST is as under:-**

"I. At least second class Bachelor Degree's from a recognized University on need basis from the following groups with two subject:-

(a) (Chemistry , Botany or Zoology),

Or

(b) (Physics, Maths "A" or "B" or Statistics)

Or

(c) (Humanities and other equivalent groups at degree level with English as compulsory subject;

And

II. Bachelor of Education or Master of Education (Industrial Art or Business Education) or M.A Education or equivalent qualifications from a recognized University.

Whereas, appellant passed his Bachelor in 3rd division. (Copy of the notification dated 24-07-2014 is annexed herewith as Annexure "B").

4. That the Para No. 4 of the instant service appeal is correct to the extent of issuance of promotion order Endst: No. 8553-58 dated 07-02-2020 while, rest of the para as composed is incorrect hence, denied as the name of appellant is included at serial No. 22 in the working paper for Departmental Promotion Committee for promotion of SCT to SST (G) dated 11-11-2019 but the Departmental Promotion Committee did not recommend the name of appellant for promotion because of 3rd Division in B.A hence, appellant is not eligible for promotion for the post of SST (G) as per Notification dated 24-07-2014 the requisite qualification for the post of SST is at least second class Bachelor Degree's from a recognize University and eligible teachers have been promoted. (Copy of working paper is annexed herewith as Annexure "C").
5. That the Para No. 5 of the instant service appeal relates to record.

Grounds:

- a. That ground a, of the instant appeal as composed is incorrect, hence denied as the August Supreme Court of Pakistan suspended the operation of the impugned judgment dated 13-02-2017 passed in WP No. 559-A/2016 in Civil Appeal of 2039 of 2019 out of CP No. 204-P/2017 titled Govt of KP & Others VS Fazal Qadeem & Others vide order dated 09-12-2019. (Copy of the order dated 09-12-2019 is annexed herewith as Annexure "D").
- b. That the comprehensive reply has already been given in ground a.
- c. In reply to ground c, of the appeal it is submitted that each case has its own facts and circumstances.
- d. That ground d, as composed is incorrect hence, denied as impugned promotion order was issued in accordance with Law, Rules and Policy.
- e. That ground e, as composed is incorrect hence, denied. Complete reply has already been given in ground a.
- f. That ground f, as composed is incorrect hence, denied no fundamental right of the appellant has been violated as appellant did not fulfill the requisite criteria mentioned in the notification dated 24-07-2014 hence, not eligible for promotion.
- g. That ground g, as composed is in incorrect hence, denied as per judgment reported as 2013-SCMR-99, this Honourable Tribunal has got no jurisdiction to entertain the instant Service Appeal as Tribunal has got nothing to do with the fitness for promotion case hence, instant service appeal is liable to be dismissed without further proceedings.



Gulzar Ahmed, J. We have heard the learned Additional Advocate General, KP. He has specifically relied upon the Rules pertaining to Elementary and Secondary Education Department contained in Notification No. SO(PE)4-5/SSRC/Meeting/2013/Teaching Cadre dated 24.07.2014 whereby the appendix to Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion and Transfer) Rules, 1989 were amended and for the post of Secondary School Teacher, eligibility criteria was mentioned that of atleast Second Class Bachelors' Degree from a recognized University on need basis from the groups mentioned therein. He contends that admittedly the respondents do not

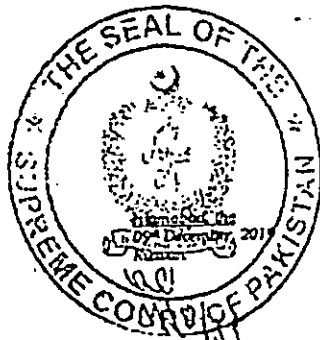
comply with this eligibility criteria, for that, they are not Second Class Bachelors' Degree holders rather Third Class Bachelors' Degree holders and thus, their promotion cannot be made.

2. We have gone through the relevant documents and are of the view that the High Court by allowing promotion to the respondents perhaps has gone beyond what the eligibility criteria has provided in the Rules and thus the matter needs consideration. He further contends that the High Court had no jurisdiction in the matter as it related to terms and conditions of service of the respondents and in terms of Article 212 of the Constitution the very jurisdiction of the High Court was barred.

3. Contentions raised by the learned Additional Advocate General, KP require consideration. Leave to appeal is granted to consider, *inter alia*, the same. The appeal shall be heard on the available record but the parties are allowed to file additional documents within a period of one month. As the matter relates to service, the office is directed to fix the same expeditiously preferably immediately after three months.

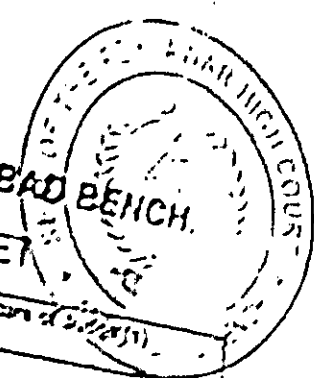

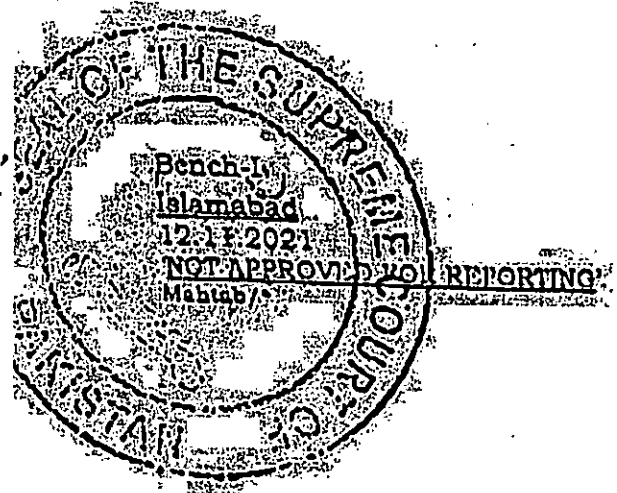
