**SUBJECT: INQUIRY REPORT ABOUT THE INDUCTION OF Mr. LAL BADSHAH, INDUCTED AS PTC
IN BARA DISTRICT KHYBER**

Reference: DEO Khyber Endst. No 2561-69 Dated: 06/10/2022

BACKGROUND HISTORY:

One Mr. Lal Badshah was inducted/appointed on PTC post at GPS Mastak Tirah vide the then Agency Education Officer Endst: 11347-51/Khy:PTC(M) Dated: 26/7/2006 Vide F- 1. According to the statements he hails from District Bajaur the then Bajaur Agency. It was traced out that some Ghost persons/employees were drawing their salaries from the system. Mr. Lal Badshah was one of these Missing or Ghost (Employees). In order to dig out the factual position an inquiry was initiated against all these Missing/Ghost people by the then Agency Education Officer Mr. Mohammad Jadoon Khan. Mr. Lal Badshah was found out as "fake" for he did not appear physically before the inquiry committee. Consequently he was struck off from the Education Roll District Khyber vide DEO Khyber Endst:No: 3066-70 Dated: 15/01/2019.

PROCEDURE ADOPTED FOR COLLECTING EVIDENCE:

The committee informed all of the persons/officials evidently involved in the case. All of them were summoned to District Education Office for personal hearing and answering the questionnaires that were served upon them. It is worth mentioning that the then Agency Education Officer (DEO), who apparently issued the recruitment/induction order, has passed away. The committee summoned the following officials/officers for personal hearing.

1. Mr. Lal Badshah, Ex PST (Fake).
2. Mr. Shamshad Khan the then Superintendent DEO Office Khyber.
3. Mr. Fazal Ur Rahman the then AAEO (ASDEO) Bara.
4. Mr. Hidayatullah the then AAEO (ASDEO) Bara.
5. Mr. Tameez Ud Din the then J/C DEO Office Khyber.

All of the above officials with the exception of Mr. Lal Badshah, personally appeared before the committee. They were interviewed and at the end questionnaires were served upon them for collecting the record in writing. They answered all the queries asked from them. Responses of the above mentioned Ex and serving officials/officers are attached, Vide F- 2(a) to F- 2(d).

Mr. Lal Badshah was contacted through his Mobile No.03090807377 and 03028018046. At first he promised to appear before the committee but refused to appear at the eleventh hour. The committee informed him about the consequences of not cooperating with the inquiry committee but of no avail. The committee thinks that there is something fishy about his case.

The committee retrieved first appointment order and Domicile Certificate of Mr. Lal Badshah from external source. Receipts of payments/Acquittance Roll for the months of October 2006, March 2007, April 2007, July 2007, September 2007, March 2008, and July 2008 (vide F- 3 to F- 9) were collected from DEO Office Khyber. Advertisement for the posts and other codal formalities to fill the posts were also checked and annexed Vide F- 10.

Findings:

- 1 Original 1st Appointment Order/Notification, Charge Reports, and Original Service Book of Mr. Lal Badshah could not found out even after a thorough search. However, other related documents in this connection were retrieved (vide F- 10.)
- 2 Proper procedure was followed in the recruitment of Mr. Lal Badshah i. e the posts were advertised, Departmental Selection Committee was constituted, Test was taken, and Merit List was prepared. (Vide F-10)
- 3 The then Agency Education Officer (AEO) Mr. Abdur Rasheed Qureshy has passed away on 22/04/2009 (vide Death Certificate attached at F- 11).
- 4 As per Domicile certificate, attached as F- 12 Mr. Lal Badshah is a bona fide resident of District Bajaur, the then Bajaur Agency. It is also evident from the claim of Mr. Lal Badshah while making his transfer from Khyber to Bajaur. It was on the basis of his domicile of the Bajaur that he was transferred to Bajaur. Transfer order attached as F- 13
- 5 Evidence shows that Mr. Lal Badshah made fake entry into an Agency/District cadre post. Being a bona fide resident of Bajaur Agency (District Bajaur) he had no right to grab a district cadre post in Khyber Agency (District Khyber). Though his domicile, which paved the way for his appointment, could not be found in office record of the District Education Office Khyber, but all other official documents record him as a domicile holder of District/Agency Khyber. While the fact remains that he had a domicile of Bajaur which he had made in 1996 and on the basis of that domicile he clandestinely made his transfer to Bajaur.
- 6 Mr. Lal Badshah was struck off from the pay roll system of Khyber Education in 2019, (after issuing a Show Cause Notice vide at F- 14) vide DEO Khyber Endst:No 3060-70/struck off/Notification Dated: 15/01/2019 (Annex. F- 15) as he had gone missing and did not appear before the committee constituted to find out the missing employees of Khyber Education who were drawing their salaries on the pay roll of the department.

7. Mr. Lal Badshah made fake signatures of the then Agency Education Officers Mr. Hasham Khan, Mr. Asmat Khan and Mr. Abdur Rauf Shah in his service book. All these officers refused to verify their signatures. Vide annexure F- 16.
8. Mr. Lal Badshah unimpededly received his salaries from July 2006 to October 2017 till he was traced out unavailable for physical verification in October 2017. The mentioned period was turbulent and chaotic due to militancy and military operations in the area where Mr. Lal Badshah was appointed. People of the area were almost left IDPs/TDPs due to the severe threats for their lives. Hence, no proper system of check and balance was possible. Mr. Lal Badshah took full advantage of the situation and remained vanish from the screen. Besides, bomb blast in GPS Mastak and three shifting of the DEO Office, brought about all the relevant record either destroyed, lost or missing.

RECOMMENDATIONS

1. Mr. Lal Badshah being guilty of forgery, may kindly be considered dismissed and all the salaries that he had drawn on the payroll of Education Khyber may be recovered from him.
2. Other necessary proceedings, as the law of the land permits, for the forgery and using unfair means, to obtain a civil service may be initiated against Mr. Lal Badshah.

- 2. The appointment of the candidates will be purely on contract basis and liable to terminate without assigning any notice. If the candidates want to resign their services, they will have to give one month prior notice or forfeit one-month pay in lieu thereof.
- 3. They should produce their original academic/professional certificates/Council before their taking over charge and file two copies of the same on the record of the school/office after the verification from the Board/University concerned.
- 4. They should produce their Health and Age certificate from the Agency surgeon concerned.
- 5. They should not be hand over charge, if they are below 28 years or above 33 years of age.
- 6. If they fail to report their arrival within 15 days the order will be treated as cancelled.
- 7. The order of the candidates is purely on regularly contract basis vide Govt of NWFP Finance Department Notification No. 6 (E&AD) 13-1/2005, dated 10/08/2005. They will not be paid their charges until their documents are verified from the quarter concerned.
- 8. Trained local candidates are permissible for transfer to any where against available vacant post on case to case basis.
