JOINT PARAWISE COMMENTS ON BEHALF OF RESPONDENTS No: 1-3.

Respectfully Sheweth :-

The Respondents submit as under:-

PRELIMINARY OBJECTIONS.

- 1 That the Appellant has got no cause of action locus standi.
- 2 That the instant Service Appeal is badly time barred.
- 3 That the Appellant has concealed material facts from this Honorable Tribunal in the instant service appeal.
- 4 That the instant service appeal is against the relevant provisions of law.
- 5 That the appellant has not come to this Honorable Tribunal with clean hands.
- 6 That the instant appeal is liable to be dismissed for mis-joinder & non-joinder of the necessary parties to the present appeal.
- 7 That the appellant is estopped by his own conduct to file the instant appeal.
- 8 That the instant Service Appeal is not maintainable in the present form & circumstances of the case.
- 9 That the instant Appeal is barred by law.
- 10 That the impugned seniority list dated 13/12/2017 of the respondent No.1 is within legal sphere & liable to be maintained.
- 11 That no Departmental Appeal has been filed by the appellant against the impugned final seniority list as stood on 13/12/2017 has got finality against the appellant.
- 12 That the plea regarding placing the appellant in seniority list to the Respondents No: 4 -434 is without any legal Justification.
- 13 That the Respondents No:1-3 have asked as per law, rules & even the mandatory provisions of the KPK employees Regularization of services ACT of 2009.
- 14 That the mandatory provisions of sections 3&4 have been observed by the Respondents Department prior to the grant of service Regularization of the Respondents No: 4 to 434 & have been placed as per their respective correct seniority against the subject specialist post in BPS17.

ON FACTS.

- 1 That Para-1, is correct to the extent of the Notification dated 10/09/2005 vide which the appellant alongwith 45 subject specialists were inducted in the Respondent department on purely adhoc & contract basis for the initial period of 6 months or till the arrival of the formal selectees of the KPK public service commission Peshawar whichever is earlier with the additional observation that the content & order of the appellant alongwith others shall automatically stand terminated after 180 days from the date of issuance of the said Notification. Whereas, rest of the para is misleading on the grounds that the services of the appellant has properly been placed & shown in the seniority list dated 13/12/2017 as Notified on 01/01/2018 by the Respondent Department under the mandatory provisions of civil servant Act 1973 read with Section -4 of service of Regularization Act 2009. **(Copy of said seniority list dated 13/12/2017 & Regularization Act 2009 are attached as Annexure A&B).**
- 2 That Para-2, is correct to the extent of promulgation of service & Regularization Act 2009 vide which those employees inducted in the Respondent Department on contract/adhoc basis & who were on active strength against the said post till 31/12/2008 were regularized under the mandatory provisions of section 3 of the said Act of 2009 whereas section 4 is applicable upon the case of the appellant who was also working on contract/adhoc basis in the Respondent Department. Therefore, the plea of the appellant regarding the grant of seniority ahead of the Respondents is illegal & even in violation of the sections 3&4 of the Act 2009.
- 3 That Para-3 is correct that vide Notification dated 24/09/2009, the services of the appellant against the SS post has been regularized whereas, regularization of the service Act: 2009 has been passed on 24/10/2009 whereas, the services of the appellant has been regularized vide Notification dated 31/05/2010 with immediate effect. Therefore, the claim of the appellant is baseless & liable to be rejected. **(Copy of the Notification dated 31/05/2010 is attached as Annexure -C).**
- 4 That para-4 needs no comments being pertaining to the record of the KPK public service commission whom the appellant has not made Respondent in the instant case on mala-fide intentions.
- 5 That para-5 also needs no comments as the service Regularization-Act: 2009 to the extent of section 3&4, is very much clear at the time of grant of regularization to Respondents No 4 to 234, the appellant though inducted against the SS post in 2005 but was not regularized till the passing of the said Act in 2009. Hence, under the said Act, the appellant stood junior to the Respondents no 4 to 234 under the relevant provision of law & rules. Hence, taking shelter of the irrelevant Notifications by the Public Service Commission is itself an illegality on the part of the appellant.
- 6 That para-6 is incorrect & misleading on the grounds that the appellant was not regularized till the passing of the Act 2009 against the SS post. Furthermore, the said Act was mainly for the induction of adhoc Subject Specialist of 2009 batch and not for the Subject Specialist of 2005 in the Department. Hence, the stand of the appellant is baseless and the Seniority list dated 13/12/2017 is within legal parameter & liable to be maintained.
- 7 That para-7 is incorrect & denied. No Departmental Appeal has been filed by the appellant against the final seniority list as stood on 13/12/2017 and notified on 01/01/2018 by the Respondent Department. The previous seniority lists were not questioned by the appellant. Therefore, the said final Seniority list has got finality against the appellant under the law of limitation Act 1908. Hence, on this score the appeal in hand is liable to be dismissed. **(Copies of the said seniority list is attached as annexure-D)**


- 8 That para-8 is correct vide judgment dated 07/06/2018 wherein, the Honorable Peshawar High Court Peshawar has returned the petition of the appellant for approaching proper forum under the relevant provisions of law (**copy of the order sheet dated 07/06/2018 is attached as Annexure:- E**)
- 9 That para-9 needs no comments being pertaining to the record of this Honorable Tribunal.
- 10 That para-10 is legal. However the Respondent, No3 further submit on the following grounds inter alia:-

GROUND.

- A Incorrect & not admitted the stand of the appellant is against the mandatory provision of section 3 & 4 of the said Act of 2009, as the appellant was inducted against the SS post in 2005 & has continued as such till his regularization of his services vide Notification dated 31/05/2010 much later than the promulgation of the said Act of 2009. Hence, the claim of the appellant is misleading & liable to be rejected in view of the foregoing submission.
- B Incorrect & not admitted, the Act of the Respondent Department to the extent of issuing the final seniority list dated 13/12/2010 on 01/01/2018 is within legal sphere & liable to be maintained.
- C Incorrect & not admitted the plea of the appellant is without any cogent reason & justification. Hence, deserves to be rejected in view of sections 3 & 4 of the Act of 2009 passed by the Khyber Pakhtunkhwa provincial Assembly.
- D Incorrect & not admitted the impugned Seniority list dated 13/12/2017 as Notified on 01/01/2018 is in accordance with provision of law, rules & criteria in view of the said Act 2009.
- F Incorrect and not admitted. The plea of the appellant is not within legal parameters and liable to be dismissed with the additional submission that the Respondents No 1-3 further seek leave of this Honorable Tribunal to submit additional grounds, case law & record at the time of arguments before the Honorable Bench on the dated fixed.

In view of the above made submissions, it is most humbly prayed that this Honorable, Tribunal may very graciously be pleased to dismiss the instant Service Appeal with cost in favour of the Respondent Department.

to provide for the regularization of the services of certain employees appointed on ad hoc or contract basis.

Preamble---WHEREAS it is expedient to provide for the regularization of the services of certain employees appointed on ad hoc or contract basis, in the public interest, for the purposes hereinafter appearing;

It is hereby enacted as follows:-

1. Short title and commencement.—(1) This Act may be called the North-West Frontier Province Employees (Regularization of Services) Act, 2009.

(2) It shall come into force at once and shall be deemed to have been taken effect at the promulgation of the Ordinance.

2. Definitions. (1) In this Act, unless the context otherwise requires,

(a) "Commission" means the North-West Frontier Province Public Service Commission;

(aa) "contract appointment" means appointment of a duly qualified person made otherwise than in accordance with the prescribed method of recruitment;

(b) "employee" means an ad hoc or a contract employee appointed by Government on ad hoc or contract basis or second shift/night shift but does not include the employees for project post or appointed on work charge basis or who are paid out of contingencies;

(c) "Government" means the Government of the North-West Frontier Province;

(d) "Government Department" means any department constituted under rule 3 of the North-West Frontier Province Government Rules of Business, 1985;

(e) "law or rule" means the law or rule for the time being in force governing the selection and appointment of civil servants; and

(f) "post" means a post under Government or in connection with the affairs of Government to be filled in on the recommendation of the Commission.

(2) The expressions "ad hoc appointment" and "civil servant" shall have the same meanings as respectively assigned to them in the North-West Frontier Province Civil Servants Act, 1973 (N.W.F.P. Act No. XVIII of 1973).

3. Regularization of services of certain employees.— All employees including recommendees of the High Court appointed on contract or ad hoc basis and holding that post on 31st December, 2008 or till the commencement of this Act shall be deemed to have been validly appointed on regular basis having the same qualification and experience for a regular post:

Provided that the service promotion quota of all service cadres shall not be affected.

4. Determination of seniority.— (1) The employees whose services are regularized under this Act or in the process of attaining service at the commencement of this Act shall rank junior to all civil servants belonging to the same service or cadre, as the case may be, who are in service on regular basis on the commencement of this Act, and shall also rank junior to such other persons, if any, who, in pursuance of the recommendation of the Commission made before the commencement of this Act, are to be appointed to the respective service or cadre, irrespective of their actual date of appointment.

(2) The seniority *inter se* of the employees, whose services are regularized under this Act within the same service or cadre, shall be determined on the basis of their continuous officiation in such service or cadre.

Provided that if the date of continuous officiation in the case of two or more employees is the same, the employee older in age shall rank senior to the younger one.

4A. Overriding effect.--- Notwithstanding any thing to the contrary contained in any other law or rule for the time being in force, the provisions of this Act shall have an overriding effect and the provisions of any such law or rule to the extent of inconsistency to this Act shall cease to have effect.

5. Repeal.--- The North-West Frontier Province Employees (Regularization of Services) Ordinance, 2009 (N.-W.F.P. Ordinance No. VII of 2009) is hereby repealed.


1. Their services will be considered as regular but without pension & gratuity in terms of Section-19 of the NWFP, Civil Servants Act, 1973 as amended vide NWFP, Civil Servants (Amendment) Act, 2005. They will, however, be entitled to contributory Provident Fund in such a manner and at such rates as prescribed by the Government.
2. Their Terms & Conditions of service shall be governed under the NWFP Civil Servant Act 1973 and the rules made there under except seniority.
3. Their services will be liable to termination on one month's notice from either side. In case of resignation without notice their one month pay/allowances, shall be forfeited to Government.
4. Their seniority will be determined according to Section-4 of the NWFP, Employees (Regularization of Services) Act, 2009.
5. They should join their post within 30-days of the issue of this notification and they will be required to furnish copies of all their certificates/degrees alongwith original receipts and photo stat copies thereof, pertaining to the verification fee of the concerned Examining body (Board & University) to this Department as well as to the EDOs (E&SE) concerned

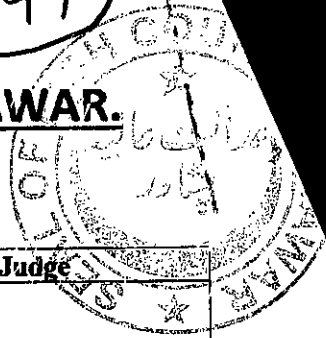

2. Departmental Promotion Committee recommended 43 HMs from BPS-16 to BPs-17 on the following dates:-

3. The contract employees/Subject Specialists (M) in various subjects were regularized in E&SE Deptt: under the NWFP Employees (Regularization) of Service) Act 2009 on 31-5-2010. Three Fifty Seven (357) Male Subject Specialists were regularised under Act 2009.

Conclusion:-

1. As under Adv. No. 1/2009, first appointment order of 118 Male-Subject Specialists was issued on 12/01/2010, and last order was issued on 25/2/2011. In this regard the ESTA code on page 229, SL158 Annexure-III, clause ii(b) states, 'when in a single reference the commission have been asked to recommend more than one person, and the recommendation of the commission is held up in respect of one or more of such persons for want of incomplete papers etc. Or for reasons beyond the control of persons concerned, the recommendation of the commission made subsequently will be deemed to have been made by the commission on the date when first recommendation was made. (Annexure-2)
2. *Imp* → Seniority No. 331 (Badshah Zamin) to seniority No. 758 (Mian Ijaz Mustafa) final seniority list BPS-17(M) officers on 25/5/2017 may be ranked senior as per ESTA Code rules already mentioned on page-229 clause-II (B) than H/Masters promotion order issued on 20-01-2010 and 27/3/2010; respectively.
3. Those subject specialists, who were regularized ^{under} and NWFP Employee Act 2009 and services regularized on 31/5/2010 while Head Masters have been promoted in BPS 17 on 20/01/2010 so the head masters will be ranked senior (Annexure 3):



A. FACTUAL POSITION OF THE CASE:

- i. That KP PSC invited applications from the eligible candidates for the posts of Subject Specialists (BPS-17), vide Advertisement No.01/2009, dated: 26.01.2009.
(Copy of Advertisement dated: 26.01.2009, is attached as Annexure "A")
- ii. That the answering Respondents, being eligible, were recommended by the KP PSC, vide office letters dated: 27.06.2009, 30.07.2009, 20.08.2009, 25.08.2009, 03.11.2009, 10.11.2009, 16.03.2010, 27.03.2010, 01.04.2010, 16.04.2010, 05.05.2010, 06.05.2010 & 17.05.2010 i.e. in 15 intervals.
(Copies of KP PSC recommendations, are attached as Annexure "B")
- iii. That the answering respondents were subsequently appointed, by the competent authority, vide Notifications No. 12.01.2010, 16.08.2010, 23.12.2010, 06.01.2011, 24.02.2011 & 25.02.2011 i.e. more than 5 different intervals.
(Copies of Appointment Notifications, are attached as Annexure "C")
- iv. That KP PSC, after issuance of the final recommendation dated: 17.05.2010, issued inter-se seniority of all the recommendees w.e.f. 27.06.2009 till 17.05.2010, in order of merit, on 13.08.2011, in view of section 35(III)(a)(b) of KP PSC Regulations 2003.
(Copies of extract from KP PSC Regulations 2003 & Inter-se Seniority list dated: 13.08.2011, are attached as Annexures "D" & "E", respectively)
- v. That in pursuance of Inter-se Seniority List dated: 13.08.2011 of KP PSC, tentative departmental Seniority List, was issued on 31.12.2016.
(Copy of Tentative Seniority list dated: 31.12.2016, is attached as Annexure "F")

- vi. That Appellant, alongwith others, being beneficiary of the KP Employees (Regularization of Services) Act, 2009 i.e. KP Act No.XVI of 2009, filed objection(s) against the tentative seniority list dated: 31.12.2016, which were considered at appropriate level and the competent authority, constituted appellate committee, comprising of 04 members including the Chairman, to decide the matter in accordance with law/rules governing the subject, resultantly, after thorough deliberation and giving anxious thought, the recommendees of Advertisement No. 01/2009 i.e. the answering respondents alongwith others, whose appointment orders were issued from 12.01.2010 to 25.02.2011 while the contract employees i.e. appellant and others, were regularized on 31.05.2010 i.e. much latter then the first appointment order of the answering respondents, which was issued on 12.01.2010, therefore, the answering respondents, alongwith others, were declared senior than the appellant & others, hence, their objections were filed/rejected. Needless to add that U/S 04(I) of the KP Act No. XVI of 2009, the employees whose services are regularized shall ranked junior to such other persons, who, in pursuance of the recommendation of the commission made before the commencement of this Act, are to be appointed to the respective service or cadre, irrespective of their actual date of appointment. **(Copies of KP Act No. XVI of 2009 and appellate committee decision dated: 17.10.2017, are attached as Annexure "G" & "H", respectively)**

- vii. That the competent authority, in pursuance of the decision dated: 17.10.2017 of the appellate committee, issued revised/updated final seniority list, as stood on 23.10.2017. **(Copy of final seniority list dated: 23.10.2017, is attached as Annexure "I")**

- viii. That the answering respondents alongwith others were subsequently promoted to BPS-14, vide Notifications dated: 22.10.2018 & 25.01.2019. **(Copies of Notification dated 22.10.2018 & 25.01.2019, are attached as Annexure "J" & "K", respectively)**

- ix. That Minute perusal of the KP PSC recommendations i.e. w.e.f. 27.06.2009 upto 17.05.2010, subsequent appointment Notifications of the answering respondents & others, w.e.f. 12.01.2010 upto 25.02.2011, inter-se seniority list dated: 13.08.2011, issued by KP PSC and final seniority list dated: 23.10.2017, it will transpire that Subject Specialists at S.No.200 (Final Seniority List) is at S.No.06 (Inter-se Seniority of KP PSC) while he was appointed on 23.12.2010, but ranked senior to Subject Specialist at S.No. 588 (Final Seniority List), is at S.No.418 (Inter-Se Seniority List issued by KP PSC), although he was appointed on 12.01.2010, much prior than S.S at S.No.200 and similar is the case with Seniority positions of employees at 234, 239, 427, 442, 544 & 587, therefore, in view whereof, it is clearer then crystal that all the appointees in pursuance of Advertisement No.01/2009 shall be dealt as a single batch/unit and there is no cavil to the proposition that their recommendations and

subsequent appointments shall be presumed as one and the same date, but in order of merit, which is reflecting from the inter-se seniority, issued by KP PSC.

B. PRELIMINARY OBJECTIONS:

- i. That tentative Seniority list was issued on 31.12.2016, however objected by the appellant (Page 137) & other employees, regularized in service, in pursuance of KP Act No. XVI of 2009, but their objections were rejected by the appellate committee, on 17.10.2017 and subsequently the final seniority list, impugned herein, was issued, but astonishingly the said decision has not been challenged by the appellant & others, rather, the same decision has got finality and still holding the field, therefore, the appellant has been estopped by his own conduct to file the titled appeal.
- ii. That 453 S.S were appointed in pursuance of advertisement No. 01/2009 while the appellant has challenged seniority of 430 S.S, therefore, doctrine of misjoinder and non-joinder is attracted.
- iii. That tentative seniority list was issued on 31.12.2016 and, after deciding objections thereto, revised/final seniority list was issued on 23.10.2017, however, the appellant filed departmental appeal, on 10.01.2018 i.e. after 2 months and 17 days, while W.P No. 2807-P/2018 was filed on 10.05.2018 i.e. after 04 months, therefore, the titled appeal is hit by limitations.

C. REPLY TO FACTS:

- 1) Para 1 related to the official respondents.
- 2) Para 2 is correct to the extent that KP Act XVI of 2009 was enacted on 24.10.2009 and under Section 3 whereof, all employees either appointed on contract or Adhoc basis and holding that post on 31.12.2008 or till the commencement of the Act ibid, were regularized in service, however, rest of the para is incorrect, hence denied, moreover, under section 4(1) of the Act ibid, it has been held that the employees whose services were regularized under the Act ibid, shall ranked junior to such other persons, who, in pursuance of the recommendation of the commission, made before commencement of the Act ibid, are to be appointed to the respective service or cadre, irrespective of their actual date of appointment, however the appellant has deliberately suppressed this aspect of the Act ibid, which speaks volumes of malafide on his part.
- 3) Para 3 is related to the official respondents.

- 4) Para 4 is misconceived, hence denied. Moreover, the KP PSC has recommended 453 S.S to the Provincial Govt, in almost 15 intervals w.e.f. 27.06.2009 till 17.05.2010, while the appellant, alongwith others, was regularized in service, w.e.f. 24.09.2009 i.e. much latter than the first recommendation of KP PSC, however, the appellant has deliberately suppressed this aspect of the case, therefore, tried to mislead this Hon'ble Tribunal, hence the titled appeal deserves to be dismissed on this score too.
- 5) Para 5 is related to the official respondents.
- 6) Para 6 is misleading, hence denied. Moreover, the appellant has partially quoted Section 4(1) of the KP Act No. XVI of 2009, while operative part whereof has escaped his sight, which reads as under:

"the employees whose services were regularized under the Act *ibid*, shall ranked junior to such other persons, who, in pursuance of the recommendation of the commission, made before commencement of the Act *ibid*, are to be appointed to the respective service or cadre, irrespective of their actual date of appointment"

In view of the above it is clearer than crystal that the answering respondents shall ranked senior than appellant. Furthermore, the tentative seniority list, issued on 31.12.2016, was objected by the appellant and others but their objections were turned down by the appellate committee, vide decision dated: 17.10.2017, which has not been challenged and thereafter, the revised seniority list was issued on 23.10.2017, therefore, the appellant has been estopped by his own conduct to challenge the same.

- 7) Para 7 is misleading, hence denied. Moreover, neither decision dated: 17.10.2017 of the appellate committee has been challenged by the appellant nor his departmental appeal is within the stipulated time, rather hit by limitations.
- 8) Para 8 is correct to the extent of filing Writ Petition before the Hon'ble Peshawar High Court, Peshawar and its order dated: 07.06.2018, but it is noteworthy that the said Writ Petition was filed after 04 months of the departmental appeal i.e. delay of 30 days, therefore, rest of the para is against the facts of the case of appellant, hence denied.

9) Para 9 needs no reply.

10) Para 10 is not attracted to the baseless claim of the appellant.

D. REPLY TO GROUNDS:

A. Ground A is misleading, hence denied. Moreover, the answering respondents were recommended by the KP PSC w.e.f. 27.06.2009 while the appellant was regularized in service w.e.f. 24.10.2009, hence shall be ranked junior than them.

B. Ground B is misleading, hence denied. Moreover, appellant is junior and shall be ranked junior than the answering respondents.

C. Ground C is misleading, hence denied. Moreover, appellant is deliberately suppressing the factum of KP PSC recommendations with regard to the answering respondents' w.e.f. 27.06.2009 and tried his best to mislead this Hon'ble Tribunal, which disentitle him for the relief prayed for.

D. Ground D is misleading, hence denied. Moreover, the revised seniority list was issued on the strength of the decision dated: 17.10.2017 of the appellate committee and is in accordance with law/rules governing the subject.

E. Ground E is misleading, hence denied. Furthermore, the public functionaries/official respondents have acted in accordance with law of the land in letter and spirit and no illegality whatsoever has been committed by them in issuance of the revised/final seniority list.

It is therefore most humbly prayed that on acceptance of instant reply, the titled Appeal may be dismissed with costs throughout, so as to discourage such like frivolous litigations and to secure the ends of justice.
