



APPEAL UNDER SECTION 4 OF THE SERVICE TRIBUNAL ACT, 1974 AGAINST THE SENIORITY LIST ISSUED BY THE RESPONDENTS IN WHICH THE PETITIONER HAS NOT BEEN CONSIDERED AND HIS DEPARTMENTAL REPRESENTATION HAS BEEN NOT CONSIDERED, WHICH IS AGAINST THE LAW AND RULES.

PRAYER IN APPEAL

ON ACCEPTANCE OF THIS PETITION/APPEAL, THE RESPONDENTS MAY KINDLY BE ORDAINED TO ENLIST THE NAME OF PETITIONER/APPELLANT IN THE UPCOMING SENIORITY LIST AS PER LAW AND RULES.

Respectfully Sheweth,

FACTS

1. That the Petitioner was appointed as Work Supervisor (BPS-11) vide office order No. 47/Z-E dated 20-05-2019 in the respondents department (C&W) Division, who is deputed in Charsadda with additional charge of Sub-Engineer. **(Copy of appointment order is attached as annexure "A")**

2. That the respondents had issued a first seniority list dated 04/06/2020 for the promotion of the employees in which the petitioner name was at serial no. 14. **(Copy of list is attached as Annexure "B")**
3. That thereafter the respondents once again had issued a seniority list dated 03-01-2022 in which the petitioner name was at serial no 7. **(Copy of list is attached as annexure "C")**
4. That the respondents has issued a tentative seniority list no. 52-E/1282/CE/C&WD dated 03-03-2022 in which the name of the petitioner was not considered which is against the law & rules. **(Copy of list attached as annexure "D")**
5. That the petitioner/appellant was aggrieved from the seniority list issued by the concern department filed an departmental presentation before the respondent no. 1 vide diary no.724 dated 31/08/2022. **(Copy of departmental appeal is attached as annexure "E")**
6. That the respondents fail to decide the departmental presentation/objection against the tentative list within the statutory time frame, being aggrieved of the said act of the respondent prefers this appeal on the following grounds amongst others:-

GROUND

- A. That from his appointment there was no complaint regarding embezzlement, theft or any other charge against the petitioner, further that the petitioner will do the job in sincere manner with the respondents/department.
- B. That the seniority list dated 03-03-2022 issued by the respondent no.1 is against the law and facts and rules.
- C. That neither any opportunity was given to the petitioner/appellant to represent himself before the Authority nor the petitioner/appellant was heard. It is well settled law that no one should be condemned unheard.
- D. That the action and inaction of the respondents regarding the unlisting the name of the petitioner/appellant from the seniority list dated 03-03-2022 is illegal, unlawful, against the law, facts and norms of natural justice.

E. That the petitioner/appellant has not been treated by the respondent department in accordance with law and rules on the subject noted above and as such the respondents violated Article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.

F. That the action of the respondents are without any legal authority, discriminatory and is clear violation of fundamental rights duly conferred by the Constitution and is liable to be declared as null and void.


G. That any other ground will be agitated at the time of arguments with the permission of this Hon'ble Court at the time of arguments.

On the recommendation of the Departmental Selection Committee as per its meeting held on 17-05-2019, Mr. Izaz Saddiq S/O Saddiq Ullah Resident of Post office Prang Akhon Khel District Charsadda is hereby appointed as "Work Supervisor (BPS-11)" (Rs. 12570-880-38970) admissible under the rule, in the Office of the Executive Engineer C&W Division Charsadda against the vacant Post on the following terms and condition:-

1. He will get pay at the minimum of (BPS-11) (Rs. 12570/-) including usual allowances as admissible under the rules. He shall also be entitled to annual increment as per existing policy.
2. He shall be governed by the Khyber Pakhtunkhwa Civil Servants Act-1973 and all the laws applicable to the Civil Servants and Rules made there under.
3. He shall for all intents and purposes be a Civil servant except for purpose of pension or gratuity in lieu of pension and gratuity he shall be entitled to receive such amount contribution by him towards General Provident Fund (G.P.F) along with the contributions made by the Government to his accounts in the said fund in the prescribed manner and rate fixed by the Government from time to time.
4. His services are liable to be terminated without assigning any reason. In case, he wishes to resign from service, 30 days advance notice will be necessary or in lieu thereof, 30 days' pay shall be forfeited.
5. He shall initially be on probation for a period of two years extendable up to 3 years.
6. He shall produce a medical certificate of fitness from the Medical Superintendent, DHQ Hospital Charsadda before reporting himself for duty as required under the rules.
7. He shall be allowed conveyance Medical House rent allowance leave and TA / DA as per Govt. Rules.
8. He has to join duty at his own expenses.
9. If he accepts the post on the above conditions he should report to the office of the Executive Engineer C&W Division Charsadda within 14-days of the receipt of this offer and produce original certificate in connection with his qualification domicile and health / age etc.


