

## CONSOLIDATED JUDGEMENT.

MIAN MUHAMMAD, MEMBER(E):- Our this judgement, will dispose of the instant service appeal as well as connected service appeal bearing No. 7748/2021 titled "Yasir Mehmood versus Government of Khyber Pakhtunkhwa through its Chief Minister and four others", as both the appellants had



been jointly proceeded against under Rule 10 (1) (a) of the Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011 and the same major penalty of "reduction to lower stage in a time scale for a maximum period of 05 years" was imposed upon them on 24.06.2021.

02. Both the service appeals have been instituted with the prayers that "on acceptance of the instant service appeal, the impugned Notification No. SOE/C&W D/8-5/2020 dated 24.06.2021 whereby the major penalty of "Reduction to Lower stage in a time scale of maximum period of 5 years" was imposed on the appellant may be declared as illegal, unlawful without lawful authority without jurisdiction, malafide, void-ab-initio and of no legal effect, hence be set aside and the appellant be exonerated of all the charges leveled against him."

03. Brief facts, as per memorandum of appeal, are that the appellant has been working in the respondent department since 06.12.1990. He was proceeded against under the Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011 for allegation of making full payment to the contractor on the basis of fake measurement in MB. On conclusion of the inquiry proceedings conducted by the inquiry committee, the competent authority finally imposed the major penalty of "reduction to a lower stage in time scale for maximum period of 05 years" upon the appellant on 24.06.2021. The

appellant challenged it through department appeal which was rejected on 11.10.2021 and thereafter the instant service appeal was instituted on 10.11.2021.

04. On admission of the service appeal in preliminary hearing on 03.01.2022, the respondents were put on notice to submit written defense through reply/para-wise comments. Reply/Parawise comments were submitted on 28.07.2022. We have heard arguments of learned counsel for the appellant as well as learned Deputy District Attorney for the respondents in Divisional Bench and gone through the record thoroughly with their assistance today.

0**'Ŝ**. Learned counsel for the appellant contended that the appellant was proceeded against on allegation to have made full payment to the contractor on the basis of fake measurement in Mb in the work regarding upgradation of GGMS to GGHS Hameed Abad Peshawar. In order to recapitulate history of the case. learned counsel for the appellant asserted that administrative approval of the scheme was accorded on 06.07.2015 whereas Technical sanction of the scheme was granted after 03 years owing to the dispute on site selection. The scheme was completed by the target time June 2019 and was inspected in July, 2019. However, certain rectifications were required which were duly communicated to the contractor on 22.08.2019 and 30.10.2019 by the appellant but due to outbreak

of Covid-19 and non availability of workers/labours, shortage of supply of the construction material as a result of lock down in the country, work on rectification and removal of deficiencies got delayed on part of the contractor. It was further argued that the inquiry committee that categorically concluded the deficiencies/incomplete work pointed out in the report of C&W department have been rectified and the delay was observed on the part of contractor. Moreover, the complainant (Deputy Speaker Provincial Assembly) on whose pointation, the enquiry proceedings were initiated, has submitted a certificate to the effect that deficiencies have been removed by the officer/officials. In the Show Cause Notice, the competent authority decided tentatively, to impose minor penalty of "withholding of two annual increments for two years" but in the impugned order dated 24.06.2021 it was converted into major penalty of "reduction to a lower stage in time scale for a maximum period of 05 years" which is not only illegal, unlawful, without authority, without justification, malafide, void ab-initio and of no legal effect but also in violation of Article 4, 8, 9, 25 and 27 of the Constitution, may graciously be set aside.

06. Learned Deputy District Attorney, on the other hand argued that the appellant was issued a proper charge sheet/statement of allegations. The enquiry committee submitted its report with findings to the effect that the deficiencies pointed

out in the inspection report, have been rectified while after examining the report, the enquiry committee stated that the charge with regard to full payment to the contractor on fake measurement has been proved. Similarly, the tentative penalty of withholding of two annual increments for two years was intimated to the appellant through Show Cause Notice. The Secretary Housing department who gave the appellant an opportunity of personal hearing on behalf of the competent authority came to the conclusion that there is no doubt left that advancement payment to the contractor was made without any justification. The authorized officer, therefore, recommended to the competent authority for imposition of the major penalty of reduction to a lower stage in a time scale for a minimum period of five years. Since all codal formalities have been fulfilled before imposition of the impugned penalty upon the appellant, the appeal may therefore, be dismissed with costs, he concluded.

 $0\vec{x}$ . Perusal of the record substantiates that the appellant was proceeded against departmentally and an enquiry committee comprising two member constituted on 06.10.2020 for the purpose to enquire into the allegation leveled against the appellant as contained in the charge sheet. The enquiry committee submitted its report with findings "after thorough investigation and going through the record provided by the department, report of M & E, inspection report of enquiry officer

as well as the replies of the accused officers, the deficiencies pointed out in the report of C&W have been rectified. However, delay has been observed on part of the contractor". It is quite obvious from the report of enquiry committee and particularly its findings that nothing has been mentioned as to whether charge against the appellant was proved or otherwise. Based on the enquiry report submitted by the enquiry committee, the competent authority issued the appellant a Show Cause Notice on 15.02.2021 indicating the tentative decision to impose minor penalty of "withholding of two annual increments for two years" which was enhanced to major penalty of "reduction to a lower stage in a time scale for a maximum period of 05 years" through the impugned order dated 24.06.2021. Had the competent authority not been satisfied with the findings of the enquiry committee, it should have either remanded back the case to the enquiry committee with specific directions in writing or might have ordered a de-novo enquiry, as per provision of sub rule 6 of Rule 14 of the Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011. No substantial and credible documentary evidence was produced in support of the conversion of minor penalty tentatively communicated to appellant in the Show Cause Notice into the imposition of major penalty imposed upon the appellant vide impugned order dated 24.06.2021.

08. As a sequel to the preceding Paras, we are of the considered view that the impugned orders are badly suffering from legal infirmity and are not sustainable in the eyes of law. The impugned order dated 24.06.2021 as well as appellate order dated 11.10.2021 are therefore, set aside and the instant appeal as well as connected service appeal No. 7748/2021, are allowed as prayed for. Parties are left to bear their own costs. File be consigned to the record room.

That the appellant is a respectable citizen of Islamic Republic of Pakistan and is appointed as Sub Engineer vide order dated 6-12-1990 and now serving as Design Engineer (OPS) O/O chief engineer foreign aid Peshawar in Communication and work Department KhyberPakhtunkhwa.

2. That back in the year (2014-2015) in a "umbrella scheme" upgradation of 50 middle schools to higher level in province of Khyber Pakhtunkhwa (Boys and Girls on need bases) in various

Districts were planned by Elementary and Secondary Education(E&S) Department on the basis of ADP NO 172/130341.As per the procedure, field informationbuilding division-l Peshawar prepared detailed cost estimates (DCE's) and sent to the Elementary and Secondary Education (E&SE for Peshawar prepared detailed cost estimates (DCE's) and sent to the Elementary and Secondary Education.
3. Education Department for further approval. Which was approved by the Secretary E&SE for Releasion Department for further approval. - 3. That after the administrative approval by Secretary E&SE Department Peshawar, XEN Building Devision-1 Peshawar called the bidding process and resultantly the work order was issued to MS SaeedUllah Construction Co, for 15.62(Million) on 14-05-2015 after adopting due course of law and fulfilling of all codal formalities. (Copy of work order is attached as Annexure B).
- 4. That it is important to note here that after the issuance of work order to the contractor when appellant along with his sub engineer visited the site spots, Government Girls Middle School, ShahiBala for execution of work the site spot was found disputed. Resultantly the scheme was shifted to Government Girls Middle School Darmangi and then to Government Girls Middle School GrangaBala and finally shifted to Government Girls middle School Hameed Abad, in short the scheme was shifted thrice for execution of work by the department and finally Government Girls Middle School Hameed Abad was approved in DDPW meeting dated 10-01-2018.

(Copy of minutes of meeting & change of site is Annexure C & D)

5. That MS SaeedUllah construction being lowest bidder was awarded the contract and due to the Lapse of 3 years from (14-05-2015 till 10-01-2018) the contractor was reluctant to carry work on changed site Government Girls Middle School Hameed Abad due to escalated prices of material and laborand by the continuous efforts of the appellant, contractor was convinced to carry his work and eventually the contractor commenced his work in Government Girls middle School Hameed Abad on 04-05-2018 and for this purpose 6 bi-annual progress reports (06/2015,12/2015,06/2016,12/2016,16/2016,12/2017)were issued which clearly reveals non handling of sites for commencement of his work till December 2017.

(Bi annual reports from 6/2015 till 12/2017 are attached as Annexure E).

- 6. That the Elementary and Secondary Education Department Peshawar was keen to close and complete the umbrella ADP Scheme by June 2019 and Communication and work Department tried utmost to accomplish the job well within time and the contractor was also in effort to complete the work on change site. All the major required work was completed by contractor and respective 7<sup>th</sup> running bill was prepared to complete the work because the payment was essential and there was no reason to carry forward scheme for financial year(2019-2020).
- 7. The appellant along with sub engineer inspected scheme in July 2019 and scheme was found completed. However certain rectifications in item i-e Internal Water Supply, Sanitary Installation , internal electrification, roof treatment work, plastering and courtyard paving were pointed out to contractor on site, and contractor was directed to complete all rectifications/deficient works vide letter no 780/1-C Dated 22-08-2019 and was reminded again on 30-10-2019.

(Copy ofletter and reminder are attached as annexure F and F/1).

8. That thereafter during course of time the contractor experienced some domestic issues and replied to the letter and reminder of Appellant by asking for some time to rectify the

deficiencies and to enable the scheme to be handed over to Elementary and Secondary Education Department. The work on rectification as communicated to contractor by theappellant herein was resumed but later on due to outbreak of Covid-19 and non-availability of workers as well as stoppage of supply of construction material and due to overall lockdown in country the work was stopped. The private contractor resumed his work and all the deficiencies pointed out to the contractor were removed and the work was duly completed in year 2020.

(Copy of PC-IV along with completion certificate and replies of contractor are attached as annexure G,G/1, G/2, and G/3).

9. That in the meanwhilean inspection committee was constituted for inspecting ADP,s scheme upgrading of 50 middle schools to higher levels on need basis upon the complaint of the deputy speaker provincial assembly Khyber Pakhtunkhwa as the subject school is situated in his constituency and thereby the officials concerned visited the subject spot and pointed out deficiencies on 31-08-2020, wherein the conclusion of reporting Engineer M.Asghar Khan Monitoring Officer-I after pointing out some rectifications, alleged shocking allegations against the appellant along with sub engineer as well as upon the contractor and upon the recommendation of monitoring officer an inquiry was initiated against the appellant, XEN building Division-I Peshawar and sub Engineer BuildingDivision-I and by suspending the above 3 officials they were directed to appear in person before the inquiry committee whereby a written reply was submitted by appellant before the inquiry committee and from the report of findings of inquiry committee it is crystal clear that deficiencies pointed out by communication and works department Peshawar were rectified but only delay have been observed on part of contractor for completion of his work.

10. That in the meanwhile a show cause notice was also issued by worthy Chief Minister to the Appellant on 15 February 2021, whereby a minor penalty of "holding of 2 annual increments for 2 years" was imposed on appellant and on 1<sup>st</sup> March ,2021 all the three officials were re-instated into their service by secretary Khyber Pakhtunkhwa Communication and work Department Peshawar and on the same day the appellant herein replied to the show cause notice of the worthy Chief Minister whereby all the facts were replied in detail before the worthy Chief Minister. Later on 6<sup>th</sup> march 2021 the letter was issued to appellant to appear before the secretary housing department, Peshawar in his office for personal hearing on 19-05-2021.

11. That afterwards an order was issued in the name of appellant by Secretary Communication and work department dated 24-06-2021, whereby the major penalty of "reduction of a lower stage in a time scale period of 5years" was imposed on the appellant and on the very same day the then XEN Division 1, Peshawar presently XEN Highway DivisionKohat was exonerated by imposing a minor penalty of "censure". (Copy of impugned notification along with order dated 24-06-2021 is attached as Annexure J to J/1)

12. That feeling aggrieved from the order no SOE/C&W D/8-5/2020 Dated 24 June 2021 by the secretary Government of Khyber Pakhtunkhwa Communication and work Department. The Appellant filed the review/appeal dated 01-07-2021 before the competent Authority (Worthy Chief Minister and later on representation/appeal of appellant was rejected by the Worthy Chief Minister Khyber Pakhtunkhwa on 11-10-2021.

(Copy of order dated 11-10-2021 is attached as annexure as K,K/1).

13. That feeling aggrieved from the above the appellant approaches this Honorable Service Tribunal on following grounds inter-alia.

### <u>GROUNDS</u>:

- A. That the impugned notification No. SOE/C&W D/8-5/2020 Dated 24-06-2021, whereby major penalty of "REDUCTION OF LOWER STAGE IN A TIME SCALE OF MAXIMUM PERIOD OF 5 YEARS" by respondent no.1 was imposed on the appellant is illegal, unlawful, without lawful authority, without jurisdiction, malafide, offends judgment of the superior court, void-ab-initio and of no legal effect, therefore, the same is liable to be set aside.
- B. That Mr. Engineer Naveed Khan (BS-18) the then XEN, Building Division No.1 Peshawar, now working as XEN C&W Division Kohatwas relieved of all the charges by imposing a minor penalty of "Censure" is discriminatory towards the appellant and in violation of rules and law, hence the impugned notification is not sustainable in the eye of law.
- C. That the impugned notification offends Article-4, 8, 9, 25 and 27 of the Constitution of Islamic Republic of Pakistan, 1973.
- D. That the impugned notification is in conflict with the principles of natural justice and also infringed the legal and accrued right of the appellant, therefore, warrants interference.
  - That deficiencies as pointed out to the contractor were rectified by contractor and the scheme stands completed, the scheme has also been handed over to the E & SE department and no loss to the government exchequer is sustained. In addition the complainant has also conveyed to the respondents that the complaint lodged in this regard after the removal of deficiencies is considered to be resolved, moreover the inquiry committee in its report has concluded that "the

deficiencies pointed out in report of C&W department have been rectified". Hence warrants interference.

F.

That the appellant seeks leave of this Honorable Tribunal to raise/ argue any additional point at the time of arguments.

It is, therefore, most humbly prayed that on acceptance of this Service Appeal, the impugned notification No. SOE/C&W D/8-5/2020 Dated 24-06-2021, whereby major penalty of "REDUCTION OF LOWER STAGE IN A TIME SCALE OF MAXIMUM PERIOD OF 5 YEARS" was imposed on the appellant may be declared as illegal, unlawful, without lawful authority, without jurisdiction, malafide, void-ab-initio and of no legal effect, hence be set aside, and the appellant be exonerated of all the charges leveled against him.





#### ANALYSIS/ OBSERVATIONS:

After scrutiny of the office record of Executive Engineer Building Division No.1 it has been noted that the subject Scheme has been completed financially in all respect in F.Y year June 2019 and dropped from ADP, but physically the scheme is incomplete although full payment has been made to the contractor, even after laps of 14 months.

During the inspection following short comings /defects observed in the said school building, at the time of inspection no constructional activity observed at site.

- 1. On the entrance to the School premises, found lot of dumps of debris in court yard.
- 2. That in class rooms /labs the steel Almiraha were not provided.
- 3. That in class rooms/laboratories black boards were not finished.
- 4. That 5 mm thick glass panes were not fixed in all steel windows.
- 5. That on steel windows cheap/substandard design of grill and wire gauze was fixed.
- 6. That in laboratories sinks were not provided along with water supply connection.
- 7. That grinding/polishing of marble tiles in class rooms and verandahs were not done.

- 8. That the steel railing was fixed around the stairs but completely rusted//
- 9. That roof treatment .i.e. lying of brick tiles as per specification has not been done.
- 10. That eclectic wiring completed without all related accessories like fixing of ceiling fans, main boards, buttons, switches, and holders etc.
- 11. That group lavatory block was incomplete in all respect along with sanitary fixtures.
- 12. That lavatory block Septic tank and soakage pet were not constructed.
- 13. That the Leveling and dressing still remaining in the court yard of the School.
- 14. That Tuff tiles/brick on edge still remaining in court yard of the School.
- 15. That plinth protection /steps not provided around the School building.
- 16. That partially primary coat of Color wash/white wash and painting was done. But the remaining coats are yet to be done.

#### CONCLUSION:

- The above deficiency / incomplete work is the negligence, irregularity, recording fack measurement in the MB and releasing advance payment to the Contractor and not completing the balance work even after laps of one year and four months on part of C&W staff i.e. Sub Divisional Officer and Sub Engineer.
- 2. The contractor is recommended for black listing as per leaving the work incomplete despite full payment has been released by the Department.

#### RECOMMENDATIONS

- 1. Sub Divisional Officer and Sub Engineer be charge sheeted and suspended for above irregularity and detail inquiry be conducted against them.
- 2. Contractor be black listed and all the balanced amount be recovered from his security deposit and work be completed on his risk and cost.

- 1. An Umbrella Scheme "Up-Gradation Of 50-Middle Schools To High Level in the Khyber Pakhtunkhwa (boys & Girls) 30:70 ON NEED BASIS in various Districts were planned by the Elementary & Secondary Education (E&SE) Department under ADP No.172/130341 for the year, 2014-15. As per procedure, the field formation of C&W Building Division-1 Peshawar prepared Detail cost estimates (DCE's) and sent to E&SE Department Peshawar for approval.
- 2. The Secretary E&SE Department Peshawar accorded Administrative Approval of the scheme for Rs.16.00 (M) vide CPO/SPO-I/E&SE/1- 1/A.A/2013-14/Peshawar dated 06/07/2015 (copy of AA attached as Annex-1).
- 3. After the receipt of Administrative Approval, XEN Building Division-I Peshawar called bidding and consequently, work order was issued to M/S Saced Ullah Construction Co, for Rs 15.462 M. on 14-05-2015 (copy attached as Annex-II) after fulfillment of codal formalities.
- 4. I the undersigned with Sub engineer, approached E&SE department Peshawar for possession and visited GGMS Shahi bala but the site was found disputed and could not be managed for execution of the scheme and subsequently the scheme was shifted thrice. a) Originally the scheme was identified at GGMS Shahi Bala: b) shifted to GGMS Darmangi, c) then shifted to GGMS Garanga Bala: d) and . finally shifted to GGMS Hameed Abad and finally school shifting to GGMS Hamid Abad was approved in DDWP meeting held on 10-01-2018 (copy of minutes of the

meeting attached Annex-III).

- 5. Technical Sanction of the scheme for Rs.13.839 (M) was accorded by competent Authority on dated 25/11/2019 (copy of T.S attached as Annexure-IV) .
- 6. All the required work was completed by the contractor and the respective last 7th running bill was prepared and submitted to XEN Building bivision - I and accordingly cheque was issued to contractor in june 2018 cheme was Due for completion in financial year 2018-19.
- 7. The undersigned with Sub Engineer inspected the scheme in July 2019 and the scheme was found completed. However certain deficiencies being of detachable nature i.e. internal water supply and sanitary installation, internal electrification and courtyard debris clearance and leveling /dressing were pointed out to contractor on site and the contractor was directed to remove all rectification / deficient works.



It is with great honor to state that the undersigned was served with a show cause notice (Annex - A) duly signed by your good self with imposition of teritative minor penalty of "withholding of two annunt increments for two years", reply to which was submitted. The charges leveled in the charge shoet were not found correct by the inquiry committee, however, the undersigned has been received the order bearing No. SOE/C&WD/8-8/2020, dated: 24-06-2021 (Annex - B), whereby, a major penalty of "Reduction of a lower stage in a time scale for a maximum period of 05 years' has been imposed. 2.

The undersigned while posted as SDO in the office of Executive Engineer Building Division No. 1. Peshawar, supervised the subject scheme, the Department initiated Departmental proceedings against the then XEN/SDO/Sub Engineer of Building Drivision No. 1 Peshawar, for which I was served with a charge sheet / statement of allegation (Annex - C). In reply to the charge sheet (Reply Annex - D), it was categorically explained that the umbrella scheme, which included up-gradation of GGMS Shahi Bala was approved, however, due to dispute of site, the scheme could not be started within the stipulated time framework. The site of the scheme was shifted / transferred thrice, finally, the land was provided by the inhabitants of Hamid Abad and the client Department handed over the site in 2018. The client Department was keen interested to close and complete the umbrella ADP scheme by June 2019 3.

Since, the site of the scheme identification was delayed, the contractor was reluctant to start the work due to increase in prices of the material, as the work order was issued to the contractor on 14-05-2015, after identification of the site / shifting from Shahi Bala to Garanga Bala and then this to Darmangi and finally to Hamid Abad, duly approved in DDWP meeting held on 10-01-2018 (Minutes of the meeting Annex - E), it is worth mentioning that due to the best efforts of the undersigned and Sub Engineer, the contractor was compelled to start the work, who started the work on 04-05-2018. 

An Umbrella Scheme "Up-Gradation Of 50-Middle Schools To High Level in the Khyber Pakhtunkhwa (boys & Girls) 30:70 ON NEED BASIS in various Districts were planned by the Elementary & Secondary Education (E&SE) Department under ADP No.172/130341 for the year, 2014-15 . As per procedure, the field formation of C&W Building Division-1 Peshawar prepared Detail cost estimates (DCE's) and sent to E&SE Department Peshawar for approval.
- The Secretary E&SE Department Peshawar accorded Administrative Approval of 2. the scheme for Rs.16.00 (M) vide CPO/SPO-I/E&SE/1- 1/A.A/2013-14/Peshawar dated 06/07/2015 (copy of AA attached as Annex-1).
- 3. After the receipt of Administrative Approval, XEN Building Division-I Peshawar called bidding and consequently, work order was issued to M/S Saeed Ullah Construction Co, for Rs 15.462 M. on 14-05-2015 (copy attached as Annex-II) after fulfillment of codal formalities.
- 4. I the undersigned with Sub engineer, approached E&SE department Peshawar for possession and visited GGMS Shahi bala but the site was found disputed and could not be managed for execution of the scheme and subsequently the scheme was shifted thrice. a) Originally the scheme was identified at GGMS Shahi Bala: b) shifted to GGMS Darmangi, c) then shifted to GGMS Garanga Bala: d) and finally shifted to GGMS Hameed Abad and finally school shifting to GGMS Hamid Abad was approved in DDWP meeting held on 10-01-2018 (copy of minutes of the meeting attached Annex-III).
- 5. Technical Sanction of the scheme for Rs.13.839 (M) was accorded by competent Authority on dated 25/11/2019 (copy of T.S. attached as Annexure-IV).
- 6. All the required work was completed by the contractor and the respective last 7<sup>th</sup> running bill was prepared and submitted to XEN Building Division -I and accordingly cheque was issued to contractor in june 2019. The scheme was Due for completion in . financial year 2018-19.
- 7. The undersigned with Sub Engineer inspected the scheme in July 2019 and the scheme was found completed. However certain deficiencies being of detachable nature i.e internal water supply and sanitary installation, internal electrification and courtyard debris clearance and leveling /dressing were pointed out to contractor on site and the contractor was directed to remove all rectification / deficient works.

- 8. The work on rectification as communicated to contractor was resumed but due to contractor personal domestic problems and outbreak of <u>COVID-19</u> the work was stopped. However after easing of lockdown, the work was restarted and all the deficiencies / rectifications were removed and work has been completed. The scheme has been taken over by E&SE Deptt: (-Signed copy of PC-IV is attached for ready reference as Annex-V-).
- 9. As far as charge regarding fake measurements and payment is concerned, the charge is denied as payment was made as per work done. The deficiencies as pointed out to contractor in Para-VII were rectified by contractor and the scheme stands completed, the scheme has also been taken over by E&SE deptt: and no loss to the Govt Ex-chequer is sustained. Furthermore the complainant has conveyed that <u>"the complaint lodged in this regard is considered to be resolved" (the certificate is attached as Annex-VI)</u>. Moreover the inquiry committee in last Para of findings states that "The deficiencies pointed out in report of C&W Department have been rectified"
- 10. The scheme has been complete in all respect and take over by E&SE Department, the complainant conveyed that issue has been resolved and inquiry committee also intimated that deficiencies in C&W Department Monitoring report have been rectified.
- 11. Hence keeping in view above facts it is humbly requested that charges leveled against me may kindly be withdrawn and tentative minor penalty of withholding of two annual increments for two years may kindly be waived off and the undersigned may be exonerated from charges please.



38. The Chief Minister Khyber Pakhtunkhwa vide orders contained in para 37/ante, authorised the undersigned to afford the opportunity of personal hearing to accused Engr. Naveed!Khan, Executive Engineer (BS-18), Engr. Muhammad Asad, Assistant Engineer (BS-17) and Mr. Yasir Mehmood, Sub, Engineer in terms of Rule 15 of Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline Rules) 2011. All the accused officers/ official were summoned by the undersigned for personal hearing along with the departmental representatives on 19-05-2021 (Annex-I). Report is submitted as under:

## Brief facts of the case

39. During the upgradation work of GGMS to GGHS at Hameed Abad, District Peshawar, it transpired that they made full and final payment to the contractor on the basis of fake measurement in MB, whereas the work done on site was found deficient/ incomplete by the monitoring team of the department even after the lapse of 14 months. This caused the initiation of disciplinary proceedings against them. Mr. Nauman Afzal Afridi (PAS BS-19) and Engr. Muhammad Nawaz, SE PHE (BPS-19) were nominated as inquiry officers by the Competent Authority. The inquiry report dated 18-22-2020 concluded that;

"After thorough investigation and going through the record provided by the department, report of M&E, inspection report of enquiry officer as well as the replies of the accused officers, the deficiencies pointed out in the report of C&W Department have been rectified. However, delay has been observed on part of the contractor."

40. Keeping in view the findings of the inquiry committee, the Competent Authority (Chief Minister Khyber Pakhtunkhwa) served separate show cause notices upon above mentioned officers. Both the officers and one official submitted their written replies to the show cause notices with the request to be heard in person by the Competent Authority under the provisions of Rule 15 of Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline Rules) 2011.

# 41. Engr. Naveed Khan, Executive Engineer (BS-18)

During personal hearing of the accused, he reiterated the stance which he held during the proceedings of the inquiry. As an additional defence, he referred to the initial monitoring report wherein the monitoring officer had fixed the responsibility of advance payment and fake entries in the measurement book upon sub divisional officer and sub engineer concerned (Annex-II) He also referred to section 220 of Central Public Works Department Code (Annex-III) as well as section 2.98 (b) of 'The West Pakistan Buildings & Roads, Department Code (Annex-IV) wherein it is stated that the sole responsibility of ensuring quality/ quantity of work being billed is upon the SDO concerned and in case of any default in this regard, SDO concerned will be personally responsible.

## Recommendations

Keeping in view the fixation of responsibility by the monitoring report upon the sub engineer and SDO concerned as well as the documents produced by the officer, it is evident that he has been sinned against more than sinning. Although preparation of MB and preparation of bill come under the sole responsibility of sub engineer and SDO concerned, he being Divisional head should have ensured that every penny paid is against the work done on ground. Having said that, the penalty of withholding two increments for two years seems to be harsher one. Minor penalty of Censure is recommended against him please.

# 42. Engr. Muhammad Asad, Assistant Engineer (BS-17)

During personal hearing of the accused, he reiterated the stance that the bill has been prepared as per actual work done on site and no advance payment has been made to the contractor on this account. His attention was invited to the written statement he submitted in reply to the show cause notice wherein he has stated that on 7<sup>th</sup> of September, 2020 he along with sub engineer concerned visited the site and told the contractor to address the minor works which were left by him. When he was confronted with the monitoring report which mentioned 16 acts of omission on part of the contractor, he could not justify his stance. His response to the role assigned to him vide section 220 of Central Public Works Department Code (Annex-III) as well as section 2.98 (b) of 'The West Pakistan Buildings & Roads, Department Code (Annex-IV) was that he made the payments as per work done and no advance payments had been made to contractor.

### Recommendations

Keeping in view his consistent refusal in discharging his duties as per role assigned to him, there is no doubt left that advance payment to the contractor was made without any justification. Had the report of the monitoring team not unearthed this grave action on his part, contractor in criminal collusion of the SDO must have bagged the money at the cost of the public exchequer. Had he been cognizant of his responsibilities and taken interest in the job assigned, he could have done his assigned job as per expectations. But it seems that he opted to keep himself aloof from the whole process, prima facie, for ulterior motives and caused the whole process damaged by irregularities, lack of transparency and procedural observances. Keeping in view the above, major penalty of reduction to a lower post or pay scale or to a lower stage in a time scale for a maximum period of five years is recommended please.

# 43. Mr. Yasir Mehmood, Sub Engineer

During personal hearing of the accused, he reiterated the stance that the bill has been prepared as per actual work done on site and no advance payment has been made to the contractor on this account. His attention was invited to the written statement he submitted in reply to the show cause notice wherein he has stated that on 7<sup>th</sup> of September, 2020 he along with SDO concerned visited the site and told the contractor to address the minor works which were left by him. When he was confronted with the monitoring report which mentioned 16 acts of omission on part of the contractor, he reiterated that MB was prepared as per actual work done and no fake entries have been recorded therein.

## Recommendations

Keeping in view his consistent refusal in discharging his duties as per role assigned to it, there is no doubt left that advance payment to the contractor was made without any justification. Had the report of the monitoring team not unearthed this grave action on his part, contractor alongwith the criminal collusion of the sub engineer must have bagged the money at the cost of the public exchequer. Had he been cognizant of his responsibilities and taken interest in the job assigned, he could have done his assigned job as per expectations. But it seems that he opted to collude with the contractor during the whole process, prima facie, for ulterior motives and caused the whole process damaged by irregularities, lack of transparency and procedural observances.
