SERVICE APPEAL UNDER SECTION 04 OF KPK SERVICE TRIBUNAL ACT, 1974 FOR DECLARATION TO THE EFFECT **GOT APPELLANT** THE THAT **VIDE** C.TAS APPOINTMENT DATED **ORDER APPOINTMENT** THE THEREAFTER, 03/03/2016. APPELLANT WAS APPOINTED AS SST BIO CHEMISTRY ON CONTRACT BASIS VIDE ORDER DATED 09/05/2017 AND THE SAME CONTRACT ORDER OF THE APPELLANT WAS CONVERTED INTO REGULAR SERVICE ON 26/03/2018. THE APPELLANT APPLIED FOR STUDY LEAVE FOR PH.D. IN CHINA BUT RESPONDENTS' DEPARTMENT DID NOT GRANT EX-PAKISTAN LEAVE PH.D. FOR PAY WITHOUT PROGRAMME AS A RESULT, THE APPELLANT WENT TO CHINA FOR PH.D. BUT DURING THE SAID PERIOD RESPONDENTS' DEPARTMENT AFTER TAKING AN EX-PARTY DECISION, REMOVED THE APPELLANT FROM SERVICE VIDE IMPUGNED ORDER DATED 05/08/2019. THAT JUST AFTER **PAKISTAN** IN ARRIVAL APPELLANT CAME TO KNOW SHE WAS REMOVED FROM SERVICE ON 05/08/2019. THE APPELLANT FILED A DEPARTMENTAL APPEAL TO THE NEXT HIGHER AUTHORITY WHICH IS YET TO BE DECIDED BY THE RESPONDENT NO.1. THE IMPUGNED REMOVAL FROM THE SERVICE ORDER OF THE APPELLANT IS PERVERSE, DISCRIMINATORY, EX-PARTY, AND THE SAME IS LIABLE TO BE SET ASIDE.

PRAYER;- ON ACCEPTANCE OF THE INSTANT SERVICE APPEAL, IMPUGNED REMOVAL FROM SERVICE

05/08/2019 OF THE APPELLANT MAY SET ASIDE AND GRACIOUSLY BE RESPONDENTS MAY BE DIRECTED TO IN**APPELLANT** THE REINSTATE SERVICE WITH ALL SERVICE BACK BENEFITS. ANY OTHER RELIEF WHICH THIS HONOURABLE TRIBUNAL DEEMS THE **PROPER** IN FIT AND CIRCUMSTANCES OF THE CASE MAY TO THE ALSO BE GRANTED APPELLANT.

Respectfully Sheweth:-

That the facts forming the backgrounds of the instant service appeal are arrayed as under;

1. That the appellant was first appointed in the respondents 'department as C.T Teacher in BPS-15 vide order dated 03/03/2016. Thereafter, she was again appointed as contract basis SST Bio Chemistry on without break on 09/05/2017 and the same contract order of the appellant was converted from contract to regular service vide order dated 26/03/2018. Copy of appointment order dated 03/03/2016 of the appellant as C.T.

on contract basis and as SST Bio Chemistry dated 09/05/2017 and regular of SST Bio Chemistry order dated 26/03/2018 of the appellant are attached as Annexure "A", "B" & "C".

- 2. That during the service the appellant served the department and left no stone unturned in the smooth functioning of the department. As per law, a civil servant after completion of two-year continuous for obtaining is eligible service extraordinary leave for studying higher education hence, the appellant applied for study leave for Ph.D. without pay but the respondents' department did not allow the study leave to the appellant. Copy of application of the appellant for study leave without pay is attached as Annexure "D".
  - 3. That as the appellant had obtained admission in the University of China in Physical Chemistry at the Institute of Chemical Physics China and the appellant was to join the institute for studying Ph.D. courses on 30/08/2018.
  - That the appellant filed an application for a grant of study leave without pay on 8-8-2018 & 18-8-2018 respondent No. 4

verbally directed to the appellant that her application for study leave without pay w.e.f 30-8-2018 to 28-8-2021 shall be got granted from the competent authority. Therefore, the appellant moved to china to get admission in Ph.D. is Physical Chemistry.

- 5. That respondent No.4 retained appellant's application with her and submitted in DEO(F) office on 31-8-2018 alongwith the appellant's absence report vide diary No. 3054 dated 31-08-2018 (Annexure) two days after the appellant's departure from Pakistan.
- No.4 retained all 6. Respondent corresponding letters with her and hid the facts until 8-4-2019 when all the letters were received corresponding through the RTI Act and hidden facts (misguidance disclosed concealment of facts on the part of respondents 3 & 4).
- 7. That the appellant was repatriated from China to Pakistan on 9-01-2020, thereafter, the appellant started shuttling in respondents' office for her adjustment against the post of SST Bio Chemistry but of no avail. The appellant received

impugned removal from service order dated 05/08/2019. Copy of the impugned removal from service order dated 05/08/2019 is attached as Annexure "E".

8. That feeling aggrieved, the appellant filed departmental appeal to the next higher authority on 23/07/2022. But the concerned authority did not bother to reply to the appellant so far. Copy of departmental appeal dated 23/07/2022 is attached as Annexure "F". Hence, the instant service appeal is filed inter-alia on the following grounds;-

#### **GROUNDS**;-

- a. That as per law, after completion of two years service, every employee becomes entitled for extra ordinary leave upto five years but in the case of appellant, respondent No. 4 only verbally assured that she would be granted leave applied for by her. But even then the extra ordinary leave for studying higher education was not granted by the competent authority which is illegal, and against law on the subject.
- b. That the appellant during her study did not receive a salary from Govt. the

exchequer. In other words, the appellant did cause a loss for the Govt. besides, the education/qualification obtained by the appellant would be utilized for the betterment of the students as well as for the dear home land.

- c. That the impugned service order dated 05/08/2019 is arbitrary against the law because no proper inquiry as per law has been conducted in the matter. The removal from the service order is liable to be set aside because the same order is an ex parte order and the appellant has not been provided with an opportunity for a personal hearing as well as defending her case. Hence, the impugned order dated 05/08/2019 is a result a audi-atram-paltram and is absolutely not maintainable at law.
- d. That this fact may not be left to fade in oblivion that the respondents have led the appellant to a place which is utterly principle of unknown to the jurisprudence, natural justice and fair neither respondents Besides, play. accepted nor rejected the application dated 18/08/2018 of the appellant which was forwarded by respondent No.4 to respondent No.3 vide letter dated

20/08/2018 but practically the same was submitted on 31/08/2018. Copy of letter dated 20/08/2018 is annexed as Annexure "G".

- e. That the matter relates to the term and condition of service tenure for this Honourable Tribunal has jurisdiction to entertain the instant service appeal under Article 212 of the Constitution of the Islamic Republic of Pakistan 1973.
- f. That the valuable rights of the appellant are involved.
- g. That there is no efficacious and adequate remedy available to the appellant except the invocation of the jurisdiction of this Honourable Tribunal.
- h. That other points shall be urged at the time of arguments.

It is, therefore, humbly prayed that on acceptance of the instant service appeal, impugned removal from service 05/08/2019 of the appellant may graciously be set aside and respondents may be directed to reinstate

the appellant in service with all service back benefits, any other relief which this Honourable Tribunal deems fit and proper in the circumstances of the case may also be granted to the appellant.





- Their regularization shall not affect the promotion quota of the existing holders of posts in 7. respective service cadre. They shall rank junior to all civil servants belonging to the same service or cadre, as the case may be, who are in service on regular basis on the commencement of the Khyber Pakhtunkhwa Employees of the Elementary and Secondary Education (Appointment and Regularization of Services) Act, 2018 (Khyber Pakhtunkhwa Act No.1 of 2018), and shall also rank junior to such other persons, if any, who, in pursuance of the recommendation of the Khyber Pakhtunkhwa Public Service Commission made before the commencement of this Act, are to be appointed to the respective service or cadre, irrespective of their actual date of appointment.
- S. The seniority shall be determined on the basis of their continous services in cadre, provided that if the date of continous service in case of two or more employees is the same, the employee elder in age shall rank scalor to the younger one.
