In pursuance of order sheet dated 26,07,2021, learned counsel for the appellant submitted additional documents including charge sheet/statement of allegations and inquiry report, which are placed on file/record.

Preliminary arguments heard.

Learned counsel for the appellant argued that the appellant is aggrieved of impugned order dated 02.11.2020 whereby major penalty of "compulsory retirement from service" was awarded to him. He preferred departmental appeal in November 2020 (no specific date is mentioned on the departmental appeal). The departmental appeal was however regretted on 24.12.2020, and communicated to the appellant on 12.01.2021. It was further contended that the appellant has 24 years of service to his credit and he was proceeded against on flimsy ground/complaint of financial corruption. He actually obtained loan amounting to Rs. 200000/- from Mr. Hassan Gul for the treatment of her ailing mother suffering from cancer. The ends of justice have not been fulfilled and the appellant has not been given the opportunity of cross examination during inquiry proceedings and as such he has been condemned unheard.

Points raised need consideration. The appeal is admitted to regular hearing subject to all legal objections. The appellant is directed to deposit security and process fee within 10 days. Thereafter, notices be issued to the respondents for submission of written reply/comments in office within 10 days after receipt of notices, positively. If Process Fathe written reply/comments are not submitted within the stipulated time, the office shall submit the file with a report of non-compliance. File to come up for arguments on 12.01.2022 before the D.B.
