A post of Director Library and Research has fallen vacant due to the retirement of its incumbent (Tilawat Khan). The respondents were, therefore, required to have followed see

the Service Rules of the Provincial Assembly Secretariat dated 25.09.2007 which prescribe the mode of filing that post under serial-9 of the rules ibid (by promotion on the basis of seniority from Librarians with 7 years as such or 12 years service as Librarian in BS-17 and above). However, to the utter violation of the service rules, the appellant was ignored for promotion and private respondent No. 7 was promoted against the post of Director Library and Research (BS-19) despite the fact that she belongs to Research cadre. Feeling aggrieved of the impugned Notification dated 07.05.2021, the appellant preferred departmental appeal dated 28.05.2021 to Speaker Provincial Assembly, the Governor Khyber Pakhtunkhwa and the Chief Secretary Khyber Pakhtunkhwa simultaneously, However, no response has been received on his departmental appeal from any of the quarter approached for relief and remedy on departmental level, hence the instant service appeal was filed under section 4 of the Khyber Pakhtunkhwa Service Appell Deposited Tribunal Act, 1974 on 21.09.2021


