
It is contended that the appellant was appointed as Medical Officer BS-17 on 18.07.2016 on adhoc basis. His service was regularized through order dated 08.05.2017 in pursuance of Khyber Pakhtunkhwa (Regularization of Service) Act 2017. Since his appointment on adhoc basis the appellant is performing duty with the respondent department but since 01.04.2018 his monthly salary has been stopped without any rhyme or reasons. A departmental appeal was submitted to the respondent No.2 on 07.05.2018 which remained un-responded, therefore, the appellant preferred Writ Petition No. 4478-P of 2018 before the Hon'ble Peshawar High Court. It was disposed of on 09.06.2020 with directions to concerned respondent to decide departmental appeal within One (01) month positively. Despite unambiguous order of the High Court the needful was not done, hence the instant appeal.

Explaining the delay in filing service appeal after more than two (02) years. It was contended that with the passage of every month a fresh cause of action accrued in favor of the appellant, therefore, the delay ibid was to be disregard. Relies 2002 PLC (CS) 1388.

Instant appeal is admitted to regular hearing subject to all just exceptions in view of the available record and arguments of learned counsel. Appellant is required to deposit security and process fee within 10 days. Thereafter, notices be issued to the respondents for submission of written reply/comments on 19.04.2021 before S.B.
