

AGAINST OFFICE NOTIFICATION NO. SO (PE) 2-6 /
DPC DATED 05-04-2022 OF R. NO. 01 WHEREBY
APPELLANT WAS PROMOTED TO THE POST OF
INSTRUCTOR PHYSICAL EDUCATION B-17 FROM THE
POST OF SENIOR PHYSICAL EDUCATION TEACHERS
MALE B-16 WITH IMMEDIATE EFFECT INSTEAD OF 02-
01-2018 WITH COLLEAGUES:**

Respectfully Sheweth:

1. That appellant was initially appointed as Physical Education Teacher (PET) on 20-10- 1993 and is serving the department to the best of the ability and to the entire satisfaction of the superiors wherever he was posted.

2. That appellant was promoted to the post of Physical Education Teacher B-14 after getting Junior Diploma Physical Education (JDP), in the year 2007, he was upgraded to B-15 as such. He was further promoted to the post of Senior Physical Education Teacher (SPET) B-16 on 21-02-2013.
3. That on 14-07-2017, Tentative Seniority List of Senior Physical Education Teachers (M) B-16 of the department was issued wherein appellant was placed at S. No. 392, while his colleagues were placed at S. No. 356, 358, 364 etc. (Copy as annex "A")
4. That colleagues of appellant were promoted to the post of Instructor Physical Education B-17 on 02-01-2018, while appellant being similarly and equally placed was ignored for no legal reason. (Copy as annex "B")
5. That on 05-04-2022, appellant was promoted to the post of Instructor Physical Education B-17 (M) on regular basis with immediate effect instead of 02-01-2018 with his colleagues and was adjusted on 27-05-2022. (Copy as annex "C")
6. That on 06-07-2022, appellant submitted representation before the authority for promotion to the post of Instructor Physical Education B-17 (M) with effect from 02-01-2018 with his colleagues but without any response. (Copy as annex "D")


Hence this appeal, inter alia, on the following grounds:-

GROUND S:

- a. That appellant and his colleagues namely Ala Nawaz, Ghulam Sarwar, Hamid Ali Khan, Javed Khan, Ismail, Jehanzada and Murad Shah were promoted to post of Senior Physical Education Teacher B-16 on one and the same date i.e. 21-02-2013.
- b. That colleagues of appellant were promoted to the post of DPE now Instructor Physical Education B-17 (M) on 02-01-2018 while appellant was promoted to the said post on 05-04-2022 with immediate effect instead of 02-01-2018 of the colleagues.


- c. That at the time of promotion of colleagues i.e. 2018, appellant was well qualified and fit for promotion to the post of IPE B-17 but no reason, whatsoever, was assigned to him by not promoting to the said date.
- d. That by promoting appellant to the post of IPE on 05-04-2022, appellant not only lost his seniority but other future service benefits was also affected.
- e. That the impugned order dated 05-04-2022 is not per the mandate of law so is of no legal effect.

It is, therefore, most humbly prayed that on acceptance of the appeal, Notification dated 05-04-2022 be modified to the extent of appellant from immediate effect to 02-01-2018 with all consequential benefits








