APPEAL UNDER ARTICLE 212 OF THE CONSTITUTION OF ISLAMIC REPUBLIC OF PAKISTAN 1973 READ WITH SECTION 4 OF KHYBER PAKHTUNKHAWA SERVICE TRIBUNAL 1974, AGAINST THE SECTION 4 OF THE KHYBER PAKHTUNKHAWA EMPLOYEES OF THE ELEMENTARY AND SECONDARY EDUCATION DEPARTMENT (APPOINTMENT AND REGULARIZATION OF SERVICES) ACT 2017 BE DECLARED ULTRA VIRES OF CONSTITUTION WHICH IS AT VARIANCE WITH THE SECTION 3 OF THE SAID ACT AND IS VIOLATIVE OF ARTICLES 4, 25 AND 27 OF THE CONSTITUTION OF ISLAMIC REPUBLIC OF PAKISTAN 1973.

PRAYER:- ON ACCEPTANCE OF INSTANCE APPEAL IT IS HUMBLY PRAYED THAT RESPONDENTS BE DIRECTED TO AMEND THE SECTION 4 OF THE ACT 2017 AND IMPUGNED

SECTION BE DECLARED AS VIOLATIVE OF THE FUNDAMENTAL RIGHTS GUARANTEED BY THE CONSTITUTION AND ALSO NULL AND VOID THE SAME MAY PLEASE BE STUCK DOWN AS WHOLE IN THE INTEREST OF JUSTICE OR AMEND AND THE APPELLANT FOR THE POST OF SST WAS REGULARIZED THROUGH THIS ACT BE CONSIDERED FOR THE PROMOTION FROM THE DATE OF HIS INITIAL APPOINTMENT /REGULARIZATION, RESPONDENTS BE DIRECTED NOT TO ISSUE FINAL SENIORITY LIST TILL FINAL DISPOSAL OF INSTANT APPEAL OR CONSTITUTE THE DPC IN THIS RESPECT AND OTHER RELIEF THAT MAY BE PERMISSIBLE UNDER THE LAW AND CONSTITUTION BE ALSO ALLOWED TO THE APPELLANT AGAINST THE RESPONDENTS TO MEET THE ENDS OF JUSTICE .

Respectfully Sheweth,

1. That in pursuant to advertisement appellant applied for the post of SST and after undergoing the due process of recruitment appellant was appointed on contract basis.(Copy of appointment order is annexed as **Annexure "A"**)`
2. That service of the appellant was regularized in the light of the impugned act from the date of their initial appointment. (Copy of notification is annexed as **annexure "B"**).
3. That the service of the appellant and many other employees were regularized from the date of initial appointment vide section 3 of Khyber Pakhtunkhawa Employees of the Elementary and secondary education Department (Appointment and Regularization of services) Act 2017. (Copy of the act 2017 is annexed as **annexure "C"**).
4. That after regularization of the contract form the initial appointment, appellant allowed all the back benefits but surprisingly respondents issued tentative seniority list of SST in the year 2020 in the light of section 4 of the act 2017

wherein appellant publicized junior to other promoted teachers.

5. That being aggrieved appellant filed departmental appeal for consideration from initial appointment, correction and redressal but till date respondents not passed any order on the same. (Copy of the appeal Performa is attached as annexure D).
6. That being aggrieved the impugned act is being assailed on the following amongst other grounds:-

GROUNDS:-

- a. That the impugned section of law is illegal and unlawful, coram -non judice, based upon mala-fide and ulterior motive hence, liable to be set aside / revised / modified.
- b. That under well-established principle of law, the seniority shall be considered from the date of initial appointment rather than date of confirmation and regularization.
- c. That as per section 3 of regularization of services act of 2017 contract of the appellant was regularized from initial appointment, wherein services/tenure of appellant secured but amazingly section 4 of act 2017 is tantamount to spoiling the initial consumed period of service and shall remain junior to other promoted teacher through this section hence section 4 of said act is ultra vires of the constitution.
- d. That similarly all in-service teachers who were inducted through NTS as SST before commencement of the said act be treated equal in seniority list with other teachers.
- e. That the honorable supreme court of Pakistan held in PLD 1963 SC 382 " any system which by giving effect to the form

and not to the substance , defeats substantive rights is defective to the extent” .

- f. That as per article 18 of constitution of Pakistan every citizen had right to enter upon any lawful occupation or profession subject to qualification as might be prescribed, as petitioners are fulfilling all requirements, have prescribed qualification and should be treated with other employees.
- g. That the impugned section of law , act and conduct of the implementation is void ab-initio, unlawful, beyond to the authority, null and void result of malafide, exercise of authority, without opportunity of being heard, against the rights of the appellant thus liable to be struck down.
- h. That, the appellant is entitled to promotion and other allied necessary matters as per old Policy which was practiced and prevailing at the relevant time of appointment of appellant and are entitled to the respective quota.
- i. That the appellant has been treated discriminately against the Art.25 of the constitution of Pakistan, 1973 hence not tenable.
- j. That, the appellant has been left without any remedy and this appeal is only the hope and remedy to the rights of the appellant and if this act will not amended the loss of the appellant would not be covered and appellant is being made victim without any fault.
- k. That appellant along with others challenged the said act before Peshawar high court Abbottabad Bench, which was dismissed being not pressed .(copies of the writ petition and order are annexed as **annexure E**).

1. That appeal is well within time.

It is therefore, humbly prayed that on acceptance of instance appeal it is humbly prayed that respondents be directed to amend the section 4 of the act 2017 and impugned section be declared as violative of the fundamental rights guaranteed by the constitution and also null and void the same may please be struck down as whole in the interest of justice or amend and the appellant for the post of SST was regularized through this act be considered for the promotion from the date of his initial appointment / regularization, respondents be directed not to issue final seniority list till final disposal of instant appeal or constitute the DPC in this respect and other relief that may be permissible under the law and constitution be also allowed to the appellant against the respondents to meet the ends of justice .

It is hereby enacted as follows:

1. Short title, application and commencement.--(1) This Act may be called the *Khyber Pakhtunkhwa Employees of the Elementary and Secondary Education Department (Appointment and Regularization of Services) Act, 2017.*

(2) It shall apply to all the employees in the *Elementary and Secondary Education Department*, as defined in clause (c) of sub-section (1) of section 2 of this Act.

(3) It shall come into force at once and it shall be deemed to have taken effect from the date of the initial appointment of the employees as referred to in clause (c) of sub-section (1) of section 2 of this Act.

2. Definitions.--(1) In this Act, unless the context otherwise requires,-

(a) "Commission" means the *Khyber Pakhtunkhwa Public Service Commission*;

(b) "contract appointment" means appointment of a duly qualified person for a specific period made otherwise than in accordance with the prescribed method of recruitment;

(c) "employees" mean duly qualified persons:-

(i) who are appointed as teachers on adhoc or contract basis by the Government after 2013 through *National Testing Service* but does not include the teachers engaged on *work charge* basis or who are paid out of contingencies;

(ii) who are appointed in the projects on contract basis in accordance with the project policy; and

(iii) who are appointed as *Junior Clerk* in the *Elementary and Secondary Education Department* by Government after 2013 through *National Testing Service*;

(d) "Government" means the *Government of the Khyber Pakhtunkhwa*;

(e) "law or rule" means the law or rule for the time being in force governing the selection and appointment of civil servants;

(f) "project" means:-

- (i) IT/Computer Teachers in Computer Labs Projects in Khyber Pakhtunkhwa (Phase-II);
 - (ii) establishment of five hundreds (500) IT Labs in Government High and Secondary Schools in Khyber Pakhtunkhwa; and
 - (iii) establishment of five hundreds (500) IT Labs in Government High Schools in Khyber Pakhtunkhwa (Phase-III); and
- (g) "teacher" means a teacher of primary, middle, secondary or higher secondary school.

(2) The expressions "ad hoc appointment" shall have the same meaning as respectively assigned to them in the Khyber Pakhtunkhwa Civil Servants Act, 1973 (Khyber Pakhtunkhwa Act No.XVIII of 1973).

3. **Regularization of services of employees.**---(1) Notwithstanding anything contained in any other law or rules, the employees, who hold posts till the commencement of this Act, shall be deemed to have been validly appointed on regular basis from the day of the initial appointment; provided that-

- (i) they possess the same qualification and experience required for a regular post;
- (ii) they have not resigned from their services or terminated from services on account of misconduct, inefficiency or any other ground, before the commencement of this Act; and
- (iii) the service promotion quota of all service cadres shall not be affected.

(2) The services of the employees shall be deemed to have been regularized only on the publication of their names in the official Gazette.

4. **Determination of seniority.**---(1) The employees whose service are regularized under this Act or in the process of attaining service at the commencement of this Act, shall rank junior to all other employees belonging to the same Cadre, who are in service on regular basis on the commencement of this Act, and shall also rank junior to such other persons, if any, who, in pursuance of the recommendation of the Commission made before the commencement of this Act, are to be appointed to the Cadre, irrespective of their actual date of appointment.

(2) The seniority inter-se of those employees, whose services are regularized under this Act within the Cadre, shall be determined on the basis of their continuous service in Cadre:

Provided that if the date of continuous service in the case of two or more employees is the same, the employee older in age shall rank senior to the younger one.

5. **Overriding effect.**--- Notwithstanding anything to the contrary contained in any other law or rules for the time being in force, the provisions of this Act shall have an overriding effect and the provisions of any such law or rules to the extent of inconsistency to this Act shall cease to have effect.





GROUNDS:-

- a. That the impugned section of law is illegal and unlawful, coram -non judice, based upon mala-fide and ulterior motive hence, liable to be set aside / revised / modified.
- b. That under well-established principle of law, the seniority shall be considered from the date of initial appointment rather than date of confirmation and regularization.
