Defendants through counsel present. None present for

plaintiffs. Repeated calls were made till the closing hours of the court, but none turned up on behalf of the plaintiffs, despite strict directions on the previous date. Hence, the Court opted to proceed further.

The background of the case in hand is that an execution, bearing No.11/10 of 2020 was filed by Mst. Sabeeha and four others against DHA, Peshawar for the execution of a fabricated and bogus decree, dated 02/02/2020 in file No 14 /1. The DHA, Peshawar after receiving the notice in said execution, filed a petition u/s 12(2) CPC against the bogus decree and also reported the matter of fake decree passed on a Sunday to the Hon'ble the Chief Justice. Peshawar High Court, Peshawar, who was pleased to threat the Hon'ble District & Sessions Judge, Peshawar to look into the matter. Resultantly, an inquiry was conducted through learned AD&SJ-XIII Peshawar, which held the decree and case in question as forged/bogus. Thus, the inquiry report was sent to the August Peshawar High Court for further directions.

The learned MIT of Peshawar High Court, vide letter No.735/MIT, dated 22/09/2021, conveyed the directions of August Peshawar High Court for departmental proceedings against the Court officials, and criminal proceedings against the beneficiaries of the fake decree and said beneficiaries have been pointed out in inquiry report of learned Senior Civil Judge (Judicial), Peshawar

There is no direct evidence regarding the involvement of the accused/official in typing he judgment or the order The only allegation against accused/official is that in the Faisla Bahi Register (hereinafter referred to as the Register) there is an entry regarding the subject case. The Reader is the custodian of the Register. Due to this reason the learned Additional District & Sessions Judgo-XIII, Peshawar, in the preliminary inquiry, has four d the accused/official to be guilty of negligence.

The real question is whether the accused/official is involved in sending the fake file (decree) to the Record Room (Civil), District Courts Peshawar. The fact of the matter is that the file was sent by the Moharrir (Qaisar Khaa, the other accused) to the Record Room. The stance of the accused/official is that the entry in the Register has Leen made by someone else and he is unaware of the same. He considers that someone has entered the case in the Register so as to make a ground for the genuineness of the decree.

It is clear that there is no direct evidence as to who has made the wrong entry. The presumption can be drawn that the accused/official himself has made the entry is he is the custodian of the register but this presumption is rebutted by the fact that the case is proved against the other accused namely Qaisar Khan, the then Mohr rir attached to the Court of the learned Civil Judge-XVI. Peshawar. It seems that the other accused somehow man ged to make the entry in the Register maintained by the accused/official. It is a normal routine that all the of icials working in the Courts do give their registers to one another if asked for.

during the discreet probe the entry was there in the Register. However he has explained after this admission that there was no entry of the decree in the Register but when people started talking about the fake decree, then someone has made the entry in his Register. In the crossexamination the accused/o ficial has also admitted that he has not given any information in writing to the learned Judge regarding the bogus entry in his Register. He has further explained that he nformed the learned Judge orally after the fake entry was detected. The charge against the accused/official is proved to the extent that the entry of the fake decree is there in the Register. However from the attend ng circumstances and the evidence recoded in both the cases (case No. 13/6 of 2021 & case No. 14/6 of 2021) it can be gathered that the accused/official has not made the entry himself. It has been made by someone else to make a ground for the genuineness of the fake decise.

Subject: Departmental Appeal against the order dated 17/02/2022 passed by District and Session Judge Peshawar wherein appellant has been compulsorily retired from service which is illegal against law and facts.

PRAYER: On acceptance of this del artmental appeal, impugned order dated 17/02/2022 passed by District and Session Judge Peshawar wherein appellant has been compulse rily retired from service may please be set aside and appellant may please be reinstated in service with all back benefits.

Respected Sir,

Appellant humbly submits as under:

- 1. That appellant was appointed as Chowkidar (BPS-1) vide appointment order dated 13/05/1999 (Copy of the appointment order dated 13/05/1999 is attached as Anneque A)
- 2. That appellant was promoted to the post of Naib Qasid vide order dated 27/09/2001 (Copy of the promotion order dated 27/09/2001 is attached as Annexure B)

- 3. That appellant was promoted to the post of Junior Clerk (BPS-5) vide promotion order dated 09/09/2002 (Copy of the promotion order dated 09/09/2002 is attached as Annexure C)
- That appellant was promoted to the post of Senior Clerk (BPS-9) vide order dated 09/07/2010 (Copy of the promotion order dated 09/07/2010 is attached as Annexure D)
- 5. That the post of Senior Clerk was upgraded from BPS-9 to BPS-14 in the year 2012-13 and was performing duty as reader to Civil Judge XVII Peshawar.
- 6. That appellant is B.A (Bachelor o Arts) qualified from Abdul Wali Khan University Mardan (Copy of the B.A degree is attached as Annexure E)
- That the findings of the Learned Additional District Judge namely Sajid Khan as a probe-finding inquiry with respect to appellant is limited to negligence which too is illegal against law and facts as at the back of the appellant (Copy of the probe finding inquiry report is attached as Annexure F)
- 8. That appellant was charge sheeted along with statement of allegation on 01/10/2021 for inefficiency/misconduct (Copy of the charge sheet along with statement of allegation is attached as Annexure G)
- 9. That appellant properly replied the same on 06/10/2021 (Copy of the reply dated 06/10/2021 is attached as Annexure H)
- 10. That the allegation against the appellant is entry in the Faisala Bahi register of the fake decree titled as Mst Sabiha and other versus Assistant Director Land, DHA and others.

- 11. That appellant denied the same and asserted that the register is not in the exclusive custody of the appellant but remains in the Court room to open cupboard without lock and key and accessible to every official of the Court.
- 12. That the entry at the bottom on 02/02/2020 regarding the fake decree has been made by someone wherein the list column has been further divided into two and thus the squares of this row are smaller than the preceding one (Copy of the relevant page dated 02/02/2020 of the Faisala Bahi register is attached as Annexure I)
- 13. That the handwriting of entry of the fake decree is different than that of the handwriting of the appellant with respect to the remaining entries in the register.
- 14. That the fake entry may have been made by the scrupulous hands much later than the date of decree most probably held guilty and dismissed from service by the Senior Civil Judge (Admin) i.e Muharrir/Naib Nazir of the Court.
- 15. That as the entry has been made clandestinely and it never came into my notice as the guilty hands had effected the entry whenever they got the opportunity.
- 16. That as a matter of fact, the working relationship of the Court is based on confidence in between the Court staff and the register cannot be kept in the exclusive custody of the reader.
- 17. That it is human for the reader to leave his seat for attending bathroom, tea-break, lunch break and prayer break.
- 18. That the opening and locking of the door of the Court is the responsibility of the Naib Qasid concerned.
- 19. That inquiry has been conducted at the back of the appellant.

- 20. That similarly appellant has not been confronted with any of the document and the appellant has not been given any opportunity to cross examine any witness.
- 21. That a show cause notice was issued to the appellant which was properly replied by the appellant (Copy of the show cause notice and reply to show cause are attached as Annexure J)
- 22. That neither appellant has been charged for making entry of bogus decree with deliberate evil/mala ide intention nor the same has been proved.
- 23. That appellant has been charged only for inefficiency and misconduct.
- 24. That neither appellant has been associated with the inquiry nor any witness has been examined in mont of the appellant. (Copy of the inquiry report of Senior Civil Judge is attached as Annexure K)
- 25. That the finding of inquiry by the Learned Senior Civil Judge Peshawar wherein he has concurred with the finding of the fact-finding inquiry officer mentioned above is also limited to negligence which too is illegal against law and facts.
- 26. That appellant has rendered 22 years satisfactory service wherein neither any show cause notice nor any warning has been issued to the appellant and has earned good ACRs throughout.
- 27. That the entire record shows that the decree is fake and bogus and with malafide designs, the execution has been filed much later after 10 months i.e on 11/12/2020 so that no one should notice the same. (Copy of fake and bogus decree and order sheets and case file is attached as Annexure L)

- 28. That appellant reiterates and aff tms on oath that appellant has never noticed the entry of the bogus decree and the moment, it came into the notice of the appellant, appellant immediately orally informed the Presiding Officer namely Mr Rafaqat Zahoor (Civil Judge XVII Peshawar) as well as Mr Justice Younas Khan (the then District and Session Judge Peshawar) and appellant submits an affidavit to this effect with this Departmental appeal (Affidavit in original is attached as Annexure M)
- 29. That appellant has been compulsorily retired vide order dated 17/02/2022 passed by the Learned District and Session Judge Peshawar which is illegal against law and fac s on following grounds: (Copy of the impugned order dated 17/02/2022 is attached as Annexure N)

GROUNDS:

- A. Because appellant is innocent and falsely charged.
- B. Because as per inquiry report, appellant has not been held guilty for misconduct and inefficiency.
- C. Because the inquiry officer has held that appellant is guilty of negligence and the impugned penalty of compulsor retirement does not commensurate with the charge as consistently held by the Honorable Supreme Court of Pakistan reported in 2006 SCMR 60. (Copy of the judgment reported in 2006 SCMR 60 is attached as Annexure O)
- D. Because the Honorable Supreme Court of Pakistan has held that major penalty cannot be imposed for the clurge of negligence.
- E. Because the handwriting of Moharrir/Naib Nazir in Ex CW-8/2 resembles with that of entry in Faisala Bahi regis er and therefore the alleged entry has been made by the Moharrir/Naib Nazir and to this effect, the present appellant is filing separate application with this Departmental appeal for forensic examination of the handwriting in Ex CW-8/2 as well as Faisala Bahi register.

- F. Because even the charge of negliger ce is not proved as the Learned Senior Civil Judge has recorded his finding as inquiry officer that the register Faisala Bahr doesn't remain in the exclusive custody of the reader but it goes into different hands of different Court officials.
- G. Because the appellant has specifically asserted in Para No 2 of the reply to charge sheet that the entries made in the register be sent to handwriting expert/Forensic Science Laboratory but the Learned inquiry officer failed to send the alleged entry made in the register to expert.
- II. Because the Learned inquiry officer has failed to arrive at the conclusion as to who has committed the act of entry of fake decree in the Faisala Bahi register.
- I. Because as per statement recorded by Inquiry officer, Qaiser (Reader to Senior Civil Judge Peshawar) has er lorsed the fact that there is no entry made in the marking register of the S. nior Civil Judge (Judicial) Peshawar.
- J. Because the mode and manner under which the entry has been effected in the Faisala Bahi register while squeeting the last row by dividing into two halves by itself speaks of the fact that it can't be entered by the appellant but the evil doers have effected the entry in a hurried manner by creating an extra row. Moreover, no serial number has been given to the said entry and the date of judgment is wrongly written as 2002 instead of 2020 which fortifies the fact that the entry has been made in a hurried manner by the evil doer.
- K. Because the cause lists and Peshi egister is maintained by the reader (appellant) and there is no entry in the cause list as well as Peshi register.

 Moreover, the appellant has completed computer training of the software developed by District Judiciary. There is no entry in the computer software maintained by the appellant.
- L. Because it was the boundened duty of the inquiry officer to give finding beyond any shadow of doubt as to who has entered the fake/bogus entry.

- N. Because there is neither any allegation upon the appellant nor its proof that appellant is in connivance with the beneficiary or has any relationship with the beneficiary fake decree holder.
- O. Because in such type of cases, the c. argc must be specific like criminal cases and must be strictly proved.
- P. Because the connected inquiry against the Moharrir/Naib Nazir wherein ultimately they have been inflicted with a more severe penalty of dismissal from service speaks of the fact that they were involved in making the entry. (Copy of the inquiry proceedings in the case of Moharrir is attached as Annexure P)
- Q. Because neither the Presiding Officer of the Court nor the KPO nor the stenotypist nor the Naib Qasid has been penalized.
- R. Because as per rules, all the accuseds should have been jointly tried but separate inquiries in the cases is illegal against law and facts.
- S. Because appellant is jobless and entitled for back benefits.

It is therefore humbly prayed that on acceptance of this departmental appeal, impugned order dated 17/02/2022 passed by Learned District and Session Judge Peshawar wherein appellant has been compulsorily retired from service may please be set aside and appellant may please be reinstated in service with all back benefits.

JUDGMENT

MUHAMMAD NAWAZ ABBASI, J.— These connected appeals by leave of the Court, have been directed against the judgment dated 16-10-2000 passed by the Federal Service Tribunal whereby the major penalties of removal/compulsory' retirement from service awarded to the respondents by the competent authority, were converted into reduction in time scale by hree stages for two years without cumulative effect and the appeals of the respondents were partly allowed. These appeals, in which leave was granted vide order, dated 26-2-2002, involving common question of law and facts, are proposed to be disposed of through this single judgment. Leave granting order is read as under:—

"Through this order we propose to dispose of above captioned three petitions filed on behalf of Autitor-General of Pakistan to assail the validity of orders dated 16th of November, 2000 whereby the Federal Service Tribunal accepted the appeals of the respondents, set aside their respective impugned orders and modified their penalty to that of reduction in time scale by three stages for a period of two years without cumulative effect with the consequence that they were reinstated in service with direction that their intervening period we ild be treated as leave of the kind due.

With the assistance of the learned counsel for the pet tioner and respondents, we have gone through the judgment impugned in all three cases. Hafiz S.A. tehman Advocate Supreme Court representing the respondents has attempted to argue that excess payments paid to recipient Government officers is being recovered from them through the process of lard, but we do not find any substantial evidence or the material to believe the same. Anyhow, the crucial question for determination involved in these cases is whether on the ground of inefficiency and negligence, the major penalty of compulsory retirement could have been converted and modified to that of reduction of time scale by three stages in exercise of the appellate jurisdiction of the A Tribunal. Furthermore, so to what type of inefficiency and negligence could attract the imposition of major penalty. To consider these questions, we grant leave to appeal in all three cases with direction to office to fix them for final disposal at an early date."

- 2. The respondents namely. Kazim Ali, (Assistant Officer) Mu nammad Ali and Syed Zahid Mumtaz, (Senior Auditor), were proceeded against for the charge of negligence and inefficiency based on the allegation that they were responsible of causing loss to the Government exch quer on account of the over payment made in certain G.P.F. accounts on final payments. The Inquiry Office Deputy Accountant-General) having held the respondents guilty of the charge of negligence and inefficiency submitted his report and the authorized officer, on the basis of inquiry report, issued show-cause notice to them proposing major penalty of removal from service. The competent authority, however, awarded the punishment of removal from service to Kazim Ali whereas Muhammad Ali and Syed Zahid Mumtaz were imposed the penalty of compulsory retirement. The respondents after exhausting the departmental remedies filed separate appeals before the Service Tribunal which were partly allowed and in consequence thereto, the punishment awarded to them by the competent authority was modified as stated above and they were reinstated in service with direction of treating the intervening period as leave of the kind due.
- 3. The learned Deputy Attorney-General has contended that Tribunal having come to the conclusion that respondents were guilty of the charge of inefficiency and negligence was not justified in converting the major penalty of removal from service and compulsory retirement into the reduction of time scale by three stages. However, on pointing out that the Tribunal having taken into consideration the nature of charge, coupled with the fact that there was no allegation of wrong ul gain through fraud, misappropriation or embezzlement formed an opinion that punishment of removal and compulsory retirement from service in the circumstances of the case was harsh, reduced the penalty the learned counsel has not been able to satisfy us that the reasons given by the Tribunal for reduction of punishment in exercise of the powers under section 5 of the Service Tribunals Act. 1973, were unfounded or unreasonable and unjustified. The learned D.A.-G. also has not been able to satisfy us that senior officers who equility shared the responsibility of negligence in the transaction of over-payment, were awarded minor penalty of recovery of nominal amount of Rs.5.000

4. In the light of foregoing discussion, these appeals fail and are accordingly dismissed. There will be no

The Hon'ble Civil court makes necessary order regarding registration and reader of the Court enters in the fresh case into his daily diary regist r. Thereafter the case is received by Muharrar and the case is registered in civil register.

The petitioner received the court file from the court of learned CJ-XVII through the Peon and necessary entries were made in the relevant civil register along with 11 others freshly instituted cases on the same day.

The suit was disposed off by the Hon'ble court, wherein the case file was sent to the petitioner as Civil Muharrar for con: gning the same to record room after necessary completion. The petitioner obliged according to the order

- It is necessary to mention that the suit file contained printed decree sheet, duly received from the Hon'ble court, wherein just small necessary entries were made by the petitioner and then the same was sent to the record room for its consignment. Thus the allegation of prepa ation of fake court decree is entirely incorrect and liable to be rescinded as suci.
- Needless to mention that the entries of the disposal of the suit file exists in the 9) register of Faisla Bahl retained by the reader to the court and signatures of the worthy presiding Officer over each order sheet which were never proved to be
- It is worth mentioning that the worthy Inquiry Officer neither called, summoned the plaintiff nor his counsel to ascertain the real factum of the case in question. In absence of such findings the inquiry report the learned ADJ-XIII, Peshawar is incomplete and cannot be relied upon.

The majority of the work done, in the suit file was in the court of learned CJ-XVII, Peshawar and the same was sent to the petitioner only for its final entries in the already printed out decree sheer, Faisal Bahi register and its consignment to the record room, which he did according to the laid down naminer) procedure. - The petitioner has not committed an thing wrong on his part, nor done any 121 corrupt practice or violation of official cuties, breach of trust and misconduct in clicial capacity, and had just followed the order contained in the order sheet of ٠.٠٠.
- The petitioner has 20 years of long se vice at his credit and that neither any complaint was ever filed against him nor was any disciplinary proceedings initiated against him during entire period of his service.
- The allegations made herein against the petitioner would adversely affect his otherwise clean service record and would definitely harm his reputation, which he built up in his long service career. There is no fault on the part of the petitioner, the charge sheet under reply is being made on the basis of false, frivolous and vague allegations is liable to be struck down while completely exonerating the petitioner of the charge aveled against him.

In view of the above, it is requested that by accepting this reply, the charges 'eveled against the petitioner may kindly be set aside, with the request to exone ate the petitioner from all the charges leveled against him.

- 1. This is a fact finding inquiry about the genuineness of conduct of proceedings and judgment in civil suit No.141/1 of 2019 titled "Mst. Sabiha and others Vs Assistant Director Land, DHA and others". The inquiry in hand was entrusted to undersigned as aquiry officer by the order of Hon ble District & Sessions Judge. Peshawar vide office order No.2525-26 dated 09.0 1.2021.
- 2. Brief facts are that a civil suit bearing No.141/1 of 2019 titled "Mst: Sabiha and other: Vs Assistant Director Land. DHA and others" was shown instituted in the Court of learned Senior Civil Judge, Peshawar and the same was entrusted to the court of learned civil judge-XVII, Peshawar vide order dated 02 05.2019. After completion of trial, the subject case was de need ex-parte vide judgment and decree dated 02.02.2020. The date of subject judgment was a non-working day and the matter of subject judgment having been passed on the date falling on non-working day i.e. Sunday, was brought into the kind notice of Hon'ble Chief Justice of Peshawar High Court. Peshawar and his ioidship had directed to look into the matter through an open inquiry.



 - II. The register of institution/marking of suits etc of the year 2019 did not cc train any entry regarding the institution of case file of subject suit.

- IN. Visible and apparent variations in the signatures of presiding officer of the court on order sheets, which are not matching each other.
- N. Process server concerned has shown ignorance and denied service of summons in the subject case.
- XI. There is entry of subject case file in register Faisla Bahi without bearing any specific number.

Khan in register No.1, register Faisla Bahi, challan book and he also admitted receiving of subject case file as well as its consignment to the record room, therefore, it could be held that Moharrir of the court namely Qaiser Khan, being custodian of record as well as aware of the forged entry of subject case file in the record, seems to be prima facie involved in the matter. Se condly, the reader of the court namely Mujahid Khan was the custodian of register faisla bahi wherein reference of subject case file has been given but without any serial number.
