AGAINST NO ACTION TAKEN ON THE DEPARTMENTAL
APPEAL OF THE APPELLANT WITHIN THE STATUTORY
PERIOD OF NINETY DAYS.**

PRAYER:

That on acceptance of this appeal the impugned Notification dated 07-02-2020 may very kindly be set aside to the extent of private respondents and the appellant may be promoted to the post of SST (G) being senior to the private respondents w.e.f 07.02.2020 with all back benefits. Any other remedy which this august Tribunal deems fit that may also be awarded in favor of the appellant.

R/SHEWETH:

ON FACTS:

- 1- That appellant was initially appointed as PTC (BPS-07 now BPS-12) on the proper recommendation of Departmental Selection Committee vide order dated 05-03-1990. That in response to the said order the appellant took over the charge and started performing his duty quite efficiently and up to the entire satisfaction of his superiors. Copies of the appointment order and service book are attached as annexure.....**A&B.**

- 2- That during service the appellant was promoted to the post of PSHT (BPS-15) vide order dated 26-07-2013. Copy of the promotion order dated 26-07-2013 is attached as annexure.....C.
- 3- That as per the seniority list issued by the Respondent No. 3 on January, 2019 the appellant stood at serial No. 270. Copy of the seniority list of January, 2019 is attached as annexure.....D.
- 4- That being senior most of the respondent Department the appellant was quite hope full for his promotion to the post of SST (BPS 16). That astonishingly the respondent Department issued the promotion Notification dated 07.02.2020 whereby junior colleagues of the appellant was promoted to the post of SST (G) (BPS-16) while the appellant has been ignored with^{out} assigning any reason and clear justification. Copy of the impugned notification is attached as annexure.....E.
- 5- That feeling aggrieved from the impugned notification dated 07.02.2020 the appellant preferred departmental appeal before the appellate authority but no response has been received from the quarter concerned so far. Copy of the departmental appeal is attached as annexure.....F.
- 6- That appellant feeling aggrieved and having no other remedy filed the instant service appeal on the following grounds amongst the others.

GROUND:

- A- That the impugned notification dated 07-02-2020 is against the law, facts, norms of natural justice and materials on the record hence not tenable and liable to be set aside.
- B- That appellant has not been treated by the respondent Department in accordance with law and rules on the subject noted above and as such the respondents violated Article-4 and 25 of the Constitution of Islamic Republic of Pakistan-1973.
- C- That the respondents acted in arbitrary and malafide manner while issuing the impugned notification dated 07-02-2020 by promoting the private respondents to the post of SST (G) (BPS-16).
- D- That it is pertinent to mention here that as per the seniority list the appellant is senior as compared to the private respondents, therefore, the impugned promotion notification is liable to be set aside to the extent of private respondents.
- E- That the appellant has served the Department for a long period with unblemished service record and having seniority cum fitness,

- therefore, the appellant has the due right to be promoted to the post of SST (G) (BPS-16).
- F- That the impugned Notification dated 07.02.2020 is violative of section-9 of the Civil Servant Act, 1973 read with Rule-7(3) of Khyber Pakhtunkhwa Civil Servant Appointment, Promotion & Transfer Rule, 1989.
- G- That the impugned Notification dated 07.02.2020 is against the principle of natural justice, hence not tenable and liable to be set aside to the extent of private respondents.
- H- That the appellant being senior to the private respondents is fully entitle for promotion to the post of SST (G) (BPS-16) but inspite that the appellant has been ignored and promoted the private respondent who are junior to the appellant.
- I- That appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed for.

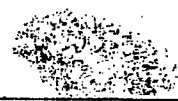

Preliminary objections

1. That the Appellant is not an aggrieved person within the meaning of Section 4 of the service Tribunal Act, 1974.
2. That the Appellant has no cause of action / locus standi.
3. That the Appellant has not come to this Honorable Court with clean hands.
4. That the Appellant has filed this instant service appeal just to pressurize the respondents.
5. The present service appeal is liable to be dismissed for non-joinder miss joinder of necessary parties.
6. That the instant service appeal is against the prevailing law and rules.
7. That the Appellant has filed this instant Service Appeal on malafide motives.
8. That the instant appeal is badly time barred.
9. That the instant service appeal is not maintainable in the present form, and above in the present circumstances of the issue.
10. That the Appellant has estopped by his own conduct.
11. That the Appellant has concealed the material facts from this Honorable Tribunal.

FACTS:

- I. That the Para No. I is irrelevant, however the respondents also seek permission of this Honorable Tribunal to advance further grounds at the time of arguments.


It is, therefore, very humbly prayed that the instant service appeal of the Appellant may be dismissed with cost in favor of the respondents.
