



This appeal seems to be the part of ongoing pursuit of appellant against his removal from service vide order dated 24.03.2015. In the meantime, he filed appeal before the Federal Service Tribunal in a status of a Federal Government employee which was remanded to the department. Although due to the 25th Constitutional Amendments, the forum for appellant changed but the parties in the matter remained the same. Last order has been passed on 09.06.2020 which is also impugned in the present appeal. Subject to valid, legal objections, this appeal is admitted for regular hearing. The appellant is directed to deposit security and process fee within 10 days. Thereafter, notices be issued to the respondents for submission of written reply/comments in office within 10 days after receipt of notices, positively. If the written reply/comments are not submitted within the stipulated time, or extension of time is not sought through written application with sufficient cause, the office shall submit the file with a report of non-compliance. File to come up for arguments on 29.11.2021 before the D.B.


