Contends that juniors to the appellant were promoted to BPS-17 through notification dated 26.02.2013 while such promotion was denied to the appellant, purportedly due to non-availability of some of her ACRs. Upon submission of departmental appeal the appellant's name was included in the promotion notification dated 17.03.2016 but with immediate effect. Resultantly, she lost her seniority by a big margin.

Speaking about the apparent delay in submission of instant service appeal, learned counsel referred to judgment of Apex Court reported as 2002-PLC(C.S)1388 and stated that in cases of seniority and promotion etc. such delay is to be disregarded.

Subject to all just exceptions, instant appeal is admitted to regular hearing. The appellant is directed to deposit security and process fee within 10 days. Thereafter, notices be issued to the respondents. To come up for written reply/comments on 23.11.2020 before S.B.
