PRAYER:- ON THE ACCEPTANCE OF THE INSTANT APPEAL THE IMPUGNED NOTIFICATION DATED 05-05-2020 ISSUED BY RESPONDENT NO. 03 BE MODIFIED TO THE EXTENT OF APPELLANT IN ACCORDANCE WITH THE REQUISITION, ADVERTISEMENT & RECOMMENDATION OF THE RESPONDENT NO. 04 AS PRINCIPAL/VICE PRINCIPAL BPS-18 INSTEAD OF SS BPS-18 OR OTHER TEACHING CADRE AND ANY OTHER RELIEF WHICH THIS HONOURABLE TRIBUNAL DEEM FIT AND APPROPRIATE MAY ALSO BE AWARDED TO THE APPELLANT.

1. That, a requisition for the recruitment of 204 (M) Principals/Vice Principal BPS-18 was sent to the Khyber Pakhtunkhwa Public Service

Commission by the E&SED in 2017. (Copy of the requisition is attached as Annexure "A").

2. That, appellant applied for the post of Principal/Vice Principal in line with the advertisement No. 03/2018 at Serial No. 22 advertised by KPPSC on 09-02-2018. (Copy of the advertisement is attached as Annexure "B").
3. That, appellant took screening test in May, 2018 and then KPPSC sent interview call letter No. PSC/SR-IX/003053 dated 13-02-2019 for the post of Principal and also intimated through text message on personal number on 04-03-2019. (Copy of the call letter dated 13-02-2019 alongwith test message are attached as Annexure "C").
4. That, appellant was recommended as Principal BPS-18 at serial No. 23 by KPPSC and recommendation letter No. PSC/SR-III/010012 dated 19-09-2019 was sent to appellant on his postal address. (Copy of recommendation letter dated 19-09-2019 is attached as Annexure "D").
5. That, KPPSC sent the recommendation of 198 male Principal/Vice Principal BPS-18 to E&SE department vide letter No. PSC/SR-II/019295-96 on 12-09-2019. (Copy of recommendation dated 12-09-2019 is attached as Annexure "E").
6. That, E&SED issued letter No. SO(SM)E&SED/3-2/2017/Recruitment of 204 male Principal dated Peshawar the September 17, 2019 to Director General, Health Services, KPK for constituting special medical Board. DG, Health Services, KPK issued letter 4773/medical dated 20-09-2019 to E&SED appearing before medical Board. Appellant got medical certificate for the post of Principal/Vice Principal. (Copy of letter dated 17-09-2019 and letter 20-09-2019 is attached as Annexure "F" & "G")
7. That E&SED issued letter No. SO(SM)E&SED/3-2/2017/Recruitment of 204 male Principals dated Peshawar the September 17,2019 to the Director E&SE, KPK directing him to furnish ACRs/PERs of the recommended Principals/Vice Principals to this office. Subsequently Deputy Director (Establishment) sent letter No. 6342/A 220/PER/Vol-V dated Peshawar the 07-10-2019 to Secretary, E&SED relating to submitting of ACRs/PERs of recommended Principals/Vice Principals.

(Copy of letter dated 17-09-2019 and letter dated 07-10-2019 are annexed as Annexure "H" & "I")

8. That, some SS BPS-18 (working Principals) filed writ petition before the Honourable Peshawar High Court Abbottabad Bench. Honourable Court disposed of writ petition with the remarks/observation that the advertised posts be considered as quota for initial recruitment in accordance with the recruitment rules for all the categories mentioned therein, on 23-10-2019. (Copy of the judgment dated 23-10-2019 is attached as Annexure "J").
9. That, in service Rules 2004 there are mainly four categories namely Principal, Vice Principal, Deputy Director PITE and Senior Subject Specialist RITE and other equivalent posts, which at time were Deputy District Education Officer and Deputy Director, but after creation/introduction of management cadre, these two posts are now fall in management cadre. The posts of Deputy Director PITE and Senior Subject Specialist RITE have been upgraded in BPS-19 in 4 tier upgradation in 2012. The post of SS BPS-18 was created in 4 tier upgradation in 2012 as well. (Copy of Rules is attached as Annexure "K").
10. That, worthy Secretary E&SED managed to constitute a committee of concerned departments for devising a mechanism for the appointment of recommendees, inspite of crystal clear judgment of Honourable Court.
11. That, the competent authority his worthy Chief Minister approved the summary for appointment on 27-04-2020.
12. That, this summary could have easily be approved in previous calendar year in the light of Honourable Court's Judgment without indulging in committee process and other delaying tactics and seniority financial loss of recommendees could be safeguarded.
13. That in appointment notification order dated 05-05-2020, appellant was appointed adjusted at serial No. 20 as subject specialist Physics at GHSS Khanispur Ayubia, Abbottabad whereas, the appellant was working as SS English and has nothing to do with Physics subject, furthermore, appellant never ever applied against the post of SS and departments said appointment notification/order is totally

contradictory to the requisition of department and recommendation of KPPSC. (Copy of notification dated 05-05-2020 is attached as Annexure "L").

14. That, another injustice/irregularity was done to the appellant that appellant was serving as SS English BPS-17 against the post of SS BPS-18 on OPS at GHSS Bagnetar, Abbottabad Mr. Sharf-ud-Din SS English BPS-18 was transferred at GHSS Bagnetar Abbottabad from GHSS Baghdada Mardan in E-Transfer on 09-04-2020. He took charge then he moved on application to Secretary E&SED through Principal, Principal forwarded the same application along with covering letter No. 635 dated 23-04-2020 posted to secretary E&SED on 28-04-2020 vide registered No. RGL 38106230, wherein Mr. Sharf-ud-Din requested that he might be adjusted against the post of SS English BPS-18 which was wrongly occupied by Akmal Hussain (Appellant) and who was recommended by KPPSC as Principal/Vice Principal and his appointment was expected soon, and he might be adjusted in his place as Vice Principal in the best interest of students. But when appointment order was issued, it was a great surprise for the appellant that the application of him and recommendation of Principal was partially accepted. Mr. Sharf-ud-Din was adjusted against the post of SS English BPS-18, which was already occupied by the appellant, but appellant was adjusted as SS Physics in a far away station GHSS Khanispur Ayubia, adopting pick and choose policy or other hidden factors, a third person was adjusted against the post of Vice Principal at GHSS Bagnetar Abbottabad instead of appellant according to said correspondence, which is sheer injustice and irregularity. Moreover, Bagnetar is the home station of appellant and appellant has served the department for about twenty years in for flung areas staying 24/7 at stations, and previous year the appellant was fortunately adjusted at GHSS Bagnetar. Now appellant's family and health would badly suffered if again posted at staying station. (Copy of application, letter and receipt is attached as Annexure "M").

15. That, appellant preferred departmental appeal on 28-05-2020 through registered post No. RGL38048359 before the respondent No. 01 but

didn't receive any response within the statutory period. (Copies of departmental appeal alongwith postal receipt are attached as Annexure "N").

16. That the appellant waited for statutory period of 90 days but received no intimation from respondent No. 01 hence, the present appeal is being submitted within the prescribed period of time, inter-alia on the following grounds:-


GROUND:

- a. That the impugned Notification dated 05-05-2020 is entirely misconceived in points of facts and the laws applicable thereto, hence, void ab-initio and the not binding on the right of the appellant.
- b. That, the impugned Notification dated 05-05-2020 is against the Law, Facts, requisition as well as against the recommendation letter dated 12-09-2019 issued by the respondent No. 04. Hence, impugned Notification dated 05-05-2020.
- c. That, the decision of Honourable Peshawar High Court Abbottabad Bench was misinterpreted by the respondents as according to Service Rules 2004 there are mainly four categories namely Principal/Vice Principal/Deputy Director PITE and Senior Subject Specialist RITE and other equivalent posts, which at that time were Deputy District Education Officer and Deputy Director, but after creation/introduction of management cadre, these two posts are now fall in management cadre while the posts of Deputy Director PITE and Senior Subject Specialist RITE have been upgraded in BPS-19 in 4 tier updatation in 2012 whereas, the post of SS BPS-18 was created in 4 tier updatation in 2012 as well. It was the sole responsibility of the respondents department to amend the service Rules 2004 according to the changes/development made in 2012, (4 tier updatation) and also lay down the procedure of newly created post of SS BPS-18 for direct recruitment and promotion.
- d. That, respondent No. 02 issued the appointment Notification on 05-05-2020 on the basis of recommendation letter No. 023290 dated 17-10-2019 issued by respondent No. 04 was misquoted by the respondent No. 01 whereas, the recommendation letter No. 019295-96 dated 12-09-2019 issued by respondent No. 04 was forwarded to respondent

No. 02 specifically for the purpose of recruitment of Principal/Vice Principal BPS-18 not for the overall teaching cadres as all the departmental process of submitting PERs/ACRs, appearing before medical Board etc were made in pursuance to the recommendation letter dated 12-09-2019. Hence, so called letter dated 17-10-2019 is void abinitio having no legal sanctity.


- e. That, on 03-06-2020 the appellant has requested via e-mail to respondent No. 04 regarding the provision of attested copy of letter dated 17-10-2019 under the provision of RTI Act but no vain. (Copy of email record dated 03-06-2020 is attached as Annexure "O").
- f. That, the appellant may be posted/adjusted at GHSS Bagnotar Abbottabad in pursuance to the recommendation of Principal/Vice Principal letter No. 635 dated 23-04-2020, against his original post.
- g. That the impugned Notification dated 05-05-2020 is liable to be modified to the extent of appellant as the appellant specifically applied for the post of Principal/Vice Principal BPS-18 and appellant passed his Masters in the subjects of English, Education and Political Science.

It is therefore, requested to your gracious honour to please on the acceptance of the instant appeal the impugned Notification dated 05-05-2020 issued by respondent No. 03 be modified to the extent of appellant in accordance with the requisition, advertisement & recommendation of the respondent No. 04 as Principal/Vice Principal BPS-18 instead of SS BPS-18 or other teaching cadre and any other relief which this Honourable tribunal deem fit and appropriate may also be awarded to the appellant.

We after examining the rules put the learned AAG to notice and directed to procure the requisition received to the Public Service Commission for the subject posts. After a while, learned AAG appeared and produced the requisition, he alongwith the Litigation Officer stated before the Court that in accordance with the recruitment rules, 20% of the vacancies were advertised for the reserved quota of initial recruitment and that they will strictly follow the recruitment rules. - A requisition for the recruitment of 204 Principals/Vice Principals was sent to the Khyber Pakhtunkhwa Public Service Commission by the E&SE department in 2017 (Annexure "A")
- Appellant applied for the post of Principal/Vice-Principal in line with the Advertisement No 3/2018, Serial No 22 advertised by KPPSC on 9-2-2018 (Annexure "B")
- Appellant was recommended as Principal/Vice-Principal BPS 18 at Serial No 23 by KPPSC and recommendation letter No PSC/SR-11/010012 dated 19/9/2019 was sent to appellant on his postal address (Annexure "C")
- KPPSC sent the recommendation of 204 Principal/Vice Principal to E&SE department vide letter No PSC/SR 11/019295-96 on 12/9/2019 (Annexure "D")
- Some SS 18 (Working Principals) filed writ petition before Honourable Peshawar High Court Abbottabad Bench. Hon'ble court disposed of writ with the remarks/observation that the advertised posts be considered as quota for initial recruitment in accordance with the recruitment rules for all the categories mentioned therein on 23-10-2019. (Annexure "E")
- On service rules 2004, there are mainly four categories namely Principal/Vice-Principal, Deputy Director P.T.E and Senior Subject Specialist R.T.E and other equivalent posts which were at that time were (1/5)

Distric Education officer and Deputy Director, but after creation/introduction of Management Cadre, these two posts are now fall in management Cadre. The posts of Deputy Director P.T.E and Senior Subject Specialist R.T.E has been upgraded in BPS 19 in 4 tier updation in 2012. The post of SS 18 was created in 4 tier updation in 2012 as well. (Annexure "F")

- His worthy Secretary E&SE managed to constitute a Committee of concerned departments for devising a mechanism of appointing recommendees, inspite of evident court judgment

- The competent authority his worthy chief minister approved the summary for appointment on 27/4/2020

- This summary could easily be made in previous calendar year in the light of H/able court judgment without indulging in committee process and other delaying tactics and seniority, financial loss of recommendees could be safeguarded.

- Education department (E&SE) issued the appointment notification on 05/5/2020. In this notification the recommendation of KPPSC dated 12-9-2019 was misquoted that recommendation was for all teaching cadres, whereas the recommendation letter is self speaking and contrary to said notification. The judgment of H/able court was also mis-interpreted in the said notification for court ordered to implement the service rules 2004 in the appointment of recommendees.

- In appointment notification order dated 05/5/2020 appellant was appointed/adjusted at S.No.20 as Subject Specialist physics at G.H.S. Khanspur

Ayubia Abbottabad whereas the appellant was working as SS' English and have nothing to do with physics subject, furthermore appellant never ever applied against the post of Subject Specialist and department's said appointment notification/order is totally contradictory to the requisition of department and recommendation of public Service Commission. (Annexure "G")

- Another injustice/irregularity was done to the appellant was that appellant was serving as Subject Specialist English BPS 17 against the post of subject Specialist English BPS 18 on O.P.S at GHSS Bagrotar Abbottabad. Mr Sharf-uddin SS 18 English was transferred at GHSS Bagrotar Abbottabad from GHSS Baghdada Marsdan in E-transfer on 9-4-2020. He took charge. Then moved an application to Secretary E & SE through principal, principal forwarded the same application along with covering letter No-635 dated 23-04-2020, registered to Secretary E & SE on 28/4/2020 wherein Mr Sharf-uddin requested that he might be adjusted against the post of SS English BPS 18, which was wrongly
