The abridgment of what has been agitated at the bar by the learned counsel representing appellant is that on induction as a Lecturer in Computer Science in the respondent-department on 04.11.2010 on adhoc basis as a staff gape arrangement, his services were extended for one year by making reappointment by virtue of notification dated 07.02.2012 on adhoc basis, subsequently, his services were regularized by virtue of notification dated 15.12.2014 and adjusted as Lecturer in Statistic against the regular post in Government Degree College Kotha, District Swabi, where he assumed his charge of his assignment. That by virtue of judgment of dated 24.05.2017 his colleagues his juniors who held similar position have been regularized from the date of initial adhoc appointment in the light of Regularization Act, 2014, nevertheless, appellant has been regularized with effect from 26.05.2014, it is apprehended that if respondents allowed back benefits and seniority to his colleagues and juniors colleagues appellant will have to suffer definitely. The departmental appeal moved for the purpose resulted in no response hence, the present service appeal.

The point so agitated at the bar needs consideration. The appeal is admitted for regular hearing subject to all just legal objections. The appellant is directed to deposit security and process fee within 10 days, thereafter, notices be issued to the respondents for written reply/comments for 29.03.2021 before S.B.




