That by virtue of judgment of dated 24.05.2017 his colleagues his juniors who held similar position have been regularized from the date of initial adhoc appointment in the light of Regularization Act, 2014, nevertheless, appellant has been regularized with effect from 26.05.2014, it is apprehended that if respondents allowed back benefits and seniority to his colleagues and juniors colleagues appellant will have to suffer definitely. The departmental appeal moved for the purpose resulted in no response hence, the present service appeal.
