



Mr. Zartaj Anwar, Advocate for the appellant present. Preliminary arguments heard.

Learned counsel for the appellant argued the case at the stage of preliminary hearing and contended that the appellant is aggrieved of the impugned order dated 07.10.2021 whereby he was promoted from the post of Junior Trade Instructor (Civil) BS-11 to the post of Trade Instructor (BS-15) and transferred from GCT Nowshera to Govt. Technical & Vocational Centre (Boys) Charsadda against the vacant post of Trade instructor (BS-15). The appellant filed an application for inquiry to be given antedated promotion to the post of Trade Instructor BS-15 from the date when his junior colleagues were promoted i.e. 04.03.2013 instead of 07.10.2021. The appellant is therefore aggrieved from the office order of his promotion with immediate effect. His departmental appeal was not responded within the stipulated statutory period whereafter, he approached the Service Tribunal on 13.04.2022.

Points raised need consideration. The appeal is admitted to regular hearing, subject to all just and legal objections. The appellant is directed to deposit security and process fee within 10 days. Thereafter, notices be issued to the respondents for submission of written reply/comments. To come up for reply/comments before the S.B on 09.08.2022. Alongwith the service appeal, CM was also submitted on 17.06.2022 to the effect that prayer clause whereas the date of impugned order was inadvertently written as 16.10.2021 whereas the correct date of impugned order is 07.10.2021 and may also be allow to place on file the impugned order dated 07.10.2021, which is placed on file. Notice be also issued to the respondents for submission of reply/comments.
