PARAWISE COMMENTS BY RESPONDENT NO. 1, 2, 3 & 4.**Respectfully Sheweth:****PRELIMINARY OBJECTIONS:**

- I. That the honorable Tribunal has no jurisdiction to entertain the present appeal.
- II. That the appellant has no locus standi to file the present appeal.
- III. That the appellant has not come to this Honorable Tribunal with clean hands.
- IV. That the appeal is not maintainable in its present form.
- V. That the appellant has suppressed and concealed the materials facts from this Honorable Tribunal.
- VI. That the appeal is barred by law and limitation.
- VII. That the appeal is bad for mis joinder and non joinder of necessary parties.

ON FACTS:

1. The appellant along with other being members of discipline force deliberately absented their selves from their lawful duty and to that the then Political Agent issued notices to them for duty but in vain. In the year 2007-10 the insurgency spread in the district and the appellant left the law and order at the mercy of miscreants therefore he was rightly removed/dismissed from service.

4. Correct, however, the order dated 08.12.2015 is silent about back benefits; therefore another order in compliance with directions of honorable court was issued on 11.12.2015 wherein decision regarding back benefits was made **(Both orders attached as Annexure A & B)**
5. Correct to the finding of enquiry committee. The rest of the para needs explanation to the effect that he was reinstated into his previous service by the Competent Authority/then Political Agent/Commandant Levy/Khassadar Force Bajaur pursuant to the recommendations of enquiry committee with immediate effect at the bottom of seniority as the appellant remained far from his service for a long period.

6. This para needs explanations to the effect that order of the Federal of Service Tribunal as well Supreme Court of Pakistan dated 20.10.2015 has been fully complied with.
7. Correct.
8. Incorrect. The appellant was provided an opportunity of personal hearing on 20.10.2020 as per judgment of Federal Service Tribunal Islamabad.
9. The appellant along with others approached this honorable Tribunal with un sound grounds.

- A. Incorrect. The appellant was treated in accordance with rules and policy.
- B. Incorrect. As earlier stated that respondents filed CPLA before the honorable Supreme Court of Pakistan against the judgment dated 11.05.2015 of Federal Service Tribunal Islamabad which came up to final adjudication on 20.10.2015 wherein directed the respondents to hold an enquiry as per law and proceed to take appropriate action after issuance notices to the appellants. The question of back benefits of the appellants shall be depended upon the enquiry conducted and the result thereof; hence, appellant was reinstated into his service upon the recommendations of enquiry by the competent authority i.e. Political Agent/Commandant Levy/Khassadar Force.

Till finalization of the inquiry none of them will be entitled for any financial or other benefits including back benefits.



- H. Incorrect. The respondents exercised the discretion fairly and in a structured manner as prescribed by the law/rules.
- I. Incorrect. The appellant was treated as per laid down procedure and law.
- J. Incorrect. The impugned order has been passed according to law.
- K. Incorrect. All the orders passed by the respondents are legal and lawful.

L. Incorrect. The appellant has been dealt in accordance/provision of law/rules.

M. That the respondents also seek leave of this honorable Tribunal to rely on additional grounds at the time of arguments/hearing.

PRAYERS:

Keeping in view the facts and law, It is therefore humbly prayed, that the appeal may kindly be dismissed with costs, please.




