Respected Sir:

1. That in the year 1980, appellant was appointed as Constable and was promoted to the rank of Head Constable in the year 1994. The said process was continued when in the year 2005, he was promoted to the rank of Assistant Sub-Inspector and thereafter to the rank of Sub-Inspector in the year 2009 and further promoted to the rank of Inspector in the year 2013 on officiating basis and confirmed such as in the year 2015. At present he is serving the department as Acting DSP for the last one year.

2. That on 21-04-2008, appellant along with others were confirmed in the rank of ASI and their names were brought on promotion list "E" with effect from 05-04-2008 along with Arab Nawaz Khan, Noor Zaman, Tayub Jan Khan, Fazal Wahid Khan, Izhar Shah, Ayaz Mahmood, Yar Nawaz, Abid-ur-Rehman, Mehr Ali, Hazrat Ullah, etc. (Copy as annex "A")
3. That appellant along with others appeared in final examination of the Upper College Course at Hangu 01-12- 2009 and were declared passed and merit position was assigned against their names. Appellant was assigned merit position at S. No. 02, while Arab Nawaz, Tayub Jan Khan, Yar Nawab, Ayaz Mehmood, Abid ur Rehman, Izhar Shah, Hazrat Ullah, Mehr Ali, Noor Zaman, Fazal Wahid were placed below him. (Copy as annex "B")
4. That on 15-03-2013, seniority list of Inspectors and Sub-Inspectors was circulated wherein the name of appellant was not figured therein without assigning any reason, while the names of Junior Colleagues were figured at S. No. Izhar Shah 173, Abid ur Rehman 174, Arab Nawaz 204, Noor Zaman 252, Hazrat Ullah 253, Tayub Jan 268, Fazal Wahid 269, while Muhammad Yasin Khan at S.No. 204, Bashir Dad at S. No. 259, Fazal Dad at S. No. 317, etc who passed Upper Course in the year 2010 were made seniors. (Copy as annex "C")
5. That on 21-06-2013, appellant was confirmed in the rank of Sub-Inspector on the recommendation of Departmental Selection Committee with immediate effect. The name of appellant was placed at S. No. 05, while the incumbents at S. No. 01 to 04 were placed above the name of appellant who were much juniors. (Copy as annex "D")
6. That Notification dated 08-12-2017 was revised and the confirmation of Fazal Dad was anti-dated with effect from 30-07-2010 instead of 30-09-2012. (Copy as annex "E")
7. That on 30-01-2018, department issued Notification wherein on the recommendation of Departmental Selection Committee, the incumbents mentioned therein were promoted to the rank of DSPs B-17 on regular basis with immediate effect. The incumbent at S. No. 23 Mr. Yar Nawab was colleague of appellant. No reason was assigned to appellant for not promoting him to the said rank, followed by subsequent Notification of 16-05-2019 promotion to the rank of DSP B-17 on regular basis

wherein one Fazal Dad who was junior to appellant was promoted, while appellant was again ignored for no legal reason. (Copy as annex "F")

8. That on 30-04-2020, subsequent Seniority List of DSPs B-17 was circulated wherein one Fazal Dad, who was Junior to appellant was placed at S. No. 114. The name of appellant should have been figured at S. No. 113 above his name. (Copy as annex "G")
9. That on 10-07-2020 another Seniority List of Inspectors / Sub-Inspectors was issued by the department wherein the name of appellant was figured at S. No. 75, while his junior colleagues were brought in the seniority list dated 30-04-2020 as DSPs. (Copy as annex "H")
10. That on 06-01-2021, appellant submitted representation before R. No. 02 to place the name of appellant in the Seniority List dated 30-04-2020 at S. No. 113 above the name of Fazal Dad at S. No. 114 but in vain. (Copy as annex "I")

Hence, this appeal, inter alia on the following grounds:

GROUND S.


1. That from the aforesaid seniority lists, it is crystal clear that appellant was senior than others, yet his colleagues were brought to the rank of Inspectors now to the rank of DSPs, while he is still in rank of Inspector. No reason for doing so was attributed to him is going to be disturbed.
2. That in the final examination of Upper College Course for the year 2009, appellant was assigned merit position at S. No. 02 while other colleagues were placed below him but in the later Seniority List they were placed senior to him for no legal reason.
3. That as and when seniority position is going to change, then the effectee to becomes junior than his colleagues etc, he shall be served with Show Cause Notice by giving reason of the change in seniority position.
4. That while changing seniority position of appellant, now reason was assigned to him for the purpose.

It is, therefore, most humbly prayed that on acceptance of the Appeal, Seniority List dated 30-04-2020 be set aside / modified and name of appellant be placed at S. No. 113 above the name of Fazal Dad with all service benefits.

5. That on 21-06-2013, appellant was confirmed in the rank of Sub-Inspector on the recommendation of Departmental Selection Committee with immediate effect. The name of appellant was placed at S. No. 05, while the incumbents at S. No. 01 to 04 were placed above the name of appellant who were much juniors.

REPLY BY RESPONDENTS NO. 1, & 2.

Respectfully Sheweth:-

PRELIMINARY OBJECTIONS:-

1. That the appeal is badly barred by law & limitation.
2. That the appeal is bad for mis-joinder and non-joinder of necessary and proper parties.
3. That the appellant has not come to Hon'able Tribunal with clean hands.
4. That the appellant has no cause of action and locus standi.
5. That the appellant is estopped by his own conduct to file the instant appeal.
6. That the appellant has concealed the material facts from Honorable Tribunal.
7. That the appeal is not maintainable being devoid of any merit.

REPLY ON FACTS:-

1. Para No.1 relates to record, however the appellant has personally admitted the facts that he was given promotion to the next higher rank on eligibility and own merit. It clearly reflects that no pick and choose formula was followed which speaks of a fair process on the part of respondents.
2. Incorrect. The appellant has personally admitted the facts that he was given promotion/confirmation in list "E" rightly in accordance with law/rules. The appellant after completion of the requisite laid down criteria have been confirmed in the rank of ASI.
3. Incorrect. Para pertains to record, however Seniority in the examination of Upper College Course does not effected in list 'E'".
4. Incorrect. Actually mandatory period for confirmation in the rank of SI was not completed by the appellant. The appellant was also confirmed in the rank of SI after completion of pre requisite criteria. It is worth to mention here that the appellant never challenged order when his colleagues were promoted. The present appeal filed by the appellant is time barred. Therefore he is not entitled to claim his seniority with his colleagues already confirmed due to their completion of pre requisite criteria
5. Incorrect. In fact confirmation in the rank of S.I requires completion of eligibility criteria under 13-10 (2) of PR 1934 amended 2017, which provides that "no sub inspector shall

be confirmed in a substantive vacancy unless he has been tested for at least a year as an officiating S.I in independent Incharge of PS, a notified post, or as in charge investigation of a PS or CTD. As such appellant was also confirmed in the rank of S.I on qualifying the said eligibility criteria. (copy of rule is annexed as "A")


6. Incorrect. Each and every case has separate facts and grounds. In the instant case no irregularity has been occurred.
7. Incorrect. Actually only those colleagues of the appellant are confirmed in the rank of DSP who fulfill the laid down criteria and no one considered without completion of requisite criteria.
8. Incorrect. Seniority list of DSPs was issued per the laid down criteria, hence objection raised by the appellant in the para is not maintainable.
9. Incorrect. As explained in the preceding para that all proceeding regarding issuance of all seniority lists are in accordance with law/rules without any discrimination.
10. Incorrect. Appeal of the appellant was rejected/filed after due consideration by the appellate authority on merit.

REPLY ON GROUNDS:

1. Incorrect. The point raised by the appellant having no legal footage. However it is worth to clarify that promotion and confirmation amongst employees of respondent department have been made in accordance with law/rules and no pick and choose formula is followed. Actually only those colleagues of the appellant were confirmed in the next ranks who fulfill the laid down criteria and no one considered without completion of requisite criteria.
2. Incorrect. No one mandatory course is affected each list relating to seniority of the personnel.
3. Incorrect and denied on the ground that appellant has been treated strictly in accordance with law/rules and no legal right has ever been violated by the respondents.
4. Incorrect. As explained in the above para seniority of the appellant was issued after consultation with the participants of DSC which is in accordance with law/rules.

PRAYERS:-

It is therefore most humbly prayed that in light of above facts and submissions the appeal of the appellant being devoid of merits, legal footing may kindly be dismissed with costs please.



10. In rule 13.10, for sub rule (2) the following shall be substituted namely:

"(2) No Sub-Inspector shall be confirmed in a substantive vacancy unless he has been tested for at least a year as an officiating Sub-Inspector in independent charge of a Police Station, a notified Police Post, or as in-charge Investigation of a Police Station or in Counter Terrorism Department:

Provided further that he shall also have to spend one year in any other Unit excluding the period spent on long leave, deputation or promotional training course i.e. upper college course".

11. After rule 13.16, the following new rule shall be added, namely:

"13.16A. One year mandatory tenure for promotion to Deputy Superintendent of Police.---An Inspector shall be promoted to the post of Deputy Superintendent of Police after successful completion of mandatory training i.e. Advance Course and completion of one year tenure as Inspector in the Investigation Branch, or Counter Terrorism Department, or Special Branch, or any police training institution."

12. After Form No. 13.7, the following new Appendices shall be added, namely:
