The impugned order dated 24.10.2019 passed in pursuance to a formal enquiry in the matter of disciplinary proceedings against the appellant reveals that major penalty of compulsory retirement and in addition recovery of Rs. 4, 64,400/- was imposed upon the appellant. The appellant challenged the said penalty through service appeal stated in the facts at Para-4 of the memorandum of appeal that service appeal No. 1246/2016 of the appellant was finally decided which was also upheld by the august Supreme Court of Pakistan. Through present service appeal the appellant seek relief for correction of his seniority and grant of accruable benefits which he could not get due to disciplinary action by the department. Let notice be given to the respondents for rebuttal of the claim of the appellant, the appeal is admitted for regular hearing subject to all just anmd legal objections. The appellant is directed to deposit security and process fee within 10 days. Thereafter, notices be issued to the respondents for submission of written reply/comments in office within 10 days after receipt of notices, positively. If the written reply/comments are not submitted within the stipulated time, or extension of time is not sought through written application with sufficient cause, the office shall submit the file with a report of non-compliance. 


