memorandum of appeal, are that the appellant is serving as Physical.

THE REAL MAINER

Education Teacher (PET) since 25.08.2014 at GGMS Khuti, D.I.Khan and her services were regularized on 10.03.2018; that on 22.02.2019, the appellant, after getting knowledge that a post of PET is laying vacant at GGMS Wanda Mochianwala, D.I.Khan filed an application for her transfer from GGMS Khutti to GGMS Wanda Mochiyanwala but respondent No.3 did not accept the application of the appellant with the remarks that there is Ban on transfer of teacher and the request of appellant will be entertained after removing of ban; that respondent No.3 went to Saudi Arabia to perform Hajj and respondent No.4 took charge of post of respondent No.3; that respondent No.4 vide impugned order dated 31.07.2019, transferred private respondent No.5 to the post of PET at GGMS Wanda Mochianwala for which the appellant was entitled to be transferred; that feeling aggrieved from the order dated 31.07.2019, the appellant filed writ petitioner No. 830-D/2019 before the Hon'ble Peshawar High Court, D.I.Khan Bench which was converted into departmental appeal and sent the same to the respondent No.4; that the departmental appeal of the appellant was not responded within ninety days, the appellant then filed this appeal in this Tribunal.

02. We have heard learned counsel for the appellant and learned Additional Advocate General for the respondents.

Service Appeal No1171/2020 titled "Kanwal Yasmin-.vs-Government of Khyber Pakhtunkhwa through Secretary Education Department, Khyber Pakhtunkhwa Peshawar and others" decided on 30.09.2022 by Division Bench comprising Kalun Arshad Khan. Chairman, and Salah- Ud-Din, Member Judicial, Khyber Pakhtunkhwa Service Tribunal, Camp Court Dera Ismail Khan.

03. Learned counsel for the appellant argued that impugned transfer order made by respondent No.4 is against the Constitution, law, rules and departmental policy. That according to Khyber Pakhtunkhwa Posting/Transfer Rules, an employee can maximum serve at a station for not more than three years while the appellant has served and is serving the present school for five years. Learned counsel for the appellant further contended that the impugned transfer order is issued by an incompetent authority which is liable to be set aside. He requested that the impugned order is illegal, without jurisdiction may kindly be set aside and the respondents may directed to transfer the appellant against the post of PET in Government Girls Middle School Wandha Mochianwala, D.I.Khan.

04. Learned Additional Advocate General contradicted the arguments of learned counsel for the appellant and raised preliminary objection on maintainability of the service appeal under Section-4 that there is no original or appellate order in the instant appeal. He further contended that the appellant has got no cause of action or locus-standi to file the instant appeal. He requested that the appeal might be dismissed with cost.

05. The appellant feels herself aggrieved of order dated 31.07.2019, whereby private respondent No.5 was transferred from GGHS, Kirri Shamozai D.I.Khan to GGMS Wanda Mochianwala, D.I.Khan. When

confronted with the situation that vide the impugned order, the appellant was not transferred, how, she was aggrieved of the transfer order of somebody else, the learned counsel for the appellant submitted that the appellant had already moved an application for her transfer to the post where private respondent was transferred. The situation is totally incomprehensible as to how the transfer order of somebody else could be assailed by the appellant before this Tribunal as the appellant is having no locus-standi to challenge the transfer order of somebody else nor is she said to be an aggrieved person. The learned counsel for the appellant could not explain the situation. This being so this appeal is groundless and is dismissed. Consign. Cost shall follow the event. Consign.



Respectfully Sheweth;

Petitioner humbly submits and requests as under:-

- That the appellant is permanent resident of Basti ustrana South Tehsil & District Dera Ismail Khan. Copy of CNIC of petitioner is annexed as **Annexure "A"**.
- 2. That the appellant, is serving in the Education Department Dera Ismail Khan as Physical Education Teacher (PET) since 28/05/2014 in GGMS Khuti and service of the appellant was regularized by the competent authority vide order#2463-68 dated 10/03/2018 and till now the appellant is serving in the same school with great zeal and to the entire satisfaction of her high-ups. Copy of order dated 10/03/2018 is annexed as Annexure "B".
- 3. That the appellant has been performing her duties with great zeal and to the entire satisfaction of her high-ups.
- 4. That on 22/02/2019, the appellant, after getting knowledge that a post of PET is laying vacant at GGMS Wanda Mochianwala D.I.Khan, filed an application for her transfer from GGMS Khutti to GGMS Wanda Mochiyanwala because the appellant is resident of Basti Ustrana South and Wanda Mochiyanwala is near to the house of appellant. Copy of application is annexed as **Annexure-C**.
- 5. That the respondent#3 did not accept the application of appellant with the remarks that there is Ban on transfer of teachers and the request of appellant will be entertained after removing of ban. In this respect Zia Ullah Khan Bangash (Ex.Education Advisor to CM KPK) also published news on his social media (facebook) account. Copy of facebook page is annexed as <u>Annexure-D</u>.
- 6. That the respondent#3 has gone to Saudi Arabia to perform Hajj and in her absence the respondent#4 took charge of Action District Education Officer (Female) vide notification No.

2

155-57 dated 29/07/2019 in which the respondent#4 was assigned the duties as mentioned in the above said notification. Copy of the notification dated 29/07/2019 is annexed as **Annexure-E**.

- 7. That the respondent#4, just after taking charge, on 31/07/2019 issued the impugned transfer order#15621-28 vide which she transferred her blue eyed female teacher on their wishes and also filled the post of PET at GGMS Wanda Mochianwala and transferred the private respondent#5 for which the appellant was entitled to be transferred. Copy of the impugned transfer order#15621-28 dated 31/07/2019 is annexed as **Annexure-F**.
- 8. That Feeling aggrieved from the order#15621-28 dated 31/07/2019, the appellant filled a writ petition#830-D/2019 and the honourable Peshawar High Court Bench Dera Ismail Khan was pleased to convert the writ petition of the appellant into departmental appeal and sent the same to the respondent#4. Copy of W.P and order dated 02/10/2019 are jointly annexed herewith as Annexure-G.
- **9.** That up-till now no response has been shown from the respondents and after the laps of statutory limitation of departmental appeal, cause of action has been accrued to the appellant for the instant appeal, Hence the instant service appeal.
- 10. That jurisdiction of this worthy service tribunal is being invoked in attending circumstances against the impugned transfer order#15621-28 dated 31/07/2019, inter alia on the following grounds amongst others;

GROUNDS: -

- A. That the impugned transfer order made by respondent No. 4 is against the Constitution, service laws, rules, departmental policy and natural justice.

A hence liable to be declared as null and void by this Honourable Court.

- C. That the appellant belongs to City Dera Ismail Khan and having a family of two children and also served five years by travelling from City D.I.Khan to GGMS Khuti, the distance of which consists of about 35 Kilometers daily.
- D. That according to Khyber Pakhtunkhwa Posting/transfer Rules, an employee can maximum serve at a station for not more than 3 years while the appellant has served and is serving in the present school for five years.
- E. That if this honourabel Tribunal will peruse the impugned transfer order it will come into the notice that according to the notification dated 29/07/2019, the respondent#4 has only jurisdiction to sign the bills etc but not authorized to appoint or transfer the employees of the Education Department, hence, on this sole ground the impugned transfer order is liable to be set aside.
- F. That the appellant, time and again, requested the respondents and also submitted an application for her transfer but due to the lethargic conduct of the respondents the requests of the appellant are shuffling from desk to desk and grievance of the petitioner has not been redressed as yet.
- G. That the appellant has to travel almost 60 KM daily and the petitioner has also been suffering from severe back pain it is humanly impossible for a woman in the milieu of Pakistani society to look after her family and carry out her professional obligations at the same time under such circumstances.
- H. That counsel for the appellant may please be allowed to raise additional grounds at the time of arguments.

It is therefore respectfully prayed that on acceptance/issuance of instant appeal by declaring the transfer order#15621-28 dated 31/07/2019 issued by the respondent#4 as illegal, without jurisdiction and ineffective over the rights of appellant and the respondents may further be directed to follow the law, rules of the Department regarding the transfer policy and to transfer the appellant against the post of PET in Government Girls Middle School Wandha Mochianwala Dera Ismail Khan.

Any other relief deemed appropriate in the given circumstances may also be granted in the larger, interest of justice.



PRELIMINARY OBJECTIONS:

- 5. That the appellant is stopped by his own unwholesome conduct as Public Servant to file this appeal.

- <u>7.</u> That the appellant has concealed the material facts and ground realities from this Honourable Tribunal.

- 8. That the matter of transfer exclusively comes under the terms and conditions of the Civil Service and that Article 212 of the Constitution of Islamic Republic of Pakistan bars jurisdiction of the Honourable High Court.

Parawise comments on behalf of respondent No.5 are as under:-

PRELIMINARY OBJECTIONS

- a. That appellant has got no cause of action and locus standi in the matter.
- **b.** That the appeal is not competent, as the controversy agitated therein is based on wrong interpretation of laws and rules.
- **c.** That the appeal has not been based on true facts, appeal is barred by law of limitation.
- **d.** That appellant is estopped by his own conduct to file the instant appeal.
- e. That appeal is bad for mis-joinder and non-joinder of parties.

f. That appellant has not approached this august forum with clean hands.

- That the relief claimed by the appellant is against service laws.
- h. That appellant had impugned the transfer order No 15621-28 while on the other hand the appellant only impleaded respondent No. 5 as party, which clearly predicts that the appellant has not approached this august forum with clean hands and appeal is bad for misjoinder and non-joinder of parties.

That appellant transfer posting at the place of her choice,

as of right.

REPLY ON FACTS

1. For Para No 1 burden of proof lies on the appellant.

Para no.2 related to the record needs no reply. However the answering respondent was firstly appointed vide order NO 5029-35 dated 28/05/2014 and was posted at GGMS Panaila. Soon after the arrival at GGMS Panaila, appointment order of the answering respondent was withdrawn. Answering / respondent challenged the order vide writ petition No. 350-D/2014 in Honorable Peshawar High Court Bench DIKhan. Honorable Peshawar High Court Bench DIKhan accepted the writ petition of the answering respondent and directed DEO (female) DIKhan to appoint the answering respondent. Since, then answering respondent was serving the department as PET GGHS Kirri Shamozai with great zeal and zest. Copies annexed.

Para no.3 is also related to the record needs no reply Para no. 4 is incorrect, not admitted. Pertinent to mention here that according to impugned order No.15621-28 many vacant posts in different schools of city i.e GGMS Chah Baraywala, GGMC Chah Hussain, GGHSS. No. 2 DIKhan were laying vacant but appellant claiming a specific school, is against service laws because posting and transfer is not a vested right. Similarly the answering respondent has also been serving the department in a very far flung hard area School i.e GGHS Kirri Shamozai. At the time of appointment the answering respondent was posted at Paniala but after a lengthy period of litigation, when re-instated by the department, was posted aat a very far flung area. Answering respondent is a mother of

disable girl and suffered hardship of several years and had been begging for her posting at DIKhan City, when become vacant. Para no. 5 is incorrect, not admitted. Moreover Para No. 5 is not related to the answering respondent.

Para no.6 related to the record needs no reply.

Para no. 7 is incorrect, not admitted. The para is against the service laws and rules. The appellant is claiming her posting/transfer at the of her choice. Answering respondent soon after re-instatement had been submitting applications to the high ups for her transfer and kept waiting for several years. Answering respondent is mother of a disable girl and she was suffering too much, because she had to take her disable daughter to the far flung school. The appellant on one side had impugned the transfer order wholly but on the other hand only impleaded the answering respondent as private party despite of the fact the other schools are also within the city DIKhan. Hence the appeal of the appellant is bad for mis-joinder and non-joinder of necessary and proper parties.

Para no. 8 relates to the record.

Para no.,9 is incorrect. The appeal of the appellant is badly time barred and is liable to be dismissed. Moreover the appellant has no cause of action to the instant appeal.

10. Para No. 10 is incorrect. Appeal is not maintainable on the given grounds

GROUND-WISE REPLY

A. Incorrect. Transfer order was issued in accordance with the law and rules and the appellant impugning the same transfer order and merely challenging the transfer order to the extent of answering respondent is against law and norms of justice. It is crystal clear

from the impugned transfer order that there are more school where vacant posts of PET are available but the appellant only challenged the transfer of answering respondent because the appellant is desiring her posting/transfer on her own choice. Hence, transfer order is very much according to the law and rules.

B. Incorrect, issuing the transfer order is in accordance with law, rules and within the jurisdiction of the officials and no discrimination or injustice has been done.

C. Incorrect, answering respondent after re-instatement is serving the department and was posted at GGHS Kirri Shamozai, the distance of which is 80 kilometers from the city Dera Ismail Khan and scarcely a public transport is available there. Moreover, answering respondent is also a mother of minor children. One of the daughter of the answering respondent is disable and the respondent had to take her disable daughter with her, on daily basis. Hence, the transfer of the answering respondent is according norms of justice.

- **D.** Incorrect, according to principles set by worthy superior courts "posting/transfer is not a vested right of the civil servant". Hence, appellant being a civil servant is not liable to claim her transfer as her vested rights.
- **E.** Incorrect. The order dated 31/07/2019 was issued by the competent authority.
- **F.** Incorrect, appellant claiming her transfer as her vested right is totally against service laws.
- **G.** In reply of para-G answering respondent stats that the answering respondent is also a mother of children, one

of the daughter of the answering respondent is also disable and the respondent had to take her disable daughter with her on daily basis. It is pertinent to mention that the answering respondent was posted at GGHS Kirri Shamozai, the distance of which is 80 kilometers from the city Dera Ismail Khan. It is the answering respondent who had served the department in above mentioned condition. Similarly answering respondent also had to take care her other children and her house hold activities beside her duty, which was nearly impossible for her to perform her duties as a civil servant and a mother. But the answering respondent stayed concentrated and performed her duties with great zeal and zest as a civil servant and as a mother and kept waiting for her transfer/posting. Appellant has wrongly approached this Worthy Tribunal as the transfer order correctly been issued.

H. The counsel for the answering respondent may also be allowed to raise additional grounds during the arguments.

<u>It is therefore prayed that appeal of the</u> appellant may please be dismissed with cost.



- The petitioner is a permanent resident of D.I.khan and is well educated, skilled, honest and efficient citizen. Copies of the educational documents are annexed as <u>Annexure "A".</u>
- 2. The respondent No.3 (DEO, D.I.Khan) issued advertisement which was published on 1st January, 2014. The petitioner applied for the post of PET BPS-15 mentioned at serial No. 3 of the advertisement. The minimum required qualification for the post of PET was mentioned as BA/B.Sc or equivalent along with 01 year Junior Diploma in Physical Education (hereinafter referred as JDPE). Copy of the advertisement is annexed as Annexure "B".
- 3. That petitioner having Qualification as SSC, HSSC; Graduation, Master in health & Physical education, Senior Diploma in Physical Education (hereinafter BED, referred as S: DPE), applied for the post of PET. The test was conducted by NTS. The petitioner scored good passing marks. Copy of Result slip is annexed as Annexure "C".
- 4. The National testing services declared its result, wherein at serial No. 262 petitioner's name was shown. Consequently vide appointment order No. 5029-35 dated 28.05.2014, petitioner was appointed as PET and posted at GGMS Panaila. Copy of short list and appointment order is enclosed as **Annexure "D & E"**, respectively.
- 5. That soon after petitioner submitted her arrival report and took charge in GGMS Paniala, District D.I.Khan. Copies of arrival report and charge certificate are enclosed as **Annexure "F"**.

- 8. That the present petitioner is left with no option but to invoke the constitutional jurisdiction of this august Court in the matter for the annulment of orders dated 29.05.2014 by respondents No.3, on inter alia, following grounds.

MUHAMMAD AYUB KHAN, J.- Through the instant petition under Article 199 of the Constitution of Islamic Republic of Pakistan, 1973, the petitioner Mst. Maria Hina seeks the following relief:-

> "It is thus humbly prayed that on acceptance of this petition, the impugned order No.5289-95/PET/F dated 29.5.2014 of respondent No.3 be declared as illegal, sans jurisdiction and devoid of lawful authority; and respondents/functionaries, especially respondent No.3 be directed to consider petitioner for appointment against the post of Physical Education Teacher in BPS-15, and petitioner be allowed to continue her services."

2. As per contents of the petition, respondent No.3 advertised certain posts in the year 2014. The petitioner applied for the post of PET BPS-15 for which minimum required qualification was mentioned as BA/B.Sc or equivalent alongwith one year Junior

EXAMINOR Beravar High Court Benco, Dera Ismail Kourt Dera Ismail Kourt DD -11-250 Diploma in Physical Education. The petitioner having qualifications of SSC, HSSC, Graduation, Master in Health & Physical Education, Senior Diploma in Physical Education and B.Ed applied for the post of PET. After conduct of test, the NTS declared result, wherein the petitioner's name appeared at serial No.262 and consequently, she was appointed as PET vide order dated 28.5.2014 and posted at GGMS, Panyala. On the following day i.e. on 29.5.2014, appointment order of the petitioner was cancelled on the ground that eligibility criteria for the post of PET was B.A and JDPE, hence the instant petition.

3. It is the stance of respondent No.4 in her comments that the petitioner lacks the requisite minimum qualification of JDPE for the post of PET and thus she is not entitled to be appointed as PET.

4. We have heard the arguments of learned counsel for the parties and have gone through the available record.

5. This Court time and again held that possessing higher qualification than the required minimum qualification would not be sufficient to deprive a candidate from appointment provided the candidate

6. Admittedly, the petitioner is possessing Senior Diploma in Physical Education (SDPE) alongwith degree of Master in Health & Physical Education which is higher qualification than the Junior Diploma in Physical Education (JDPE), required for appointment to the post of PET and on this ground alone, the petitioner could not be denied appointment. The qualifications mentioned by the petitioner in the petition have not been denied by the respondents in their comments. It is also not denied that the petitioner has not got through the screening test. In such view of the matter, the petitioner was entitled to be appointed as PET.

7. For the reasons mentioned above, we allow the instant petition and direct respondent No.4 to issue

- 01. Their services will be considered as terminated, when the case in CPLA is decided by The August Supreme - Court of Pakistan against them or any major penalty is sentenced by Higher Authorities / The NAB Courts

- 02. Their services will be considered as terminated, if their appointment Orders are decided invalid by the Competent/ Higher Authorities of the Department.
- 03.
