

Appellant alongwith his counsel Mr. Abbas Ali Khan, Advocate present and submitted fresh Wakalatnma on behalf of the appellant. Preliminary arguments heard.

Learned counsel for the appellant at the outset of his arguments, contended that the appellant is basically aggrieved of the impugned order dated 21.10.2021 whereby he was accorded two weeks extra ordinary leave without pay w.e.f 08.10.2021 to 21.10.2021 despite the fact that he had cardiac problem and medical leave was requested for. His departmental appeal requesting for conversion of extra ordinary leave without pay to medical leave submitted on 03.11.2021 was regretted by respondent No.1 vide communication dated 11.11.2021. It was further argued that the appellant has rendered about 26 years regular service in the department and impugned order is neither justify nor sustainable in the eyes of law particularly under revised Leave Rules 1981 .

The appeal is admitted to regular hearing subject to all just legal objections. The appellant is directed to deposit security and process fee within 10 days. Thereafter notices be issued to respondents for submission of reply/comments. To come up for reply/comments on 05.07.2022 before S.B.




