

Learned counsel for the appellant further contended that neither proper inquiry was conducted nor opportunity of personal hearing and defence was provided to the appellant. It was further contended that the appellant was dismissed from service from the date of absence i.e retrospectively therefore, the impugned order is void and limitation does not run against the void order as per judgments of the superior court therefore, is liable to be setaside.
