<u>JUDGMENT</u>

Rozina Rehman, Member(J): Brief facts of the case are that appellant was appointed as Head Constable. He was implicated in a criminal case vide F.I.R No.379 and was arrested. Consequently, he was issued charge sheet and was finally awarded major penalty of dismissal from service. He filed departmental appeal which was also dismissed, hence, the instant service appeal.

2. We have heard Qamar Nadeem Afridi Advocate learned counsel for appellant and Kabir Ullah Khattak, learned Additional



Advocate General for the respondents and have gone through the record and the proceedings of the case in minute particulars.

- 3. Qamar Nadeem Afridi Advocate, learned counsel for appellant submitted that mandatory provisions of law and rules were blatantly violated by the respondents as appellant was not treated according to law. He argued that no proper inquiry was conducted to find out the real facts and that the appellant was not associated with the inquiry proceedings. He contended that he was acquitted of the charges leveled against him vide F.I.R No.379 and that the prosecution itself had submitted an application U/S 494 Cr.PC as there was no probability of the appellant/accused being convicted of any offence. It was lastly submitted that the appellant has more than 11 years of service at his credit, therefore, he may kindly be reinstated with all back benefits.
- 4. Conversely, learned A.A.G submitted that appellant absented himself from duty as he was involved in smuggling of narcotics and was caught red-handed for having 910 gram of Charas. He submitted that acquittal from criminal charges does not exonerate the appellant from departmental proceedings and that he was called in Orderly Room and was heard in person. He was given ample opportunity to defend himself but he failed, therefore, his appeal was also rejected by R.P.O.
- 5. From the record it is evident that Constable Banaras Khan of Shangla District Police was proceeded against departmentally on the allegations of his involvement in case F.I.R No.379 dated 26.10.2019 registered at Police Station Besham U/S-9(b) of C.N.S.A. He was charge sheeted and Naseeb Shah D.S.P Headquarter, Shangla was



nominated as Inquiry Officer. In the meanwhile, Challan in the criminal case was submitted against him in the Court and he was tried. An application U/S-494 Cr.PC was submitted before the learned Magistrate seeking withdrawal from prosecution and vide order dated 11.02.2020 of the learned Sessions Judge/JSC, MCTC Shangla, the present appellant was acquitted from the charges leveled against him. He was dismissed from service vide order dated 10.12.2019 of District Police Officer, Shangla. He filed departmental appeal on 20.12.2019. He was acquitted of the charges leveled against him on 11.02.2020 and despite his acquittal, his departmental appeal was rejected by R.P.O Malakand Region on 20.02.2020.

- 6. It has been held by the Apex Court that all acquittals are certainly honorable. There can be no acquittal, which may be said to be dishonorable. Implication of the appellant in the criminal case of narcotics was the only ground on which he had been dismissed from service and the said ground had subsequently disappeared through his acquittal, making him re-emerge as a fit and proper person entitled to continue with his service.
- 7. It is established from the record that charges of involvement in the criminal case ultimately culminated in honorable acquittal of appellant by the competent Court of Law in the above-mentioned criminal case. In this respect, we have sought guidance from 1988 P.L.C (C.S) 179; 2003 S.C.M.R 215 and P.L.D 2010 Supreme Court 695.



In view of the foregoing, the instant appeal is accepted and the 8. appellant is re-instated in service with all back benefits. Parties are left to bear their own costs. File be consigned to record room.





After hearing the arguments, I have come to the conclusion that although section 25 of Control of Narcotics Substance Act excluded the applicability of section 103 Cr. Prosecution has not been able to establish the most crucial link of the chain of the prosecution's case with regard to safe custody of samples or its safe transmission to the office of Chemical Examiner without the same being tampered with or replaced while in transit. Reliance is placed on case tiled "Ikram Ullah and others ... VS... The State (2015 SCMR 1002).

In view of the above, there is no probability of conviction of the accused, even if further evidence is recorded in the present case. Further proceeding would be mere wastage of precious time of the court and would yield no useful result.



SUBJECT: PARA-WISE COMMENTS BY RESPONDENTS

Respectfully Sheweth:

PRELIMENARY OBJECTIONS:

- 1. That the Honorable Tribunal has no jurisdiction to entertain the appeal as the appellant was not Civil Servant.
- 2. The applicant has got no course of action to file the present appeal.
- 3. The conducts of appellant preclude the appellant to file the present appeal.
- 4. That the appellant has not come to this Honorable Tribunal with clean hands.
- 5. That the appellant has been estopped by his own conduct to file instant appeal.
- 6. That the appeal is bad for misjoinder and non-joinders of necessary parties.
- 7. That the appeal is barred by law & limitations.

OBJECTIONS ON FACTS:

- 1. Incorrect, appellant was appointed as Constable in Police Department on contract basis and was not Civil Servant under the rules.
- 2. Relates to record during employment his performance was not up to the mark, hence no comments.
- 3. Incorrect, The appellant absented himself from duty vide D.D No. 29 dated 23.10.2019, he was involved in smuggling of Narcotics (Chars), On 26.10.2019 at Nakabandi point Sadeen Besham, he was caught red-handed and recovered 910 Gram Chars from his possession, consequently a case vide FIR No. 379 dated 26.10.2020 u/s 9BCNSA was registered against appellant at Police Station Besham. Furthermore, acquittal from criminal charges does not exonerate appellant from departmental proceedings/inquiry (Copy of DD Report and FIR is annex: "A and B").
- 4. That the appellant was called in orderly room on 18.12.2019 heard him in person by the Regional Police Officer, Malakand. He was given ample opportunity to defend himself however, he failed to produce any cogent reason. Therefore, his appeal for re-instatement in service was rejected by the Regional Police Officer Malakand (Copy of the order enclosed as annexure "C").
- Incorrect. Appellant was found involved in case FIR No. 379 u/s 9BCNSA dated 26.10.2019 PS Besham. He was suspended vide OB No. 112 dated 29.10.2019, Served show cause notice No. 5548/E dated 30.10.2019 as per report of OII PS Besham. Respondent No. 1 Charged Sheeted Vide No. 203/E dated 15.11.2019 disciplinary action Vide No. 5945-46/E dated 15.11.2019 for purpose of scrutinizing the conduct of applicant with reference to allegation. Mr. Naseeb Shah the then DSP/Head Quarters Shangla was appointed as inquiry officer to conduct proper departmental enquiry. The inquiry officer recommended the appellant for major punishment, & he was terminated/dismissed from contract service Vide OB No. 133/E dated 10.12.2019, (Copy of Suspend Order/Show cause notice/Reply/Charge Sheet/Enquiry/Dismissal Order are enclosed as annexure "D, E, F, G,H,I,& J").
- 6. That the appellant was called in orderly room on 18.12.2019 in the office of Regional Police Officer Malakand, heard in person and the inquiry conducted by DSP/HQ Shangla was thoroughly perused. The charges leveled against the appellant have been proved

bound to stop/prevent Narcotics from the area, however he himself was involved in Narcotics smuggling. This act of appellant costs bad impact on other Police Officials. Therefore, his re-instatement in police force was detrimental to the interest of Police Department. Therefore, his appeal was rejected on above cogent reasons.

7. The appeal is not maintainable under the law/rules and wrongly challenged the legal and valid orders of respondents through unsound grounds.

ON GROUND

- (A) Incorrect, the Order is based on facts legal and in accordance with law/rules. Therefore, tenable in eye of law.
- **(B)** Incorrect, the applicant has committed moral turpitude offence during official duty. He was terminated/dismissed from after observing all codal formalities under the rules.
- **(C)** Incorrect, Proper Departmental inquiry was initiated against the appellant by giving him right of self defence and personal hearing.
- **(D) Incorrect**, charges leveled against appellant is proved in departmental proceeding and he was found guilty therefore, he was dismissed/terminated from contract service.
- (E) Incorrect, the appellant is retired from Paramilitary Force, being contract employee with KP Police and there is no benefits allowed for contract employees after retirement in Police Department. He can not claim contract service as regular service under the rules/policy.
- (F) That the respondents may also be allowed to agitate any other additional grounds at the time of hearing.

PRAYER:

Keeping in view the above stated facts it is humbly prayed that the service appeal of the appellant being not maintainable under rules may kindly be rejected will costs, please.



ORDER:

This order will dispose off appeal of Ex-Constable Banaras Khan No. 3378 (Ex-Serviceman) of Shangla District for reinstatement in service.

Brief facts of the case are that Ex-serviceman Constable Banaras No. 3378 of Shangla District Police was found involved in case FIR No. 379 dated 26/10/2019 u/s 9B-CNSA Police Station Besham and sent to judicial lockup. He was issued Show Cause Notice No. 5548/E, dated 30/12/2019. But reply to the Show Cause Notice was found unsatisfactory, therefore, proper departmental enquiry was initiated and Charge Sheet No. 203 dated 15/11/2019 coupled with statement of allegation issued to the appellant and DSP Hqrs Shangla appointed as Enquiry Officer. After proper departmental inquiry, the Enquiry Officer recommended the appellant for major punishment. Inquiry file of the appellant and finding report of the Enquiry Officer was perused by DPO Shangla and found purely on merit. Therefore, the DPO Shangla as a competent authority awarded him major punishment of dismissal from service vide OB No. 133 dated 10/12/2019.

He was called in Orderly Room on 18/02/2020 and heard him in person. Enquiry conducted by the DSP Hqrs Shangla was thoroughly perused and found that the charges against the appellant have been proved. Being a Police Officer he was required to prevent crimes rather than to spread evil in the society. His this kind of act has affective the discipline of Police Department. Therefore, his appeal for reinstatement in service is hereby filed.
