**JUDGMENT:**

SALAH-UD-DIN, MEMBER:- Precisely stated the facts as alleged by the appellant in his appeal are that he was appointed as PTC vide order dated 17.04.1994 and performed his duty to the entire satisfaction of his high-ups. Initially, the date of appointment of the appellant was wrongly mentioned as 31.04.1994 in his service book, which was later on corrected as 18.04.1994 after a proper inquiry. Vide Notification dated 12.04.2013 colleagues of the appellant as well as some of his juniors were promoted to the post of SPST (BPS-15), while the appellant was wrongly and illegally



deprived from such promotion. The appellant being aggrieved from the Notification dated 12.04.2013, voiced his grievance before the respondents and in consequence thereof, Notification and corrigendum dated 24.08.2013 was issued, whereby the appellant was promoted to the post of SPST, however his seniority was wrongly ordered to be considered with effect from 17.05.2013. Later on, colleagues as well as juniors of the appellant were promoted to the post of PSHT (BPS-15) vide Notification dated 20.08.2018 but the appellant was ignored. The appellant again approached the respondents for redressal of his grievance and he was thus promoted to the post of PSHT (BPS-15) vide Office Order dated 16.09.2019 but with immediate effect instead of 20.08.2018 i.e the date on which his colleagues were promoted. The seniority of the appellant as SPST was though corrected by giving it effect from 12.04.2013, however his promotion to the post of PSHT (BPS-15) was not given effect from 20.08.2018, constraining the appellant to file departmental appeal, which was not responded within the statutory period of 90 days, hence the instant service appeal.

2. Notices were issued to the respondents, who submitted their comments, wherein they refuted the assertions as raised by the appellant in his appeal.

3. We have heard the arguments of learned counsel for the parties and have perused the record with their valuable assistance.


4. The appellant has filed the instant service appeal seeking prayer to the effect that directions may be issued to the respondents

for correction of impugned office order dated 16.09.2019 regarding promotions to the post of PSHT (BPS-15) by considering the appellant at par with his similarly placed colleagues and giving effect to his promotion as PSHT (BPS-15) from 20.08.2018 with all back benefits. The issue in question was agitated by the appellant through filing of departmental appeal, however the same was not at all responded by the appellate Authority. The controversy in question necessitates that the departmental appeal of the appellant may first be decided by the appellate Authority through a speaking order in accordance with relevant law/rules on the subject.

5. In view of the above, the departmental appeal of the appellant is remitted to the appellate Authority with the directions to decide the same through a speaking order in accordance with law/rules within a period of 30 days of receipt of copy of this judgment. Parties are left to bear their own costs. File be consigned to the record room.

Brief but relevant facts of the case are as follows:

1. That the appellant was initially appointed against the post of erstwhile P.T.C now P.S.T in BPS-07 vide order dated 17-04-1994. (Copy of appointment order and service book is filed herewith and annexed as Annex-A & A/I)
2. That the appellant is performing his duties to the entire satisfaction of his seniors. Earlier the colleagues of the appellant were promoted to the post of S.P.S.T (BPS-14) vide Notification dated 12-04-2013. The perusal of the said Notification would reveal that junior colleagues are promoted, whereas

the appellant was been deprived from promotion. (Copy of Notification dated 12-04-2013 is filed herewith and annexed as **Annex-B**)

3. That feeling aggrieved of the aforesaid Notification, the appellant approached the respondents for redress of his grievance. In pursuance of which the appellant was promoted to the post of S.P.S.T (BPS-14) vide Notification & Corrigendum dated 24-08-2013 but granted seniority w.e.f 17-05-2013. (Copy of Notification dated 24-08-2013 is filed herewith and annexed as **Annex-C**)
4. That later on the colleagues of the appellant were promoted to the post of P.S.H.T (BPS-15) vide Notification dated 20-08-2018. The perusal of the said Notification would reveal that junior colleagues of the appellant are promoted, whereas the appellant has been deprived from promotion. For instance one Mr Nasir Khan who was appointed along with the appellant on the same date vide same appointment order has been promoted to the post of PSHT (BPS-15) vide Notification dated 20-08-2018 (Serial No 48); and one Mr Niaz Muhammad S/o Hazrat Amin who is appointed as PST on 29-05-1994 and is junior than the appellant, has been promoted to the post of PSHT vide aforesaid Notification (Serial No 65). The date of appointments of the aforementioned teachers is mentioned in Seniority List as stood on 22-07-2017. (Copy of Notification dated 20-08-2018, Notification dated 30-07-2019 and Seniority List is filed herewith and annexed as **Annex-D, E & F** respectively)
5. That the appellant approached the respondents for redress of his grievance, in pursuance of which the appellant is promoted to the post of PSHT (BPS-15) vide Office Order dated 16-09-2019 but with immediate effect instead of the date from which his colleagues are promoted i.e., 20-08-2018. It is pertinent to mention here that in the said Office Order, the seniority of the appellant is justified/corrected and has been granted SPST seniority with effect from 12-04-2013 instead of 17-05-2013. (Copy of Office Order is filed herewith and annexed as **Annex-G**)
6. That it is worth mention here that the whole controversy started due to the fact that initially in the service book of the appellant his date of appointment was wrongly mentioned as 31-04-1994 instead of 18-04-1994, which has been later rectified after an inquiry. (Copy of inquiry report is filed herewith and annexed as **Annex-H**)
7. That feeling aggrieved of the aforesaid Office Order, the appellant filed departmental appeal which has not been decided yet, the statutory time has lapsed. (Copy of Departmental Appeal is filed herewith and annexed as **Annex-I**)



Hence the instant service appeal on the following amongst other grounds:

**Grounds:**


- a. That, the impugned Office Order is against the law, illegal, unlawful, without lawful authority, void and ineffective upon the rights of the Appellant, thus calling interference of this Honorable Tribunal.
- b. That the impugned Office Order is in utter disregard of KP Civil Servants Act and KP Civil Servants (Appointment, Promotion and Transfer) Rules, 1989.
- c. That the junior colleagues of the appellant are promoted to the post of PSHT with effect from 20-08-2018, whereas vide impugned Office Order, the appellant is promoted with immediate effect.
- d. That, the Respondents are violating all the basic Fundamental Rights and protections given to the Appellant in the Constitution of Islamic Republic of Pakistan, 1973.
- e. That the impugned seniority list is against the principles of administrative law, based on colorful exercise of powers and against the dictums of the August Supreme Court of Pakistan.
- f. That the Appellant craves permission of this Honorable Tribunal to rely on other grounds at the time of arguments and produce any additional document if required in support of his Service Appeal.

It is, therefore, prayed that on acceptance of this Service Appeal, the impugned Office Order 16-09-2019 to the extent whereby the appellant is promoted to the post of PSHT (BPS-15) with immediate effect be declared as against the law, illegal, unlawful and ineffective upon the rights of the appellant and respondents may kindly be directed to correct the impugned Office Order to the effect that the appellant be treated at par with his similarly placed colleagues and be promoted to the post of PSHT (BPS-15) with effect from 20-08-2018 with all back benefits.

Any other relief which has not been specifically prayed for and deemed fit and appropriate by this Honorable Tribunal in the circumstances may graciously be granted.

In the light of D.E.O.(M) NSR office order No. 12477-79 dated 18-10-2018, the Inquiry committee visited The GPS Marhati Banda NSR to probe into the matter on 24-11-2018. Mr. Habib Ur Rehman PST B-14 was present.

Facts Findining.

Mr. HabibUr Rehman PST, the concern teacher was served a questioner to record his statement. In his statement he writes that he was appointed as PST Teacher vide DEO (M) Primary Nowshera No. 17871-85 dated 17-4-1994 and took over charge of post on 18-04-1994. He submitted copy of his 1st Appointment order and, Medical and charge report as proof. (Anx-A).

He showed us his original service book for verification. At page 04 of his service book, the date of 1st appointment has been entered wrongly as 31-04-1994 which is clearly a clerical mistake as there are only thirty days in the month of April. Later on, It has been corrected as 18-04-1994 and signed/ cutting attested by the then SDEO Nowshera. Proof attached. (Anx-B)

He also writes that in the seniority list prepared by the DEO (M) Nowshera, his date of 1st appointment is wrongly entered. As a result his name dropped to the bottom and many other teachers became senior of him and promoted. He submitted a copy of the seniority list in supports of his statement. (Anx-C)

CONCLUSION

The facts shows that:-


1. All the facts proves that the correct date of taking over charge against the posts is 18-04-1994.
2. Date of 1st appointment written in the seniority list is a clerical mistake. Thus the concern teacher has been deprived from his promotion right.

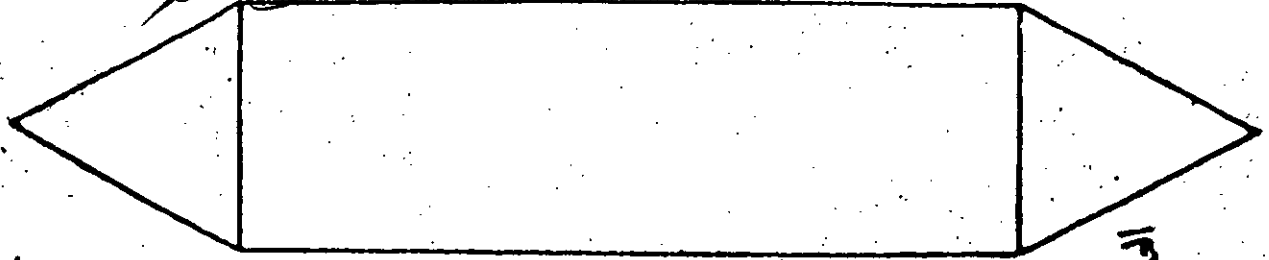


