
Counsel for the appellant present and heard. Contends that the appellant has been removed from service vide the impugned order dated 4.7.2011 received by him in the month of December 2011. While working as Sub Engineer, the appellant applied for extra ordinary leave without pay. He was granted said EOL. The leave was extended from 1.6.2009 to 15.8.2010. In the mean time the appellant got seriously ill and remained on bed. Certain notices were issued but these were never received by the appellant. The appellant was sent to Standing Medical Board for examination on 22.1.2011. Without waiting for report of the Standing Medical Board, absence notice of the appellant was published in newspapers. Without issuing any show cause notice or conducting any inquiry vide the impugned order dated 4.7.2011 the appellant was removed from service, however, the order was not communicated to the appellant. The appellant when attended the office after availing his leave in the month of December, he came to know about the order of his removal from service. The appellant preferred a departmental appeal on 26.12.2011 but with no response. Counsel for the appellant further contended that the appellant has been removed from service without fulfilling the legal requirements. Moreover, the order of removal has been made from retrospective effect which is illegal. The appellant has never committed any act or omission which could be termed as mis-conduct. His illness was not willful but due to his illness. Points raised need consideration. The appeal is admitted to regular hearing subject to all legal objections. The appellant is directed to deposit the security amount and process fee within 10 days. Thereafter, notice be issued to the respondents. Case adjourned to 12.9.2012 for submission of written reply.



Appeal under section 4 of the Service Tribunal Act, 1974 read with section 10 of the Khyber Pakhtunkhwa (then NWFP) Removal from Service (Special Powers) Ordinance, 2000 against the Office order No. 1478-82 dated 4.7.2011 communicated to the appellant in the month of December, 2011 whereby the penalty of Removal from Service has been awarded w.e.f 16.8.2010 against which the departmental appeal dated 26.12.2011 was not responded so far.

Prayer in Appeal:

On acceptance of this appeal the impugned order dated 04.07.2011 may please be set aside and the appellant may be reinstated in service with full back wages and benefit of service.

Respectfully Submitted:

1. That on the recommendation of the Khyber Pakhtunkhwa Public Service Commission the appellant was initially appointed as Sub-Engineer (BPS-11) in the Irrigation Department vide order dated 17-11-2006. (Copy of order dated 17-11-2006 is attached as Annexure A).

2. That ever since his appointment the appellant was performing his duties as assigned to him with full devotion and honesty and there was no complaint whatsoever regarding his performance.
 3. That while working in the said capacity in the year 2008, the appellant applied for extra ordinary leave without pay, the application was accepted and he was granted EOL, the leave was extended from 16-08-2009 to 15-08-2010.
 4. That in the mean time the appellant got seriously ill, he was due to which he was unable to resume his duties as he remained on bed. In the meantime certain notices were issued regarding absence to the appellant however, these were never received to the appellant. (Copies of Medical Certificate and Notices are attached as Annexure B & C).
 5. That it is pertinent to mention that the appellant duly applied for medically leave on 08-01-2011 which was duly forwarded on 12-01-2011 and again on 25.1.2011. (Copies of the applications and forwarding letter are attached as Annexure D & E).
 6. That thereafter, the appellant case was sent to Standing Medical Board for examination on 22-01-2011, thereafter letter dated 31-03-2011 and 28-04-2011 were sent to DG Health regarding decision of the standing Medical Board (Copies of letters dated 22.1.2011, 31.03.2011 & 28.4.2011 are attached as Annexure F, G & H).
 7. That thereafter without waiting for the report of the Medical Board absence notice of the applicant was published in the newspapers. (Copies of the absence notices and advertisement are attached as Annexure I & J).
 8. That without issuing any show cause or conducting any enquiry vide order dated 04-07-2011 the appellant was removed from service, however, the order of removal was not communicated to the applicant. (Copy of the order of Removal is attached as Annexure K)
 9. That since the applicant when attended the office after availing his leave in the month of December, came to know about the order of his dismissal from service.
 10. That soon after the knowledge of his dismissal the applicant filed appeal on 26-12-2011, however it was not respondent till
-

date. (Copy of the departmental appeal is attached as Annexure L).

11. That the Notification whereby the appellant was awarded the major penalty of Removal from service and the rejection order are liable to be set-aside inter alia on the following grounds.

Grounds of Appeal:


- A. That the appellant has not been treated in accordance with law.
- B. That all the proceedings conducted against the appellant were violative of law and against the mandatory provisions of Khyber Pakhtunkhwa (then NWFP) Removal from Service (Special Powers) Ordinance, 2000, the Notification impugned is thus liable to be set at naught.
- C. That no proper procedure as required by the law was followed before removing the applicant from service the no inquiry was conducted, the applicant was not served with any charge sheet or show cause. Hence all the proceeding, are defective in the eye of law and legally no penalty can be imposed on basis of defective proceed.
- D. That no show cause or enquiry was ever served upon the appellant before awarding his penalty of Removal from service.
- E. That the applicant was not provided with opportunity of hearing before awarding him the major penalty of removal from service.
- F. That the order of removal is made from retrospective effect which is illegal.
- G. That the appellant duly applied for medical leave after expiry of EOL his case was forward to Standing Medical Board, the authority should have waited for the decision of Standing Medical Board, however, instead of waiting for the Medical Board, the appellant was illegally removed from service.
- H. That the appellant was never committed any act or omission which could be termed as misconduct his absence was not willful but was due to his illness.

- I. That the appellant has at his credit a long service, serving the department since 1987, the penalty imposed is too harsh and has brushed aside his long service career.
- J. That the appellant never absented himself willfully he has duly applied for leave in time, however was never communicated any letter refusing the leave.
- K. That the appellant is jobless since his illegal removal from service.
- L. That the appellant seeks the permission of this Honourable Tribunal to rely on additional grounds at the hearing of this appeal.

It is therefore prayed that on acceptance of this appeal the impugned **order dated 04.07.2011** may please be set aside and the appellant may be reinstated in service with full back wages and benefit of service



Respectfully Submitted:

1. That the appellant has filed the accompanied service appeal in which no date has been fixed so far.
2. That the appellant prays for the condonation of delay in filling the above noted appeal inter alia on the following grounds: -

Grounds of Application:


- A. That the appellant duly applied for Medical Leave vide application dated 08.01.2011 he was of bonafide belief that his medical leave has been sanctioned. After gaining Health the appellant when went to joined duty the month of December, 2011, he was told that he has been removed from service 04.07.2011. Since the order of removal was never communicated to the appellant in time, therefore, the delay if any is condonable.
- B. That the proceeding conducted against the appellant are illegal, void and nullity in the eyes of law, no inquiry has been conducted nor the appellant has been given any opportunity of hearing, before awarding punishment to the appellant, no notice was served upon the appellant, before awarding him punishment. Even the order of removal is made with retrospective effect which is illegal and nullity in the eye of law. Thus the whole proceedings are nullity in the eye of law and hence no period of limitation run against an order based on illegal / defective proceedings.

- C. That the delay if any was not because of negligence of the appellant but it was due to the reluctant behavior of the respondents that they never communicated the removal order to the appellant.
- D. That the appellant never remained negligent while pursuing his remedy thus the delay if any is condonable.
- E. That valuable rights of the appellant are involved in the case hence this Service Appeal deserves to be decided on merit.
- F. That the delay if any was not willful or contumacious hence deserve leniency.
- G. That it has been the consistent view of the superior courts that causes should be decided on merit rather on technicalities including the limitation. The same is reported in 2004 PLC (CS) 1014 & 2003 PLC (CS) 769.



- (a) appointment of an inquiry officer or an inquiry committee, provided that the inquiry officer or the inquiry committee, as the case may be, shall be of a rank senior to the accused and where two or more accused are proceeded against jointly, the inquiry officer or the convener of the inquiry committee shall be of a rank senior to the senior most accused;
- (b) the grounds for proceeding, clearly specifying the charges along with apportionment of responsibility;
- (c) appointment of the departmental representative by designation; and
- (d) direction to the accused to submit written defense to the inquiry officer or the inquiry committee, as the case may be, within reasonable time which shall not be less than seven days and more than fifteen days of the date of receipt of orders.

(2) The record of the case and the list of witnesses, if any, shall be communicated to the inquiry officer or the inquiry committee, as the case may be, along with the orders of inquiry.

(3) In a case where preliminary or fact finding inquiry was conducted, and the competent authority decides to hold formal inquiry, the inquiry officer or the inquiry committee for the purpose of conducting formal inquiry shall be different from the inquiry officer or the inquiry committee which conducted the preliminary inquiry.
