- 4. That again Appellant was Transferred / adjusted to the post of Key Punch Operator to the Office of SDEO (Female) Town IV Peshawar by Respondent No 2 Vide Order No 3071-75 dated 18-9-2017. (Copy of Transferred Order is attached as Annexure "E").

- 7. That the Appellant submitted applications to Director E & SE, DEO (Male) Peshawar and Accountant General office Peshawar for the release of Salary and cancellation of Transfer order on wrong Cadre but all in Vain.
- 8. That Respondents rejected the Appellant's Appeal and Stopped the Appellant Monthly Salary. Monthly Salary and rejected the Depemental Representation Vide order no 1347dated 29/05/2018. Therefore the Appellant has no other option open to the Appellant but to file this appeal before this Honorable Service Tribunal for the redressal of Appellant's Grievances on the following grounds

GROUNDS:

A. That the impugned order of Respondents for changing the Cadre without the sanction of Finance Department and stoppage of monthly

- salary is Un lawful, arbitrary, void, illegal, Malafide and as such without law full authority.
- B. That the Appellant was appointed by Respondents No 2 as ADEO (P & D) in the Office Executive District Education Officer (Male) Peshawar. But Later on illegally the Appellant was transferred from his original Cadre to other Cadre which is not allowed in the eye of law. More Over Respondent No 3 was not competent authority to change the cadre of the Appellant.
- C. That the Monthly salary is stopped by Respondent No 1 is based on Malafide and against natural Justice.
- D. That the Appellant is entitled for monthly salary and the Appellant's original cadre cannot be changed to other Cadre without mutual understanding and Approval of Finance department which is mandatory.





PRELIMINARY OBJECTIONS.

- 1. That the Appellant has got no cause of action / locus standi.
- 2. That the Appellant concealed material facts from this Hon, ble tribunal.
- 3. That the Appellant has not come to this Hon, ble tribunal with clean hands.
- 4. That the Appellant is not entitled for the relief he has claimed.
- 5. That the Appellant is stopped by his own conduct.
- 6. That the instant Appeal is based on malafide intention.

ON FACTS.

- 1. That Para No.1 pertains to record.
- 2. That in Reply to Para No.2, It is submitted that the transfer order of the Appellant is according to Law and Transfer Rules. Moreover transfer of the Civil Servant was made in the best interest of Civil Servant and transfer is not a punishment but it is a part of service, while rest of the Para is incorrect, misleading and against the facts hence denied.
- 3. That Reply to Para No.3, It is submitted that the post of the Appellant is provincial cadre, to avoid to serve in a far flung area the Respondent Department adjusted the Appellant on the KPO (BPs-16) post on his verbal request.

- 8. Para No.8 is incorrect, misleading and against the facts. The Appellant has no cause of action to file the instant Appeal.

GROUNDS

- A. That Ground –A is incorrect and misleading. The Cadre of the Appellant has not been changed and he has only been posted against the newly created IT post by competent authority in public interest.
- B. That in reply to Ground-B, The Appellant served the post of ADEO (P&D) since 2011 and then he was transferred in best interest of public however to avoid to serve in a far-flung area, the Appellant was adjusted in the office of District Education Officer Female Peshawar in his own verbal request in BPs-16. Furthermore his Cadre has not been changed.

- That in reply to Ground C, It is submitted that The Respondents have already submitted the salary bills of the Appellant in the office of Respondent No.1.
- D. That Ground D has been replied in the above Para's the Cadre of the Appellant has not been changed.
- E. Ground E is incorrect, misleading and against the facts. The detail reply has been given in the Para's above furthermore there is no malafidy on the part of the Respondents.
- F. That Ground F is incorrect and against the facts the detail reply has been given in the above Para's.
- G. That the Respondents also seek leave to provide additional documents at the time of arguments.

It is therefore most humbly prayed before this Honorable court that on acceptance of this Para wise comments the Appeal in hand may kindly be dismissed in favour of Respondents.
