Learned counsel for the appellant argued that vide impugned order dated 23.08.2017, he was transferred/adjusted against the post of computer operator (BPS-16) in utter violation of rules. This order was issued by incompetent authority. Subsequently, vide order dated 20.12.2017 the appellant was posted as ADEO(F) Primary Peshawar but this order was withdrawn on 03.01.2018. Feeling aggrieved he filed departmental appeal on 27.03.2018. His departmental appeal was rejected on 29.05.2018, hence, the instant service appeal. Departmental representation preferred by the appellant against order dated 23.08.2017 was time barred. Time and again learned counsel for the appellant when confronted on the point of limitation was unable to give any convincing reply. No application for condonation of delay has been submitted.

Points urged need consideration. Admit, subject to limitation. Appellant is directed to deposit of security and process fee within 10 days, thereafter, notices be issued to the respondents for written reply/comments for 16.08.2018 before S.B.



Order No 1058-60 dated 03/01/2018 where in Respondent No 2 has with drawn the correct order of correct Cadre of Appellant Vide Order No 4618-19/A dated 20/12/2017. The Departmental Representation dated 27/3/2018 submitted to Respondents No2 was rejected Vide Order No 1347 dated 29/5/2018 hence this appeal.

Prayer:

On acceptance of this appeal order dated 23/8/2017 and order dated 3/1/2018 stoppage of salary as well as rejecting Departmental Representation may kindly be set aside and order dated 20/12/2017 bearing Endst No 4618-19/A-17/ADEO/A&DEO .F Transfer Proposal July 2016 of the competent Authority (Director Elementary & Secondary Education Khyber Pakhtun Khawa Peshawar may kindly be restored.

Respectfully Sheweth:

The Appellant most respectfully submits as under:

1. That the Appellant joined the Education Department as ADEO Management Cadre in BPS-16 through Public Service Commission on 5-5-2011 vide order Endst No 584-83/File No I/Ado (M)/MC Dated 5/5/2011.

(Copy of Order is attached as Annexure "A").

2. That the Appellant was adjusted in July 2013 as ADEO (P & D) in the Office of DEO (Female) Peshawar and in May 2014 the Appellant was transferred to the Office of DEO (Male) Peshawar as ADEO (P & D). With Malafide intention.

(Copies of orders are attached as Annexure "B" & "C" respectively).

3. That Respondent No 5 has Transfer the Appellant to the post of Key Punch Operator (KPO) to the Office of SDEO (Male) Town I Peshawar Vide order No 1209-12 dated 23/8/2017. **(Copy of order is attached as Annexure "D")**

4. That again Appellant was Transferred / adjusted to the post of Key Punch Operator to the Office of SDEO (Female) Town IV Peshawar by Respondent No 2 Vide Order No 3071-75 dated 18-9-2017. **(Copy of Transferred Order is attached as Annexure "E").**

5. That again Appellant was Transferred / Adjusted to the Post of ADEO Establishment Secondary by Director E & SE Vide order No 4618-19 dated 20/12/2017 but this order was cancelled vide order No 1058-60 dated 03/01/2018. **(Copies of orders are attached as Annexure "F" & "G").**

6. That Currently the Appellant is working on the post of Key Punch Operator at SDEO Town IV (Female) Peshawar, but the Accountant General Office does not release the Salary of the Appellant and returned the bill with the observation of wrong Cadre as KPO Key Punch operator instead of original Cadre ADEO (P & D). This added fuel to the fire and thus the Appellant and his Family have been forced to starvation and also disconnected of Medical treatment.
7. That the Appellant submitted applications to Director E & SE, DEO (Male) Peshawar and Accountant General office Peshawar for the release of Salary and cancellation of Transfer order on wrong Cadre but all in Vain.
8. That Respondents rejected the Appellant's Appeal and Stopped the Appellant Monthly Salary. Monthly Salary and rejected the Depemental Representation Vide order no 1347dated 29/05/2018. Therefore the Appellant has no other option open to the Appellant but to file this appeal before this Honorable Service Tribunal for the redressal of Appellant's Grievances on the following grounds

GROUND S:

- A. That the impugned order of Respondents for changing the Cadre without the sanction of Finance Department and stoppage of monthly

salary is Un lawful, arbitrary, void, illegal, Malafide and as such without law full authority.

- B. That the Appellant was appointed by Respondents No 2 as ADEO (P & D) in the Office Executive District Education Officer (Male) Peshawar. But Later on illegally the Appellant was transferred from his original Cadre to other Cadre which is not allowed in the eye of law. More Over Respondent No 3 was not competent authority to change the cadre of the Appellant.
- C. That the Monthly salary is stopped by Respondent No 1 is based on Malafide and against natural Justice.
- D. That the Appellant is entitled for monthly salary and the Appellant's original cadre cannot be changed to other Cadre without mutual understanding and Approval of Finance department which is mandatory.
- E. That the Departmental appeal of the Appellant has been rejected by the Respondents, which represents Malafide intention on the part of the Respondents. **(Copies of appeals and rejection of appeal are attached as Annexure "H" & "I" respectively).**
- F. That under the circumstance as mention above the Impugned order of stoppage of the monthly salary and posting on wrong Cadre is liable to be set-aside.

G. That the Appellant also rely on additional grounds after filling the written statement by Respondents.

It is, therefore, most humbly prayed that on acceptance of this appeal, the impugned order of stoppage of monthly salary and posting on wrong Cadre of Appellant may kindly be set-aside and the Appellant may please be allowed to draw monthly salary on his original Cadre post and this appeal may very kindly be accepted in favour of the Appellant against the Respondents-with cost.

GROUND




- C. That in reply to Ground C, It is submitted that The Respondents have already submitted the salary bills of the Appellant in the office of Respondent No.1.

- G. That the Respondents also seek leave to provide additional documents at the time of arguments.


