

2. AND WHEREAS the Competent Authority (Chief Minister Khyber Pakhtunkhwa) had imposed major penalty of "Reduction to a lower pay Scale" upon Mr. Noorani Shah, Ex- SDEO (BS-17) District Lakki Marwat (Teaching cadre) now Headmaster (BS-17) GHS Baist Khel Lakki Marwat vide this Department Notification No. SO(SM) E&SED/4-17/2012/Noor Hassan & Others dated 26.12.2013.

3. AND WHEREAS he filed a Service Appeal before the Khyber Pakhtunkhwa Service Tribunal against the said penalty. The Service Tribunal vide its judgment dated 21.01.2021, set aside the impugned order dated 26.12.2013 and the appeal was accepted with all consequential benefits.

AND WHEREAS he filed an Execution Petition No. 980/2021 in Service Appeal No. 689/2014 before the Khyber Pakhtunkhwa Service Tribunal and this Department filed CPLA in the Supreme Court of Pakistan against the said Judgment of the Service Tribunal which, was dismissed by the Apex Court vide judgment dated 07.12.2021 in Civil Petition No.187-P/2021.

The petitioner served the respondents department w.e.f 02.11.2009 till 11.10.2011 as Sub Divisional Education Officer (SDEO) Lakki Marwat and during the said period, recruitment of some teachers were made by the Departmental Selection Committee headed by District Coordination Officer, Lakki Marwat.
2. That some irregularities were detected in the recruitment process and the appellant, despite being not a member of Departmental Selection Committee, was awarded a major penalty of reduction to a lower pay scale. The service appeal no. 689/2014 against impugned order was filed in the Service Tribunal; impugned order was set aside and

appellant was restored to his original pay scale through order dated 21st January, 2021 (Annexure-A).

3. The respondents were made fully aware of consequences in defiance of the order, yet they openly flouted and are reluctant to implement the order dated 21.01.2021 in its letter and spirit, hence the instant execution petition.

It is, therefore, most humbly prayed that on acceptance of this execution petition, the order dated 21st January, 2021 passed by this hon'ble Service Tribunal may kindly be implemented in its letter and spirit to bring the justice to its ultimate end.

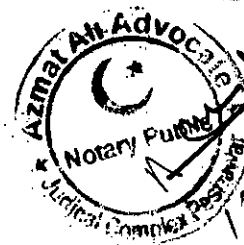

JUDGEMENT: -

Mr. ATIQU UR REHMAN WAZIR: - Brief facts of the case are that the appellant served with the respondent's w.e.f. 02-11-2009 until 11-10-2011 as Sub Divisional Education Officer (SDEO) Lakki Marwat; that some recruitment of teachers were made by the Departmental Selection Committee headed by District Coordination Officer Lakki Marwat and after due process, appointment/placement orders of the teachers were issued by Executive District Officer Education, which finally reached office of the appellant for release of salaries. The appellant processed their case for release of salaries and which ultimately were released to the teachers. During the course, some irregularities were noticed in the recruitment process, against which a preliminary inquiry was conducted against chairperson and members of the departmental selection committee and held

them responsible for irregularities. The appellant though not member of the recruitment committee, but was held responsible for release of salaries to such appointees. Charge sheet/statement of allegation to this effect duly served upon the appellant, followed by show cause notice, which resulted into imposition of major penalty of reduction to a lower pay scale. Feeling aggrieved, the appellant filed departmental appeal, which was not responded to within the statutory period, hence the instant service appeal with prayers that the impugned order dated 26-12-2013 may be set at naught and status of appellant may be restored to his original position.

02. Written reply/comments were submitted by respondents.

03. Arguments heard and record perused.


04. Learned counsel for the appellant contended that departmental selection committee headed by DCO Lakki Marwat with other members in the committee had undertaken a recruitment process after proper advertisement in the newspapers and selected some applicants, whose notification and subsequent placement orders were issued by EDO (Education) Lakki Marwat. The selected teachers reported their arrivals in their respective schools of postings and gone through the procedure of medical fitness as well as other necessary formalities. Learned counsel for the appellant contended that head masters of the respective schools submitted proforma(s) for activation of their salaries. Learned counsel for the appellant explained that not finding any illegality in their documents submitted so far, the appellant was duty bound to forward the names of such employees for monthly payments, which was done accordingly. Learned counsel for the appellant argued that the appellant was neither member of the said recruitment committee nor having any association with such recruitments, which is evident from the fact that the preliminary inquiry conducted was directed against the recruitment committee for procedural irregularities committed in the recruitment process, but the appellant was also tangled for release of salaries to

such appointees. Learned counsel for the appellant further argued that the main culprits who selected and appointed teachers and who were held directly responsible for the act were ignored, which is discriminatory but the appellant was penalized for release of salaries to those who were genuinely appointed through a departmental selection committee and who are still serving. Learned counsel for the appellant referred to one of such employee namely Sher Daraz who was granted relief in release of salaries by this Tribunal vide judgment in Service Appeal No. 18/214. Learned counsel for the appellant further added that Sher Daraz is still serving inspite of the fact that he was also amongst those, who were allegedly irregularly appointed. Learned counsel for the appellant presented record of such employees who are still in service as well as promoted to the next grade. Learned counsel for the appellant contended that the inquiry conducted was replete with deficiencies as written reply was sought in the shape of questionnaire, thus a mandatory provision of a regular inquiry in this factual controversy was never satisfied. Learned counsel for the appellant further pointed out that neither any pro and contra evidence was ever recorded to prove the vague charges, nor any personal hearing before competent authority was ever afforded. Learned counsel for the appellant contended that the appellant was never provided with a copy of the so-called inquiry and hence violated Section 14(4) (c) of E&D Rules, 2011. Learned counsel for the appellant explained that the impugned order is not a speaking order, as it does not divulge the nature and amount of negligence especially when the appellant was never assigned any role in the impugned selections. Learned counsel for the appellant further explained that the penalty of reduction to lower pay scale was imposed upon the appellant with no mention of any date/time period. Learned counsel for the appellant prayed that the impugned order dated 26-12-2013 may be set aside and status of the appellant may be restored to his original position as was before the impugned order without any condition.



05. Learned Assistant Advocate General appeared on behalf of official respondents contended that the appellant has been found guilty by the inquiry officer in the preliminary inquiry, thereafter he was proceeded against under Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011 with formal inquiry conducted to this effect. Learned Assistant Advocate General contended that charge sheet/statement of allegations as well as Show Cause Notice duly served upon the appellant, to which he responded. Learned Assistant Advocate General further contended that every opportunity of defense was afforded to the appellant including personal hearing and he was rightly penalized for the irregularities he committed. Learned Assistant Advocate General pointed out that the appellant being drawing & disbursing officer was responsible for release of salaries to the teachers, who were recruited unlawfully by the recruitment committee. The learned Assistant Advocate General added that the instant case being devoid of merit may be dismissed.

06. We have heard learned counsel for the parties and perused the record. To address the basic question as to what was the role of the appellant in the recruitment process was of prime importance. It however was noted that the appellant being not member of such committee, nor having any role in selection process was penalized for release of salaries during status quo granted by a Court, but no such status quo was presented before this court. Record reveals that departmental selection committee selected teachers, whose appointment order and subsequent placement in their respective schools were issued by the concerned executive district officer. Such employees started their duty in their concerned schools and headmasters of such schools submitted their proforma for activation of their salaries to the office of the appellant, who naturally was duty bound to further submit such documents to Account office for activation of their salaries. It was astonishing to note that such employees are still working against their respective positions, but the appellant is still in the lower pay scale in spite of lapse of seven years. It was also observed that one of such employees



namely Sher Daraz was granted relief in release of salaries by this Tribunal, who is still serving and whose name was also available in the list of employees allegedly irregularly appointed. Record is silent as to what happened to other co-accused including DCO Lakki Marwat and others, who were held responsible for irregular appointments, but the case of appellant in hand suggests that the appellant was wrongly implicated in recruitment case, who was neither competent to made such appointments nor having any role in the recruitment process. Needless to mention that the inquiry conducted is also replete with deficiencies as one questionnaire devised for all accused including the appellant and written reply was sought, main questions of which however pertained to other co-accused and not to the appellant. In the nutshell, it can be construed that the appellant was not afforded proper opportunity of defense; rather the inquiry officer only fulfilled codal formalities and ignored merit of the case.

07. In view of the situation, the impugned order dated 26-12-2013 is set aside and the appeal is accepted as prayed for with all consequential benefits. No orders as to costs. File be consigned to record room.

SUMMARY FOR CHIEF MINISTER

SUBJECT: - IMPLEMENTATION OF THE JUDGMENT OF THE HON'BLE SUPREME COURT OF PAKISTAN DATED 17.12.2021.

44. The Chief Minister being the Competent Authority, had imposed major penalty of "**Reduction to a lower pay scale**" upon Mr. Noorani Shah Ex-SDEO BS-17 (Teaching Cadre) District Lakki Marwat vide Notification dated 26.12.2013 (**Annex-I**). He filed Service Appeal No. 689/2014 in the Khyber Pakhtunkhwa Service Tribunal against the said Notification. The Service Tribunal in its judgment dated 21.01.2021, accepted the appeal as under:- (**Annex-II**).

"The impugned order dated 26-12-2013 is set aside and the appeal is accepted as prayed for with all consequential benefits."

45. Mr. Noorani Shah Ex-SDEO BS-17 (Teaching Cadre) District Lakki Marwat filed Execution Petition No 980/2021 in Service Appeal No689/2014, before the Service Tribunal against the said Judgment. The Service Tribunal in its Judgment dated 05.01.2022 (**Annex-III**) directed that:-

"Let the other benefits of promotion deferred vide minutes of the meeting of PSB held on 29.06.2016 is required to be restored due to soon reaching retirement of the petitioner on Superannuation. The respondent are directed to place the case of petitioner before PSB in the forthcoming meeting for consideration of the promotion of the petitioner from the date when his promotion was deferred obviously subject to the decision of CPLA."

46. This Department filed CPLA in the Supreme Court of Pakistan against the said Judgment of the Service Tribunal (**Annex-IV**) but the same was dismissed vide judgment dated 07.12.2021 in Civil Petition No.187-P/2021, which was received by this Department on 16-02-2022 (**Annex-V**).

47. In order to implement the Judgment of the Supreme Court of Pakistan dated 07.12.2021, this Department proposes to withdraw the penalty of "**Reduction to a lower pay scale**" imposed upon Mr. Noorani Shah Headmaster BS-17/Ex-SDEO District Lakki Marwat w.e.f 26.12.2013.

48. The Chief Minister/Competent Authority, under Section-4 (1) (a) of the Khyber Pakhtunkhwa Govt. Servants (Appointment, Promotion & Transfer) Rules 1989 is requested to approve the proposal contained in Para-47 of the Summary, please.



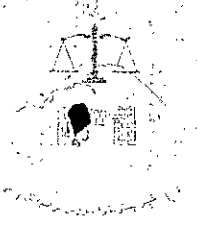


