
APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 AGAINST THE IMPUGNED FINAL SENIORITY LIST DATED 02.03.2018 OF ACTING/AD-HOC CHARGE AND OFFICIATING ASSISTANT SUB INSPECTORS AND HEAD CONSTABLES ON LIST D AS IT STOOD ON 31.12.2017 AND THEREBY THE IMPUGNED ORDER NO.7154/ES DATED 23.12.2019 PASSED BY RESPONDENT NO.2 IN THE DEPARTMENTAL APPEAL OF TEH APPELLANT VIDE WHICH THE OFFICIAL RESPONDENTS CHANGED/ALTERED THE SENIORITY POSITION OF THE APPELLANT IN THE IMPUGNED SENIORITY LIST WITHOUT ANY LEGAL JUSTIFICATION.

JUDGMENT

KALIM ARSHAD KHAN CHAIRMAN: According to the appeal, the appellant was appointed as Constable in 1991 in D.I.Khan Police; that he was promoted to the rank of Head Constable in 1999 and his name was on the seniority list (18.03.2018) of Head Constables; that on a complaint of the superior; the appellant was demoted and he filed service appeal before this Tribunal, which was allowed vide order dated 25.01.2016; that the appellant got knowledge of the wrong entry in the seniority list (D) of Head Constables prepared by respondent No.2 on 02.03.2018 in which his name was shown at No.171 instead of 70 without any reason; that the appellant filed departmental appeal on 12.03.2019, which was rejected vide impugned order No.7154 dated 23.12.2019 and communicated to the appellant on 15.01.2020, hence, this appeal on the grounds enumerated in the memo and grounds of appeal.

2. On receipt of the appeal and its admission to full hearing, the respondents were summoned, who on putting appearance contested the appeal by filing written reply raising therein numerous legal and factual objections. The defence setup was a total denial of the claim of the appellant.


3. We have heard learned counsel for the appellant and learned Additional Advocate General for the respondents.

4. The learned counsel for the appellant reiterated the facts and grounds detailed in the memo and grounds of the appeal while the learned AAG controverted the same by supporting the impugned order(s).

5. It is undisputed that on completion of three years demotion period, the appellant was restored to his original position of Head constable and once the appellant's original position as Head constable stood restored this meant that his punishment period came to an end and thus he ought to have been placed in the seniority list at his due place, which has admittedly not been done by the department on restoration of the appellant to his original position. When confronted with the situation the learned Additional Advocate General and the representative of the respondents did not controvert the situation rather submitted that they wished to place before the Tribunal the latest Seniority List and hopefully the grievance of the appellant might have been redressed in the latest list. The respondents produced provisional seniority list of Officiating Sub Inspectors and Head Constables on List 'D' as it stood on 31.12.2021 signed on 28.04.2022. The learned AAG and the representative of the respondents stated at the Bar that the appellant had not been assigned his correct seniority in the above list. Admittedly, on restoration of the appellant to his original post of Head constable, his seniority was not restored, therefore, on allowing this appeal we direct that the appellant's name be entered in the seniority list at his due place.







KALIM ARSHAD KHAN CHAIRMAN: According to the appeal, the appellant was appointed as Constable in 1991 in D.I.Khan Police;

the same was granted to the other colleagues and junior colleagues of the appellant with all back benefits.

23. Notices were issued to the respondents, who submitted their comments.

24. Mr. Nisar Muhammad Khattak, Advocate representing the appellants in the instant appeal as well as connected service appeals bearing No. 13582/2020 and service appeal bearing No. 13583/2020 has contended that the impugned notification dated 30-06-2020 and appellate order dated 07-10-2020 are against law, facts, norms of natural justice and material on record, hence not tenable in the eye of law and liable to be modified/rectified to the extent of promotion of the appellants to the post of SPP(BPS-19) on acting charge basis; that the appellant has not been treated in accordance with law and rules on the subject and as such the respondents violated Article-4 and 25 of the Constitution; that there are some prosecutors in the impugned seniority list, who were recruited in BPS-16 as APPs and have been promoted by the respondents by extending them benefits of up-gradation twice i.e firstly when they were working as APPs in BPS-16 and their post was up-graded to BPS-17 and again the said post was up-graded to BPS-18, but it seems that the benefit of up-gradation are not being given to the appellants which is discriminatory; that at the time of up-gradation of APP to BPS-17, there was no concept of APP in BPS-17 in the relevant rules, but without considering prosecution rules or any other technicality, said APPs enjoyed BPS-17, just after two years service in BPS-16 because of up-gradation and subsequent promotion to BPS-18 paved their way to BPS-19 vide impugned notification, but quite astonishingly, the services of appellants in BPS-18 as Dy.PP was not being considered for promotion; that the post of Dy.PP was up-graded by the orders of honorable High Court and the benefit of same was also extended to the Prosecutors, who are senior to appellant in their promotion case because the period after the up-gradation of post of Dy.PP was considered in their promotion to BPS-19, though they were neither selected directly in BPS-18 nor they have been promoted to BPS-18; that the appellants were initially appointed in BPS-17 and the post was up-



Peshawar and twenty six others" as well as service appeal bearing No. 16099/2020 titled Bibi Sumaira Vs The Government of Khyber Pakhtunkhwa Through Chief Secretary, Khyber Pakhtunkhwa, Peshawar and Twenty six others", as common question of law and facts are involved therein.

02. Brief facts of the case are that the appellants joined prosecution department on 24-05-2016 as Deputy Public Prosecutor (Dy.PP) BPS 17. During the period, the post of Assistant Public Prosecutor (APP) (BPS-16) was up-graded to BPS 17 by the respondents on the direction of honorable Peshawar High Court, but the post of Dy.PP was not up-graded, hence both the cadres started working in BPS 17. Feeling aggrieved, the Dy.PPs filed writ petition No. 110-P/2015 for up-gradation of the post of Dy.PP to BPS-18, which was allowed vide judgment dated 07-06-2016 and to this effect, up-gradation order was issued vide order dated 02-07-2017 with immediate effect, which was challenged in COC No. 08-P/2020 and it was clearly directed by the Honorable Peshawar High Court that post of Dy.PP shall be considered as up-graded from the date of judgment i.e. 07-06-2016, which was notified accordingly by the respondents from the date of judgment, hence the total service of the appellants comes to 13 days only in PBS-17 and the chapter of BPS-17 was closed after its up-gradation to BPS-18. The provincial government vide notification dated 30-06-2020 made certain promotions to the posts of Senior Public Prosecutors (BS-19) on acting charge basis, which was impugned by the appellants on the grounds that the private respondents No. 5 to 27 so promoted, were junior to them, hence they preferred departmental appeal dated 06-07-2020, which was dismissed vide order dated 07-10-2020. The appellants filed the instant service appeal with prayer that the impugned notification dated 30-06-2020 may be modified/rectified to the extent of 23 juniors of the appellants being illegal and unjustified and the appellants may be considered for promotion to the post of (SPP) (BPS-19) on acting charge basis with effect from 30-06-2020 i.e. from the date when







That the appellant after his promotion performing his duty as Head Constable in different Police Station of District Dera Ismail Khan but unfortunately on wrong and malafide complaint of the superior the appellant was demoted from his service to the post of Constable without adopting any coda/formalities, hence being aggrieved from the demotion order the appellant preferred a service appeal in this Honourable Tribunal which was very graciously be allowed Vide order dated: 25-01-2016. Attested copy of appeal along with order dated: 25-01-2016 are enclosed as **Annexure: B.**
 3. That the appellant got knowledge about the wrong entry into the seniority list of Head Constables list D in the Seniority list prepared by respondent No. 2 on 02-03-2018 in which the name of appellant was marked/ present/ shown at serial No. 171 instead of serial No. 70 which is totally unjustified and without any lawful authority is pertinent to mention here that in the Colum of impugned seniority list remarks shown as "assigned revised seniority vide DPO D.I. Khan order No. 881/86/EC Dated: 29-03-2016". Copy of the impugned Seniority list is herby enclosed as **Annexure: C.**
 4. That the appellant being dissatisfied from the impugned seniority list preferred departmental appeal under the law to the competent authority i.e. respondent No. 3 trough an appeal. Copy of appeal dated: 12-03-2019 is enclosed herewith as **Annexure: D.**
 5. That on 23-12-2019 the appeal of the appellant was rejected by the competent authority vide impugned order No. 7154 dated: 23-12-2019 which was communicated to the appellant on 15-01-2020. Copy of the order dated: 23-12-2019 is enclosed as **Annexure: E.**

Sheer

6. That being aggrieved from impugned seniority list dated: 02-03-2018 and order dated: 23-12-2019 the appellant is having no other remedy but to knock the doors of this Honorable Tribunal by invoking the jurisdiction under section 4 of Khyber Pakhtunkhwa Service Tribunal Act 1974, inter alia, on the following grounds,

GROUND:

- a) That the impugned office order dated: 23/12/2019 along with final seniority list dated: 02/03/2018 passed by the respondents is illegal, unjustified, without lawful authority and against the settled laws of the land, hence, and liable to be set aside.
- b) That the appellant had been serving the department since long and the name of appellant was illegally removed from the seniority by interpreting the judgment of this Honourable Tribunal with malafide intention and just to deprived the appellant from his due right of promotion.
- c) That the official respondents are bent upon to promote their blue eyed cherish persons despite the fact that the appellant has a superior rights over the junior employees and in this respect documentary proof is also available in favor of the appellant against the junior employees. Copy of order dated: 08-03-2019 is enclosed herewith as ready reference vide which the Junior Head Constables was promoted by the respondent No. 2 by ignoring the seniority of appellant which is illegal act, hence liable to be rectified under the law.
- d) That it is settled law of the land the seniority position of any employee cannot be changed/ altered by wrong interpreting the judgment of court/ tribunal but in the case of appellant the respondent violated the law, hence the appellant is entitled to be placed in the seniority list on his original position i.e. at serial No. 70.
- e) That is admitted law seniority will be counted from the date of promotion but in the case of appellant the respondent without

The

any lawful authority changed the seniority position of the appellant from the seniority list which is alien to law.

- f) That the counsel for the appellant may graciously be allowed to raise additional grounds at the time of arguments.

ON ACCEPTANCE OF INSTANT APPEAL, THE IMPUGNED SENIORITY LIST DATED: 02-03-2018 AND OFFICE ORDER DATED 23/12/2019 ISSUED BY RESPONDENT NO.2 MAY PLEASE BE REVERSED AND SET-ASIDE AND DECLARE AGAINST THE SETTLED LAW, SERVICE LAWS AND REGULATIONS IN THE BEST INTEREST OF JUSTICE AND THE SENIORITY POSITION OF THE APPELLANT MAY PLEASE BE RESTORED ACCORDING TO THE FINAL SENIORITY LIST DATED: 18/03/2016 & WITH ALL BACK BENEFITS IN THE BEST INTEREST OF JUSTICE AND EQUITY.

PRELIMINARY OBJECTIONS

1. That the appellant has got no cause of action.
2. That the appeal is bad for misjoinder/non-joinder of necessary parties.
3. That the appeal is badly barred by law & limitation.
4. That the appellant has not come to the Honourable Tribunal with clean hands.
5. That the appellant is estopped due to his own conduct.
6. That the appellant has concealed the material facts from the Honourable Tribunal.

BRIEF FACTS


1. Correct to the extent that the appellant was employee of Respondent department but during service his performance was not satisfactory. List of bad entries enclosed as "A".
2. Incorrect. He was awarded major punishment of reduction in rank of Post Constable vide order bearing OB No. 753 dated 16.04.2012 after proper departmental enquiry, wherein all codal formalities were fulfilled under the rules.
3. Incorrect. The punishment was upheld by the Honourable Service Tribunal and only period of 03 years was specified. Therefore on completion of 03 years he was restored to the rank of HC name brought List "D". Copy enclosed as "B"
4. Pertains to record. Need no comments.
5. Correct to the extent of rejection of departmental appeal filed by RPO DIKhan on the grounds that seniority was revised on light of judgment dated 25.01.2016 KP Service Tribunal Copy enclosed as "C".
6. The appellant has got no cause of action. The Honourable Service Tribunal has not aside the major punishment of reduction in rank but only specified the period for 03 years, therefore, the instant appeal is meritless and not maintainable.


GROUNDS


- a) Incorrect. The orders of Respondents are based on facts, legal and in accordance with law/rules.
- b) Incorrect. The Honourable Tribunal has not set-aside the order of punishment but only special period of 03 years as per FR-29 has been included which has been implemented in true spirit without any malafide intention.
- c) Incorrect. As stated above the Respondents have awarded due seniority to appellant without any favouritism or ill intention.
- d) Incorrect. As explain in preceding Para. The judgment of honourable tribunal is a true interpretation of issue and applied to all.
- e) Incorrect. The appellant was awarded major punishment of reduction in rank from HC to Constable which was upheld by the Honourable Service Tribunal with inclusion of period of 03 years as per FR-29. Major Punishment is a factor for supeceding and losing the seniorities with colleagues.
- f) The Respondents also seeks permission to produce additional documents at the time of arguments.

PRAYER

In view of above, it is humbly prayed that on acceptance of these Parawise Comments the instant appeal being meritless and time barred may kindly be dismissed with cost please.
