## Prayer in Appeal:

That on acceptance of this appeal, the official respondents /competent authority may kindly be directed to consider the appellant for promotion for the post of Lead Fire Rescuer BPS-12 to the post of Station Coordinator BPS-14, from the date when his juniors i.e. responetns No 5 have been promoted with all other service benefits. Any other remedy/relief available in the circumstances of the case may also kindly be granted to the appellant.

## Respectfully Sheweth:-

1. That being senior to respondents No 5 to 10 the name of the appellant was kept at Serial No 4 and on the promotion of the incumbents at Serial No 1 to 3 his name comes to Serial



No 1 of the seniority list, while the names of the respondents No 5 to 10 are appearing at Serial No 5 to 10 and after the promotion of the incumbents at Serial No 1 to 3 their numbers come to Serial No 2 to 7. (The Seniority list upto 31/12/2017 and the promotion order of incumbents No 1 to 3 dated 15/02/2019 are annexure "C" & "D").

- 2. That recently the department has promoted the respondents No 5 to 10 vide order dated 16/08/2019 (Annexure "B" above) and has ignore the appellant inspite of the fact that the appellant is senior most and the respondents No 5 to 10 are junior to the appellant as evident from the seniority list. (Annexure "C" above).
- 3. That the appellant filed a departmental appeal on 02/09/2019, which is still pending before respondent No 1 and after laps of the statutory period no order/communication whatsoever has been made on the same, so far, hence this appeal on the following grounds:-

#### Grounds:-

4\_

A. That the act and omission of the respondents is illegal, unconstitutional, against the fact and materials on the record, therefore, needs the interference of this Honoruable Tribunal.

- B. That the impugned act and omission of the official respondents are not only factually incorrect and legally untenable, but also is based on the malafide intention of the respondents and is also against the well established principles of natural justice.
- C. That the appellant is/was well qualified, fit and also senior most according to the seniority list (Annexure "C" above) and thus was quite eligible for promotion at the time of promotion of his juniors i.e. respondents No 5 to 10, therefore, non consideration of the appellant for promotion is beyond human understanding and is also not acceptable to the human mind, so on this score also the impugned act and omission of the respondents is not maintainable and need the interference of this Honoruable Tribunal.
- D. That the appellant is/was the Govt:/Civil Servant and legal and constitutional guarantee is/was availed to him to be dealt within accordance with law and to be treated equally, he however, has not been treated as such.
- E. That at the time of promotion of his juniors i.e. respondents

  No 5 to 10 the long service period and senior status of the
  appellant has been ignored due to which the appellant has
  not only sustain loss to his seniority but has also been



deprived of his legal right of pay and other benefits to the higher post/scale.

- F. That the act and omission of the respdoneths is also against the laws/rules/policies and the judgment passed by the Higher/Superior Courts and Tribunals.
- G. That the appellant has served the department for so much long time without giving any chance of complaint to his superiors, which fact also goes in favour of the appellant, entitling him for promotion from the date when his juniors have been promoted.
- H. That in the matter of promotion the appellant has been discriminated as his juniors have been promoted and he has been ignored for promotion.
- I. That other grounds not specifically mentioned in this appeal, may also kindly be allowed at the time of arguments.

It is, therefore, humbly prayed that on acceptance of this appeal the official respondents /competent authority may kindly be directed to consider the appellant for promotion from the post of Lead Fire Rescuer BPS-12 to the post of Station Coordinator BPS-14, from the date

### On Facts:-

- 1) Para No 1 of the instant appeal is totally is incorrect and the seniority list annexed by the appellant in the instant appeal is concocted, fabricated and forget one, hence denied the same. It is further stated that the appellant has been inducted in the said department on 16/11/2011, while the private respondents i.e. respondents No 5 to 10 have been inducted in the said department on 15/03/2010 so the respondents No 5 to 10 are apparently senior to the present appellant. (Copy of seniority list is attached as annexure "A").
- 2) Para No 2 of the instant appeal to the extent of promotion of respondents No 5 to 10 are correct while the rest of the Para is based upon presumptions and assumptions and also against the real facts, hence denied. Furthermore, the promotion of the respondents No 5 to 10 are accordingly to law relevant on the subject and the respondent No 5 to 10 were much seniors on the said list, similarly they have been promoted accordingly.
- 3) Para No 3 of the appeal pertains to record. The appeal is liable to be dismissed on the following grounds inter alia:-

### Grounds:-

- A. Ground A of the instant appeal is incorrect and unlawful, hence denied. Furthermore no illegality or irregularity has been committed by the answering respondents while promoting the respondent No 5 to 10.
- B. Ground B is incorrect, denied. Furthermore no malafide is there on the part of answering respondents and the respondent No 5 to 10 have been promoted according to prevailing law and established principles of natural justice.
- C. Ground C is incorrect against the law and facts, hence denied. The answering respondent has promoted those who were senior on the seniority list, rest the detail reply is available in replies to the facts and grounds mentioned above.
- D. Ground D is incorrect, hence denied. It is pertinent to mentioned here that the appellant is a Govt servant, but not a civil servant. It is again stated that only the civil servant can approach this Honourable Tribunal. Further stated that the answering respdonetns are treating all their employees equally.

E. Ground E is totally incorrect, hence denied. The respondent No 5 to 10 are much senior than the appellant as the respondent No 5 to 10 have inducted in the said department on 15/03/2010 while the appellant has been inducted on 16/11/2011. This is very much clear that nothing is against the law in respect of promotion of the respondents No 5 to 10. Loss of payment and other benefits to the appellant is out of question, keeping in view the facts and law on the subject.

F. Ground F is incorrect, hence denied. The said promotion is according to law/rules/policy and according to the judgments of the superior courts and tribunals.



- 3. Para No:3 of the appeal is incorrect. The appellant has mislead the department and stated wrong date of appointment in departmental appeal and concealed the actual facts, which means that the appellant has not come to this Hon'ble Court with clean hands.

#### **GROUNDS:**

- A. Para A of the grounds needs no reply, hence denied.
- B. That official respondents have promoted the respondents according to law and rules, thus Para B is incorrect, hence denied.
- C. Para C is incorrect, hence denied. Detailed reply has been given in preceding paras.
- D. Para D is incorrect, hence denied.
- E. Para E is incorrect, false and frivolous, the respondents are most senior to the appellant.
- F. Para F is incorrect, hypocratic and false, hence denied. Moreover, the act of the respondents is totally in accordance with law.
- G. Para G is incorrect, hence denied. It is not relevant to present respondent.

- H.Para H is incorrect. The respondents are most senior to the appellant, detailed reply has already been given in the preceding paras.
- I. Para I is incorrect, hence denied.

It is therefore, humbly prayed that on acceptance of instant written reply, the appeal of the appellant may graciously be dismissed with heavy cost.
