Learned counsel for the appellant contended that the appellant is aggrieved of impugned order dated 13.02.2017 whereby the total absence/out of service period of the appellant was treated/counted without pay and the reinstatement of appellant in service, in pursuance of judgement of Service Tribunal dated 06.10.2016, was confirmed. Feeling aggrieved with the said original impugned order, the appellant preferred departmental appeal on 10.08.2019 which was regretted on 14.10.2019. The appellant submitted revision petition on 19.10.2019 which was also filed being badly time barred vide order dated 12.07.2020. However, the same is claimed to have been communicated to the appellant on 12.06.2021, hence, the instant service appeal submitted in Service Tribunal on 30.06.2021. The question of limitation does arise because the original impugned order dated 13.02.2017 was challenged through departmental appeal dated 10.08.2019 i.e after two years and six months and as such the departmental appeal being time barred the subsequent Service appeal in Service Tribunal will also stand time barred. Moreover, there is no application for condonation submitted with the memorandum of appeal. Let pre-admission notice be issued to the respondents for reply/comments. Adjourned. To come up for preliminary hearing before the S.B on 08.12.2021.


