The appellant (SPST) has filed the present service appeal against the order dated 29.10.2019 whereby the departmental appeal of the appellant against the revised/updated seniority list of PSTs/SPSTs was rejected. Appellant argued that in the revised seniority list of PSTs/SPSTs his seniority position has been dropped to seniority No.2346 whereas his correct seniority position is 2188. Further contended that in the original seniority list, seniority was given to the appellant on the basis of age and not on the basis of merit/score.

In view of submissions made by the appellant, the present service appeal is admitted for regular hearing subject to all just legal objections. The appellant is directed to deposit security and process fee within 10 days. Thereafter notices be issued to the respondents for reply/comments. 


