






Counsel for the appellant present. Preliminary arguments heard.

The appellant seek determination of seniority from the date of his appointment i.e. 16.10.2004 instead of 01.01.2005. Obviously, the preparation of seniority list and its circulation is the requirement of law relating to terms and conditions of service. More-so, there is a particular procedure for raising objections on the seniority list if circulated and communicated as per requirement of the law. Accordingly, the question is involved whether the impugned seniority list was prepared and circulated in accordance with law and if so whether any objection was filed by the appellant in due course of time? The second question arises that if the impugned seniority list was not circulated and communicated as per requirements of law whether the appellant can be prevented to challenge the same at a belated stage? For want of determination of those questions, this appeal is admitted to regular hearing. The appellant is directed to deposit security and process fee within 10 days. Thereafter, notices be issued to the respondents for submission of written reply/comments in office within 10 days of the receipt of notices positively. If the written reply/comments are not submitted within the stipulated time, the office is directed to submit the file with a report of non-compliance. File to come up for arguments on 09.11.2021 before the D.B.


