That the appellant was initially enlisted as Constable in the Police Department on 04.04.2011 and has at his credit a bright and spot less service career.

It is pertinent to mention here that ever since his enlistment the appellant has performed his duties as assigned to him with zeal and devotion and to the entire satisfaction of his superiors and there was no complaint whatsoever regarding his performance.

That the appellant while performing his duties in the Police Station Mattani, the wife of the appellant was become seriously sick and was admitted in the hospital as there was no one for the take care of her at hospital and later on at home except appellant, the condition of the wife of the appellant was become worse and a dead child was born.

That astonishingly the appellant was informed that he was dismissed from his service on the ground of absentee vide impugned office order dated 31.03.2021. (Copy of the impugned office order dated 31.03.2021 is attached as annexure A).

That being aggrieved from the impugned order dated 31.03.2021, the appellant has submitted his departmental appeal before the competent authority which was rejected vide office order dated 09.09.2021. (Copy of the departmental appeal and rejection order are attached as annexure B & C).

That thereafter the appellant submitted revision petitioner before the competent authority under Rule 11-A of the Khyber Pakhtunkhwa Police Rules 1973 (amended 2014), which was also rejected vide office order dated 02.06.2022. That the impugned orders are illegal, unlawful, without lawful authority, against the law and facts, hence liable to be set aside on the following grounds;

That the wife of the appellant was become seriously sick and was admitted in the hospital as there was no one for the take care of her at hospital and at home except appellant, the condition of the wife of the appellant was become worse and c dead child was born.

D. That according to the section 9 of the E & D Rules the competent authority shall published a notice in at least two leading newspapers directing to resume duty within fifteen days of the publication of the that notice, but in the case of the appellant there was no publication in the newspapers it is also pertinent to mentioned here that in case of absentee there will be removal from service.

That the absence of the appellant from his duties is due to the above mentioned reason not otherwise, therefore the award of major penalty Dismissal From Service is too harsh.

- That the appellant has not been allowed opportunity of personal hearing before awarding him the major punishment of Dismissal from service, thus he has been condemned unheard.
- G. That the appellant never committed any act or omission which could be termed as misconduct, he has been illegally awarded the major penalty of dismissal from service.

That "- appellant has at his credit bright and spotless service career of more than 11 years, the penalty imposed upon him is too harsh and liable to be set aside.

I. That the appellant is jobless since his illegal dismissal from service.





#### **Respectfully Sheweth:-**

#### **PRELIMINARY OBJECTIONS:-**

- 1. That the appeal is badly barred by law & limitation.
- 2. That the appeal is bad for mis-joinder and non-joinder of necessary parties.
- 3. That the appellant has not come to Hon'ble Tribunal with clean hands.
- 4. That the appellant has no cause of action and locus standi to file instant appeal.
- 5. That the appellant is estopped by his own conduct to file the instant appeal.
- 6. That the appellant has concealed the material facts from this Hon'ble Tribunal.
- 7. That the appeal is not maintainable being devoid of any merit.

#### **<u>REPLY ON FACTS:-</u>**

- 1. Pertains to record, however the performance of appellant during service was not upto the mark.
- Incorrect. The appellant has not a clean service record and earned 15 bad entries in his credit i.e 08 Minor and 02 Major punishments on different occasions during his service. (Copy of list as annexure A)
- 3. Incorrect. In fact the appellant while posted at Police Station Mattani, Peshawar willfully absented himself from his lawful duty w.e.from 29.09.2020 to 31.03.2021 (total 06 months and 02 days) without taking any Leave/Permission. In this regard, he was issued Charge Sheet and Statement of Allegations. SDPO Badhaber conducted the enquiry into the charges. After completion of the enquiry proceedings, the appellant was issued final show cause notice, but he failed to receive in spite of repeated summons. The appellant was summoned and also contacted on his cell phone No.03115877878 with the direction to appear before the enquiry officer, but the appellant did not bothered to attend the enquiry proceedings. The enquiry officers has finalized the enquiry and submitted his findings, wherein the allegations of wilful absence were proved against him. After the receipt of the findings, Final Show Cause Notice was issued to him, but he deliberately avoided to appear and defend himself. After observing all codal formalities, he was awarded major punishment of dismissal from service. (Copy of charge sheet, statement of allegations, enquiry report, Final Show Cause Notice are annexure as B,C,D,E)

- 4. Incorrect. The competent authority before imposing the Major penalty had completed all codal formalities by issuance summons/parwana time and again also contacted on his cell phone No.03115877878, but appellant being dis interested in his official duty remained constantly absented for long period without any leave/permission, hence he was awarded Major punishment of dismissal from service.
- 5. Incorrect. The appellant has preferred time barred departmental appeal, which was properly processed and also heard him in person by the appellate authority, however he failed to defend himself with plausible/justifiable grounds, meanwhile department has send his blood sample for screening test to KMC, Peshawar as well, wherein it was revealed that appellant has positive for tetrahydro cannabinol (THC) hence appeal of the appellant was rejected/ filed having no legal footage and time barred.(copy of report is annexure as "F")
- 6. Incorrect. The appellant has preferred revision petition before the appellate authority,\* which after due consideration was also filed/rejected on the same grounds.
- 7. Incorrect. Orders passed by the competent authority are legal and lawful hence is liable to be maintained. Moreover, appeal of the appellant being devoid of merits and limitation may be dismissed on the following grounds.

#### **REPLY ON GROUNDS:-**

- A. Incorrect. The appellant was treated as per law/rules and no violation of his right has been done by the respondent department.
- B. Incorrect. Charge sheet with statement of allegations was issued to the appellant. Regular inquiry was conducted and thereafter he was issued a final show cause notice, by given him proper opportunity of personal hearing, but he was failed to defend himself, hence after fulfilling all the codal formalities he was awarded the Major punishment of dismissal from service under Police Rules 1975 (amended 2014).
- C. Incorrect. The appellant has deliberately absented himself from his lawful duty for such long period, and took the plea that his wife was ill but failed to produce any relevant documents of her illness. The appellant is drug addict and deliberately absented from his lawful duty without leave /permission.
- D. Incorrect. The appellant being member of a disciplined force was proceeded against departmentally under rules ibid. After fulfillment of all codal formalities he was awarded Major punishment on the charges of his long absence period which is not tolerable in the disciplined force.
- E. Incorrect. The appellant was willfully absented from his lawful duty without taking any leave/ permission from his Superior Officers.
- F. Incorrect. The competent authority before imposing the Major punishment had completed all codal formalities and an ample opportunity of self defense was provided to the appellant, but he failed to defend himself.

- G. Incorrect. Being a member of a disciplined force, the appellant was well aware about the proceedings and its consequences. However he was deliberately absented from his lawful duty without leave /permission. Therefore, the punishment orders were passed by competent authority and Appellate authority on the charges of his long absence period which is not tolerable in the disciplined force.
- H. Incorrect. The appellant is a habitual absentee. He earned 15 bad entries, 08 minor punishments and 02 Major punishments on the ground of his willful absence. In fact the appellant is not interested in his official duty, hence was rightly be awarded the Major punishment of dismissal from service under rules ibid.
- I. Incorrect. The appellant himself is responsible for the situation by remained constantly absented from duty for long period without any leave/permission, hence the punishment orders were passed.
- J. Respondents also seek permission of this Hon'ble Tribunal to raise additional grounds . at the time of arguments.

#### PRAYERS:-

It is therefore most humbly prayed that in light of above facts and submissions, the appeal of the appellant being devoid of merits, limitation and legal footing, may kindly be dismissed with cost please.
