

Learned counsel for the appellant contended that the appellant is aggrieved of impugned order dated 08.11.2020 whereby the appellant has been discharged from service under Rule-12.21 of Police Rules 1934. His departmental appeal dated nil was entertained and he was reinstated in service for the purpose of de-novo enquiry, vide order dated 18.12.2020. However, after submission of the de-novo enquiry report, he was again discharged for his deliberate and intentional absence of 9 months and 11 days vide order dated 10.02.2021. His departmental appeal was also rejected on 12.07.2021, hence, the service appeal in hand was submitted in Service Tribunal on 03.08.2021. Moreover, the penalty of discharge from service is very harsh and passed in violation of law and rules and as such is not sustainable and liable to be set aside. The appellant has not been treated according to law and rules and condemned unheard. Let pre-admission notice be issued to the respondents for reply/comments. Adjourned. To come up for preliminary hearing before the S.B on 22.12.2021.




