Mr. Adnan Aman, Advocate, for the appellant present. Preliminary arguments heard.

Learned counsel for the appellant has argued that the appellant was properly inducted in Khasadar Force vide order dated 16.12.2009, where-after he performing his duty regularly. He further contended that after the merger of FATA into Khyber Pakhtunkhwa Province, the Khyber Pakhtunkhwa Khasadar Force Act, 2019 was promulgated, whereby Khasadars were to be absorbed in the Khyber Pakhtunkhwa Police Force. He next contended that the appellant was legally entitled to be absorbed in the Khyber Pakhtunkhwa Police Force, however upon the recommendation of Malik Abdul Majeed, the name of respondent No. 5 was forwarded for absorption, which is against law and norms of natural justice. He further contended that the departmental appeal was filed but the appellate Authority did not pay any heed to the grievance of the appellant within the statutory period, therefore, the appellant filed the instant service appeal for redressal of his grievance.

Points raised need consideration, hence the appeal is admitted to regular hearing subject to all legal and valid objections. The appellant is directed to deposit security and process fee within 10 days, where-after notices be issued to the respondents for submission of written reply/comments in office within 10 days after receipt of notices, positively. If the written reply/comments are not submitted within the stipulated time, the office shall submit the file with a report of non-compliance. File to come up for arguments before the D.B on 11.01.2022.

The appeal is also accompanied by an application for restraining the respondents not to absorb the services of respondent No. 5 into Khyber Pakhtunkhwa Police Force till the final decision of instant appeal. Notice of the application also issued to the respondents for the date fixed.
