Needless to say that the appellant has challenged the order of his dismissal from service after an unreasonable long time but the said order on its face is deficient to disclose the reference of any particular disciplinary provisions having been invoked for issuing of the impugned order. Keeping the question of limitation intact for disposal during regular hearing, this appeal is admitted mainly for the reason that the impugned order has been passed to dismiss the appellant on the ground of willful absence which penalty on its face seems not come within the ambit of respective provisions of disciplinary rules dealing with the willful absence. Let the respondents be heard, this appeal is admitted for full hearing, subject to all just and legal objections. The appellant is directed to deposit security and process fee within 10 days. Thereafter, notices be issued to the respondents for submission of written reply/comments in office within 10 days after receipt of notices, positively.
