The substance of what has been contended at the bar by learned counsel representing appellant is that on successive promotion from PTC Teacher he rose to the post of Subject Specialist (BPS-17), he was charged In FIR bearing No. 178 dated 14.09.2017 under sections 377, 354, 352, 500, 507 PPC at P.S Ghazi Haripur however, he was acquitted of the charge. On charges of sexual abuse and acquiescing cheating one Mst. Zahida Parveen, a subject specialist, was charges sheeted. The same charges were leveled against appellant. An inquiry was conducted vide which the aforesaid lady teacher and one Mst. Yasmeen Habib were found guilty however, separate proceedings were initiated against appellant by the inquiry committee which is in contravention of the established norms as the conclusion has been drawn without putting under examination the testimony of any witness nor opportunity of cross examination was afforded and he was removed from service by virtue of order dated 15.01.2020 whereas minor penalty of censure was awarded to Mst. Zahida Parveen which is discriminatory and in derogation of Article 27 of the Constitution of Islamic Republic of Pakistan, 1973. Departmental appeal was moved but it did not met the fate of success hence, the present service appeal.

The point so agitated at the bar needs consideration. The appeal is admitted for regular hearing subject to all just legal objections. The appellant is directed to deposit security and process fee within 10 days, thereafter, notices be issued to the respondents for written reply/comments for 21.04.2021 before S.B.
