

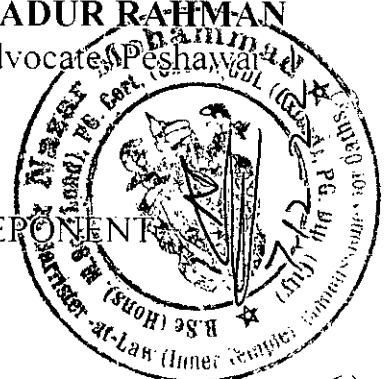

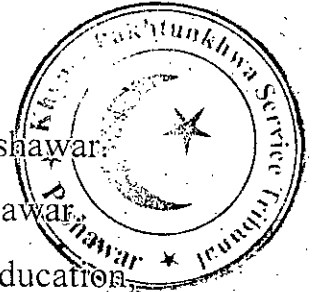

That since the appointment, the appellant performed his duties with full dedication, zeal & zest and to the entire satisfaction of his superiors.

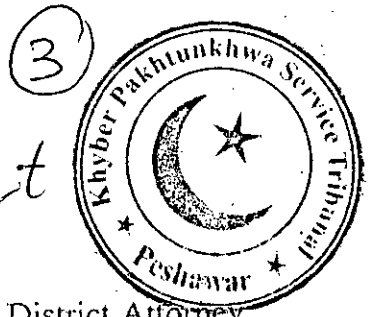





