

APPEAL UNDER SEC- 4 OF KHYBER PAKHTUNKHWA SERVICE TRIBUNALS ACT, 1974 AGAINST THE ORDER DATED 27.11.2017 WHEREBY THE APPELLANT WAS PROMOTED TO INSPECTOR BS-15 WITH IMMEDIATE EFFECT AND NOT FROM THE DATE VACANCIES WERE VACANT AND AGAINST THE REJECTION ORDER DATED 15.1.2018.

PRAYER:

THAT ON ACCEPTANCE OF THIS APPEAL, THE ORDER DATED 27.11.2017 MAY BE MODIFIED AND RESPONDENTS MAY BE DIRECTED TO CONSIDER THE APPELLANT FOR ANTI-DATE PROMOTION FROM THE DATE THE APPELLANT WAS ELIGIBLE AND VACANCIES WERE AVAILABLE WITH ALL BACKS AND CONSEQUENTIAL BENEFITS. ANY OTHER REMEDY WHICH THIS AUGUST TRIBUNAL DEEMS FIT AND PROPER THAT MAY ALSO BE GRANTED IN FAVOUR OF THE APPELLANT.

RESPECTFULLY SHEWETH:

FACTS:

- 1. That the appellant joined the Excise and Taxation Narcotics Control Department in the year 1994 as Junior clerk and has good service record throughout his career with 23 years unblemished service.
- 2. That the undersigned was appointed/promoted as Sub-Inspector (BPS-09) on acting charge basis being eligible against vacant post vide order dated 16.08.2012. Copy of order is attached as Annexure-A).
- 3. That the appellant serving as SI (BPS-9) on acting charge basis since 2012, about 5 years, but despite that the appellant was promoted as SI

- (BPS-9) as regular on 09.2.2017 with immediate effect. Copy of order is attached as Annexure-B.
- 4. That the appellant aggrieved from the order dated 09.02.2017 file appeal for antedation of promotion and termination of probation period on which the department makes correspondence and declare that the appellant already completed his 5 year service against his respective post and also eligibles for promotion to the post of inspector. Copy of letter and rules is attached as Annexure-C & D.
- 5. That the department delayed the case of promotion of the appellant without any reason and well know about that the initial recruiters were coming to join the department, thus the initial recruiters from S.no 89 to 95 in seniority list were join the department as inspector on respective dated mentioned in the seniority list. The vacancies of inspector were laying vacant which is evident from the letter dated 19.10.2017 and 25.05.2017, the appellant also file applications from time to time for promotion but quite astonishingly matter was delayed and the appellant was promoted as Inspector (BS-15) vide order dated 27.11.2017 with immediate effect not from the date vacancies was available and appellant was eligible, which really damage the seniority of the appellant. Copy of seniority list, letters, applications and promotion order is attached as Annexure-E, F, G & H.
 - 6. That the appellant aggrieved from the said order file departmental appeal for anti-date promotion but the same was rejected vide order dated 15.1.2018 in fanciful manner only touching one aspect of the case . *Copy of departmental appeal and rejection order is attached as Annexure-I & J.
 - 7. That now the appellant comes to this august Tribunal on the following grounds amongst the others.

GROUNDS:

- A) That the impugned order dated 27.11.2017 is against the law, rules and material on record, therefore liable to be modified and undersigned may be promoted as Inspector from the date appellant was eligible and vacancies were available.
- B) That the appellant was promoted to post of Inspector on dated 27.11.2017 with immediate effect and according to Superiors Courts judgment that if post is available then civil servant should be promoted on regular base from the date vacancies were available.

- C) That the appellant was eligible for promotion as Inspector, but the appellant's promotion was delayed to the post of Inspector and was promoted on 27.11.2017 after the initial recruiters, Which damages the service of the appellant, due to which the appellant's further promotion was also effected, which shows the laziness on the part of the department.
 - D) That Valuable rights of the appellant have been affected by not granting him, his due promotion from the date of his actual entitlement.
 - E) That the appellant was ignored and deprived from the date when the eligible and entitle for promotion and in illegal manner. Which is such action is part of respondent department is not sustainable in eyes of law.
 - F) That the post of Inspector (BPS-15) was available since long and the appellant was also eligible for promotion but he has been deprived from his right of promotion as Inspector (BPS-15) in time, which means that delay was caused by the department for which the appellant should not be punished for the faults of others.
 - G) That it is well settled principle of justice that no one should be suffered from the arbitrary acts of public functionaries and the public functionaries are required to act in accordance with rules and law with fair means. But in case of appellant such principle has been violated.
 - H) That order dated 27.11.2017 and not taking action on the departmental appeal of the appellant within statutory period of 90 days is against the law, fact, norm of justice and material on record.
 - I) That the Supreme Court held in many cases that though the Civil Servant could not claim promotion as matter of right but it was incumbent upon the department/Authority. That when they grant promotion, then in that case the promotion should be granted from the due date of Civil Servant / Availability of post. Thus the appellant is entitled to antedated promotion
 - J) That the appellant was deprived from his legal right by giving promotion to him from immediate effect, not from the date vacancies were available which also suffered appellant's seniority.

K) That the appellant seeks permission to advance other grounds and proofs at the time hearing.

It is, therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed for.





REPLY ON BEHALF OF RESPONDENTS NO. 1-2

Respectfully Sheweth. Preliminary objections.

- 1. That, the appellant has no locus standi to file the appeal in hand.
- 2. That, the appellant is estopped by his conduct to file the instant appeal.
- 3. That the instant appeal is not maintainable in the eyes of law.
- 4. That the appellant has come to court with unclean hands.
- 5. That the instant appeal is based on malafide, therefore, it is liable to be dismissed.

FACT.

- 1. Para-1, Needs no comments.
- 2. The appellant was appointed as Sub Inspector on acting charge basis alongwith his other colleagues. (Copies of working paper are attached as Annexure- A).
- 3. As an when clear vacancy becomes available the appellant was regularized as Sub Inspector with immediate effect accordingly. (Copies of working paper attached as Annexure-B).
- 4. As per letter SOR-II/E&AD/4-1/2004/ dated. 29.09.2017 issued by the Establishment and Administrative Department (Regulation Wings) the probation period has never been terminated rather the Administrative Department was requested to look into the matter for the said purpose. (Copy letter No. SOR-II/E&AD/4-1/2004/ dated 29.09.2017 attached as Annexure-C).

5. Para-5 is incorrect. As per the Government of Khyber Pakhtunkhwa, Civil Servant (Appointment, Promotion and Transfer) Rules 1989, Part-VI, Section 17(1) (a):in the case of persons appointed by initial recruitment, in accordance with the order of merit assigned by the Commission 2 (or as the case may be, the Departmental Selection Committee;) provided that persons selected for appointment to the post an earlier selection shall rank senior to the persons selected in a later selection".

Khyber Pakhtunkhwa, Public Service Commission vide letters No. PSC/SR-1/60691 dated. 29.05.2017 and No.PSC/SR-1/60690 dated 29.05.2017, and letter No. PSC/SR-1/60933 dated. 02.06.2017 (Copies of letters No. PSC/SR-1/60691 dated. 29.05.2017 and No.PSC/SR-1/60690 dated 29.05.2017, and letter No. PSC/SR-1/60933 dated. 02.06.2017 are attached as Annexure-D, E, & F), respectively have recommended seven Inspectors which were placed on the seniority list from S. No. 89 to 95. The Seniority of the recommendees is fixed by the Public Service Commission Khyber Pakhtunkhwa, while the appellant was recommended for regular promotion to the post of Inspector on 27.11.2017, hence he was placed junior to the recommendees of the Public Service Commission Khyber Pakhtunkhwa, accordingly.

- 6. The appellant was not considered for anti-date promotion because ante date promotion is possible where a person is eligible for his due promotion, but in the instant case the appellant passed the Departmental Examination vide Notification No. SO(Admn)ET&NC/1-19/2013 dated 20.07.2017, at S. No. 203 in higher grade which is mandatory for promotion to the post of Inspector. (Copy of Notification No. SO(Admn)ET&NC/1-19/2013 dated-20.07.2017 is attached as Annexure-G).
- 7. The appellant has got no cause of action to file instant appeal.

ON GROUNDS.

- A. Ground- A is incorrect. As narrated in Para wise Comments at Para-3.
- B. Ground-B is correct to the extent that the vacancy did exist but the appellant was not eligible to be promoted to the post of Inspector because he had not passed Departmental Examination in higher grades which is mandatory for the said promotion and that he was promoted to the post of Sub Inspector on acting charge basis on 16.08.2012 because of non availability of clear vacancy.
- C. Ground-C is incorrect. As narrated in the Para wise comments at Para-5.
- D. Ground-D is incorrect. The due right of the appellant was not damaged in face of the available facts.

- E. Ground-E is incorrect as replied in above paras.
- F. Ground- F is incorrect because the appellant was not eligible for promotion.
- G. Ground-G is incorrect. The department has not made any violation in the instant case.
- H. Ground-H is incorrect the department has responded to the appeal within stipulated period of time vide letter No. 549/ESTB/XIX-C-618 dated. 15.01.2018 (Copy of letter No. 549/ESTB/XIX-C-618 dated. 15.01.2018 is attached as Annexure-H)
 - I. Ground-I is correct to the extent that the vacancy did exist but the appellant was not eligible to be promoted to the post of Inspector because he had not passed Departmental Examination in higher grades which is mandatory for the said promotion and that he was promoted to the post of Sub Inspector on acting charge basis on 16.08.2012, because of non availability of clear vacancy.
 - J. Ground-J is incorrect and as replied above.
 - K. That the respondents seek permission to raise additional grounds at the time of arguments.

It is therefore, most humbly prayed, that on acceptance of this reply the instant appeal may kindly be dismissed with compensatory costs u/s-35-ACPC, beside actual costs.

Any other relief deemed fit in the circumstances of case may also be granted in favour of respondents and against appellant.



- 1. That, the appellant has no locus standi to file the appeal in hand.

- E. Ground-E is incorrect as replied in above paras.
- F. Ground- F is incorrect because the appellant was not eligible for promotion.
- G. Ground-G is incorrect. The department has not made any violation in the instant case.
- H. Ground-H is incorrect the department has responded to the appeal within stipulated period of time vide letter No. 549/ESTB/XIX-C-618 dated. 15.01.2018 (Copy of letter No. 549/ESTB/XIX-C-618 dated. 15.01.2018 is attached as Annexure-H)
- 1. Ground-1 is correct to the extent that the vacancy did exist but the appellant was not eligible to be promoted to the post of Inspector because he had not passed Departmental Examination in higher grades which is mandatory for the said promotion and that he was promoted to the post of Sub Inspector on acting charge basis on 16.08.2012, because of non availability of clear vacancy.


